INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Komyo America 401(k) Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Komyo America 401(k) Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

NOTE A - DESCRIPTION OF PLAN

The following description of Komyo America 401(k) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Komyo America Co., Inc. (the Company). The Plan was established January 1, 2006 under the provisions of Section 401(k) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Employees of the Company who have completed six months of service are eligible to participate. Employees may enroll in the Plan on the first day of the month following the month in which they have satisfied the eligibility requirement. Employees who are covered by a collective bargaining agreement and non-resident aliens are not eligible to participate in the Plan.

Plan Administration

The Plan is administered by the Principal Trust Company.

Contributions to the Plan

Each year, employees may contribute up to 100% of pretax annual compensation up to the statutory limit, which was \$23,000 and 22,500 for 2024 and 2023, respectively. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Compensation is defined in the Plan Document as all compensation earned during the year excluding bonuses and commissions, reimbursements or other expense allowances, fringe benefits, moving expenses, deferred compensation and welfare benefits. Participants who have attained age 50 by the last day of the Plan year are eligible to make catch-up contributions of up to \$7,500 for 2024 and 2023. In addition, participants may contribute amounts rolled over from other qualified plans. Participants may change their deferral percentage on the first day of each month.

The Company matches up to 50% of the first 6% of the participant's contribution, including catch-up contributions, up to the statutory limit. Annual profit sharing contributions may be made at the discretion of the Company. In order to receive a profit sharing contribution, an employee must be enrolled in the Plan as of the last day of the Plan year and must have completed at least 1,000 hours of service during the Plan year. No profit sharing contributions were made for the Plan years ended December 31, 2024 and 2023.

Upon enrollment in the Plan, participants may allocate contributions into any of twenty-eight investment options, which consist of one money market separate account, thirteen target maturity separate accounts, eleven miscellaneous separate accounts, and three growth mutual funds. Participants may change their deferral election on a monthly basis.

Eligibility and Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon, amounts rolled over from other qualified plans plus earnings thereon, and in Company-made qualified non-elective contributions plus actual earnings thereon.

Participants become 100% vested at death, disability, reaching normal retirement age of 65 years, or early retirement age of 55 years with 5 years of vested service.

Vesting in the Plan's matching contributions and discretionary profit-sharing contributions, plus actual earnings thereon, is based on years of service as follows:

Participant Accounts

Individual accounts are maintained for each of the Plan's participants to reflect the participant's contributions and related employer contributions, as well as the participant's share of the Plan's income and related administrative expenses. Allocations of income and expenses are based on the proportion that each participant's account balance bears to the total of all participant account balances.

Payment of Benefits

On termination of service due to death, permanent disability or achieving normal retirement age, a participant (or a participant's beneficiary in the event of death) will become 100% vested. Benefits are paid in a single lump-sum amount, equal to the value of the participant's account at the time of distribution. On termination of service for other reasons, a participant will receive a lump sum payment equal to the vested value of the participant's account at the time of distribution. Hardship distributions are allowed if the employee meets the eligibility criteria. Such hardship distributions may be paid from the participant's entire vested account balance except for qualified matching contributions.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years. Participants may be granted one loan during any one-year period and only one loan may be outstanding at a time. The loans are secured by the balance of the participant's account and bear interest at the prime rate plus two percent. Principal and interest are paid ratably through payroll deductions.

Forfeited Accounts

Forfeitures represent that part of the participant's account that is not vested. Forfeited nonvested accounts totaled \$0 for the years ended December 31, 2024 and 2023. During 2024 and 2023, respectively, \$20,166 and \$22,805 of Company matching contributions were transferred from participant accounts to the forfeiture account because the matching contributions were not vested on the dates the distributions were processed. As a result of the forfeiture additions, during 2024 and 2023, respectively, \$16,033 and \$20,264 of forfeited funds were used to reduce Company matching contributions. During 2024 and 2023, respectively, \$4,168 and \$2,582 of forfeited funds was used to pay administrative expenses of the Plan.

SECURE 2.0 Act

The SECURE 2.0 Act of 2022 (“SECURE 2.0”), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. Each of the provisions in SECURE2.0 has its own effective date ranging from the date of enactment to 2028 and beyond, with the bulk of the provisions taking effect in 2023 and 2024. The Plan is required to be amended in regard to the requirements of SECURE 2.0 by December 31, 2025.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following is a summary of significant accounting policies followed in the preparation of these financial statements. These policies conform to accounting principles generally accepted in the United States of America, and have been applied on a consistent basis.

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with U.S. generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant’s account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan payments and the Plan Administrator considers the participant loan to be in default, and the entire principal balance and interest will become immediately due and payable. The principal balance including accrued interest will be treated as a distribution and will be taxable to the participant. Loans held by terminated participants are immediately due and payable. If the outstanding balance has not been repaid within sixty days, the principal balance including accrued interest will be treated as a distribution and will be taxable to the participant.

Investment Valuation and Income Recognition

The Plan’s investments in mutual funds are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s investments in pooled separate accounts and common collective trust are stated at fair value based on net asset value. The Investment Committee determines the Plan’s valuation policies.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the plan year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Plan incurs certain general investment expenses and administrative expenses on an on-going basis which may be paid by the Plan under the Plan Document. The Investment Committee reviews these expenses on an annual and quarterly basis and these fees are benchmarked using the methodology set forth in the Investment Policy Statement. These expenses are charged to participant accounts on a monthly basis. In addition, participants are charged fees to process distributions and to administer loans. The Company pays certain general expenses which will not be reimbursed by the Plan.

Subsequent Events

Management evaluated all activity of the Plan through October 8, 2025, the date the financial statements were available to be issued and concluded that no subsequent events occurred that would require recognition or disclosure in the financial statements or notes.

NOTE C - INFORMATION PREPARED AND CERTIFIED BY TRUSTEE

The following is a summary of the Plan's investment information as of December 31, 2024 and 2023 and for the year ended December 31, 2024, included in the Plan's financial statements, that was prepared by or derived from, information prepared by the Trustee, Principal Life Insurance Company, and furnished to the Plan management. The Plan management has obtained certifications from the Trustee that such information is complete and accurate.

NOTE D - FAIR VALUE

FASB ASC 820 establishes a framework for measuring fair value which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described in the table below:

Level 1-Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2-Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3-Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at quoted market prices, which represent the net asset value of shares held by the Plan at year-end. (Level 1)

Pooled Separate Accounts: Pooled separate accounts are valued at the net asset value (NAV) or equivalent based on units of the pooled separate accounts. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is generally based on the fair value of the underlying investments held by the pooled separate account less its liabilities. This practical expedient is not used when it is determined to be probable that the pooled separate account will sell the investment for an amount different than the reported NAV. In accordance with GAAP, the pooled separate accounts at NAV has not been classified in the fair value hierarchy. The fair value amounts presented in the table below are intended to permit reconciliation to the amounts presented in the statements of net assets available for benefits.

Common Collective Trust Fund: A stable value fund, which is a collective trust that consists primarily of synthetic guaranteed investment contracts, which are a combination of a portfolio of individual assets and a wrap contract typically issued by a financial institution or insurance company that provides that participant transactions are executed at net asset value. Investments in collective trust funds are reported at net asset value, which is used as a practical expedient to estimate fair value in the statements of net assets available for benefits.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan has investments in various pooled separate accounts which invest in equity, fixed income, and target date funds. The objective of those investment vehicles invested in equity investments is to approximate the risk and return characterized by various indexes; to seek long-term capital appreciation; provide diversified exposure representative of various segments of the U.S. or foreign equity market; and/or to seek income. The objectives of the investment vehicles invested in fixed income is to provide investment results that approximate the overall performance of certain bond indices and/or to provide a predictable rate of return while preserving the safety of capital and minimizing market risk. The objective of the investment vehicles invested in target date funds is to provide various levels of asset allocations, which become more conservative over time so participants can stay with the same fund before and after selected retirement dates. These investment vehicles are generally redeemable at net asset value under agreements with the underlying investment vehicles. However, it is possible that these redemption rights may be restricted by these investment vehicles in the future in accordance with underlying agreements.

Furthermore, changes in the liquidity provisions of the funds may significantly impact the fair value of the Plan's interest in the investment vehicles.

The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

NOTE G - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in all of their account balances.

NOTE H - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statements of net assets available for benefits.

NOTE I - PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are units of participation in common collective trusts and pooled separate accounts are managed by Principal Global Investors, LLC. Principal Life Insurance Company is the Plan Trustee and asset custodian and, therefore, related investment transactions qualify as party-in-interest transactions.

Participant loans are available to participants. Related transactions qualify as party-in-interest transactions.
