NOTE 1 DESCRIPTION OF THE PLAN

The following brief description of The Barack Obama Foundation 403(b) Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

General

The Plan was adopted, effective January 1, 2015, as a 403(b) plan, and was amended on September 1, 2018 and on January 1, 2020.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Retirement Plan Committee oversees governance of the Plan. This committee also determines the appropriateness of the investment offerings, monitors investment performance and reports to the Board of Trustees. The general provisions of the Plan include the following:

Eligibility

All United States residents upon attaining age 21 who work more than 20 hours per week are eligible to participate in the Plan.

Contributions

The Plan is funded by employee contributions, employer matching contributions, and discretionary employer profit-sharing contributions. Upon meeting eligibility requirements, employees may contribute an elected amount of compensation on a pre-tax basis and/or as a Roth deferral. Also, the Plan provides that participants aged 50 (or who are projected to be age 50 or older by the end of the calendar year) and who are making deferral contributions in the Plan may make a catch-up contribution up to the Internal Revenue Service (IRS) limit.

Prior to September 1, 2018, the Plan had a discretionary match. Effective September 1, 2018, the Plan adopted the Safe Harbor contributions. Effective January 1, 2020, the Plan's matching contributions were made eligible to employees immediately upon hire date. The matching contribution is equal to 100% of an eligible employee's elective deferral that does not exceed 4% of that employee's compensation.

Discretionary employer matching contributions can be made and will not apply to elective deferrals exceeding 6% of employee compensation. The total amount of this discretionary additional matching contribution will not exceed 4% of an employee's compensation. No discretionary employer matching contributions have been made for the years ended December 31, 2024 and 2023.

All contributions are subject to statutory limitations based on the IRS's regulations.

Participant Accounts

Separate accounts are maintained for each participant to record the participant's share of contributions, rollovers, distributions, and income, gains and losses from investment of such contributions and rollovers.

Investment income or loss is allocated to participant accounts daily based on the number of units each participant holds in each investment fund and the daily price of each individual fund. Participants share only in the income, gains or losses of the investment fund(s) in which their account is invested. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Description of Fund Types

Participants may direct their investment contributions in the Plan among the investment options contained in the Plan's fund lineup. Participants may change investment directions of future Plan contributions or existing individual account balances at any time as long as they act in accordance with the investment fund's prospectus or other governing document. The Plan's fund lineup includes various mutual funds that are traded on a national exchange. The fund lineup also includes a variety of investment options that reflect the investment's objectives and policies, risk and return characteristics, operating expenses, and diversification of assets. Participants receive annual updates of fund information, and can receive more detailed information upon request in the form of prospectuses and shareholder reports, as applicable.

Vesting

Participants are, at all times, fully vested in the rollover, employee contribution, and employer matching contribution portions of their accounts.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, or 50%, of their account balance. The notes are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. Principal and interest are paid through bi-weekly payroll deductions. Participants may have up to two loans outstanding at one time. Loans are secured by the balance in the participant's account, and interest rates range between 4.25% and 9.50%, maturing in 2025 through 2029.

Payment of Benefits

Upon termination of services or retirement, a participant may elect to receive his or her benefits in the form of a lump-sum payment, installment, or direct rollover into another qualified plan or IRA account.

Administration

The Plan is administered by the Retirement Plan Committee, which is appointed by the Board of Trustees of the Plan. Great-West Trust Company, LLC and Empower Retirement Company are the trustee and record-keeper for the Plan, respectively.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accounts of the Plan are maintained on an accrual basis of accounting. The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). A description of those accounting policies of particular significance follows.

Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the asset custodian and trustee. See Note 3 for a discussion on investments and fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when distributed. Amounts allocated to accounts of participants who have elected to receive benefits from the Plan but have yet to be paid, if any, have been excluded from benefit payments. Future distributions will be reflected in the statement of changes in net assets available for benefits for the period when paid.

Expenses

Certain expenses are paid by the Plan, either through direct debit from participant accounts or as part of investment management expenses. Other administrative expenses, including audit fees and certain professional fees, are absorbed by the Plan Sponsor.

Risks and Uncertainties

The trust that holds the Plan's assets invests in various mutual funds. Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

NOTE 3 FAIR VALUE MEASUREMENTS

The Plan follows the guidance issued under the *Fair Value Measurements and Disclosures* topic of the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, which defines fair value, establishes a framework for measuring fair value, and enhances disclosures about fair value measurements required under other accounting pronouncements, but does not change existing guidance as to whether or not an instrument is carried at fair value.

The fair value hierarchy gives the highest priority to quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Inputs are broadly defined as assumptions that market participants would use in pricing an asset or liability. The fair value hierarchy is broken down into three levels based on the transparency of inputs as follows:

Level 1: Quoted prices are available in active markets for identical assets or liabilities as of the report date. A quoted price for an identical asset or liability in an active market provides the most reliable fair value measurement because it is directly observable to the market.

Level 2: Pricing inputs are other than quoted prices in active markets, which are either directly or indirectly observable as of the report date. The nature of these securities include investments for which quoted prices are available but traded less frequently and investments that are fairly valued using other securities, the parameters of which can be directly observed.

Level 3: Securities that have little to no pricing observability as of the report date. These securities are measured using management's best estimate of fair value, where the inputs into the determination of fair value are not observable and require significant management judgment or estimation.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. The valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Mutual funds (Registered investment companies): Valued at the daily closing price as reported by the fund. The mutual funds held by the Plan are primarily open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and have been categorized as Level 1.

Fixed annuities: The values for the fixed annuity options are reported daily based on the valuation method disclosed in the annuity contract, as calculated by the annuity provider. The input for this asset is generally considered observable through the review of existing contracts and readily available financial information of the issuing financial institution. This asset has been classified as Level 2.

NOTE 4 PLAN TERMINATION

Although it has not expressed such intent, the Plan has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event the Plan is terminated, the participants will become fully vested and the assets of the Plan will be distributed to the participants in proportion to their respective interests in the Plan.

NOTE 5 TAX STATUS

The Plan is a volume submitter specimen plan of FIS Business Systems, LLC (FIS). The IRS issued an opinion letter, dated March 31, 2017, to FIS indicating that the volume submitter adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (the Code). Although the Plan has been amended from the original specimen document, the Plan administrator believes that the Plan is designed and is currently being operated in accordance with the applicable requirements of the Code. Therefore, the Plan administrator believes that the Plan is qualified, and the related trust is tax exempt, as of December 31, 2024.

U.S. GAAP requires the Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain tax position that more-likely-than-not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2018.

NOTE 6 INFORMATION CERTIFIED BY THE TRUSTEES

Great-West Trust Company, LLC, is the trustee of the Plan. The Plan administrator has elected the method of reporting permitted by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Accordingly, the Plan administrator has obtained certification from the trustee that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023,
- Notes receivables from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023,
- Investment income as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and
- Schedule of assets (held at end of year) as of December 31, 2024.

NOTE 7 RELATED-PARTY TRANSACTIONS

Investment options in the Plan include units of fixed annuities managed by Great-West Trust Company, LLC, the trustee of the Plan. This transaction qualifies as a party-in-interest transaction that is exempt from the prohibited transactions rules of ERISA. There are no other known related-party transactions or prohibited transactions with a party-in-interest.

NOTE 8 RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

There were no reconciling items involving the amounts shown per the financial statements and Form 5500 for the year ended December 31, 2024.

NOTE 9 SUBSEQUENT EVENTS

In accordance with FASB ASC 855, the Plan's management has evaluated subsequent events through September 26, 2025, which is the date the financial statements were available to be issued, and has identified the following:

Subsequent to year end, effective January 1, 2025, the Plan was amended to remove the 403b match eligibility for Collective Bargaining employees of the Plan. There were no additional subsequent events identified.
