1. **PLAN DESCRIPTION**

Effective September 1, 2020, The A&B Electric Co., Profit Sharing Plan (the Plan) has adopted the provisions of the American Funds Distributors, Inc. Defined Contribution Prototype Plan and Trust. The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

*General* - The Plan, adopted November 1, 1987, is a defined contribution profit sharing plan with participant deferral options under Section 401(k) of the Internal Revenue Code. All employees of A & B Electric Co., Inc., Reman, Inc., Accusteer LLC, and A & B Communications, Inc. (the Employer) who have completed one year of service and who have attained the age 21 are eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

*Contributions* – Participants may elect to defer from 1% to 100% of their annual eligible compensation from the Employer, subject to regulatory limitations, as contributions to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions, also subject to regulatory limitations. The Employer's matching contributions and profit-sharing contributions are made at the discretion of its board of directors. For 2024 and 2023, the Employer elected to make matching contributions up to 4% of compensation.

*Participant Accounts* – Each participant's account is credited with the participant's contributions, the Employer's discretionary matching contributions, an allocation of the Employer's discretionary contributions, if any, plus earnings thereon. The allocation method for Employer discretionary contributions is defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**1. PLAN DESCRIPTION, continued**

Vesting – Participants are immediately vested in their elective deferral, rollover, and safe harbor contributions and earnings thereon. Vesting in the remainder of their account is based on years of service.

A participant is 100% vested after six years of service. A Participant will become 100% vested in all accounts upon death or disability.

Forfeited Accounts – At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$4,220 and \$1, respectively. In accordance with the Plan's provisions, forfeited balances are used to offset any otherwise required Employer contributions.

Investment Options – Participants direct the investment of their contributions into certain mutual fund and stable value options offered through Capital Bank and Trust Company, as custodian of the Plan assets.

Payment of Benefits - On termination of service due to death, disability, retirement, or for any other reason, the participant will normally receive the vested value of their account in one lump-sum payment. Additionally, the Plan allows in-service distributions at age 59 and one-half.

Excess Contributions Payable – Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions.

2. **SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

*Basis of Accounting* - The financial statements of the Plan are prepared using the accrual method of accounting.

*Investment Valuation and Income Recognition* – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Shares of registered investment companies (mutual funds) are valued at quoted market prices. Shares of the Common/Collective Trust are valued at the net asset value as a practical expedient, which is used to estimate fair value. The net asset value is based on the fair value of the underlying assets.

Each participant account is valued on a daily basis for all funds invested with Capital Bank and Trust Company. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. Units of interest for the variable investment options are revalued daily to reflect the performance of the underlying mutual fund minus any applicable fees and charges.

*Use of Estimates* - The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that effect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

*Payment of Benefits* - Benefits are recorded when paid.

*Subsequent Events* – In preparing the financial statements, Plan management has reviewed all known events that have occurred after December 31, 2024, and through the date of the Independent Auditor's Report, which is the date the financial statements were available to be issued, for inclusion in the financial statements and footnotes.

**3. FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) No. 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC No. 820 are described as follows:

*Level 1* Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the plan has the ability to access at the measurement date.

*Level 2* Inputs to the valuation methodology include:

- quoted prices for similar assets in active markets;
- quoted prices for identical or similar assets in inactive markets;
- inputs other than quoted prices that are observable for the asset;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset.

*Level 3* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Investments where fair value is measured using net asset value per share as a practical expedient are not categorized in the fair value hierarchy.

**3. FAIR VALUE MEASUREMENTS, continued**

Following is a description of the valuation methods used for assets measured at fair value. There have been no changes in the methods used at December 31, 2024 and 2023:

*Mutual Funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/Collective Trust (CT)* – Valued at the net asset value (NAV) per share/unit at the close of every business day. The NAV is used as a practical expedient to estimating fair value. The NAV is based on the fair value of the underlying investments comprising the trust and accounts less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. There are no unfunded commitments or redemption restrictions relative to the CT at the participant level. Premature termination at the plan level requires a twelve month notice and could result in a delay of transfer at the plan level.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**4. INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIANS**

Capital Bank and Trust Company, the qualified institution of the Plan, has supplied the Plan administrator with certifications as to the completeness and accuracy of all investment information reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024 and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

**5. PLAN TERMINATION**

Although it has not expressed any intent to so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**6. TAX STATUS**

The prototype Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**7. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**8. RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, and employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons. During 2024, certain investment options of the Plan were invested in shares of mutual funds managed by Capital Bank and Trust Company, the Plan's custodian. Therefore, these transactions qualify as exempt party-in-interest transactions. Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Fees for the administration of benefit payments to participants are deducted from the distribution amount.
