## NOTES TO FINANCIAL STATEMENTS

December 31, 2024 And 2023

### 1. Description Of The Plan

The following description of Live Learning Technologies SR 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering all employees of Live Learning Technologies Shared Resources, LLC (the Company). The Plan was established effective on January 1, 2016, and restated effective on January 1, 2022.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### Eligibility

All employees of the Company are immediately eligible for the Plan and are eligible to participate on the first day of the month following the employee's date of hire.

#### Contributions

Each year, participants may contribute a percentage of their annual compensation as defined in the Plan Document. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Plan includes a safe harbor matching contribution equal to 100% of the first 3% of eligible compensation plus 50% of the next 2% of eligible compensation.

Contributions are subject to certain Internal Revenue Service (IRS) limitations. Participants direct the investment of all contributions into various investment options offered by the Plan.

#### Vesting

Participants are immediately vested in their contributions and Company safe harbor matching contributions, plus actual earnings thereon. Vesting in the Company's discretionary matching contributions prior to January 1, 2022 is based on years of continuous service. A participant is 100% vested after three years of credited service or in the event of death or total and permanent disability.

### Notes To Financial Statements (*Continued*)

#### **Forfeitures**

Forfeitures of nonvested participant balances are used to reduce the Company's contributions or to pay Plan expenses. Forfeitures available for future use amounted to \$59,026 and \$61,849 as of December 31, 2024 and 2023, respectively. For the year ended December 31, 2024, no forfeitures were used to fund Company contributions. For the year ended December 31, 2023, forfeitures of \$27,033 were used to fund Company contributions. For the years ended December 31, 2024 and 2023, forfeitures of \$39,874 and \$32,251, respectively, were used to pay Plan expenses.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, Company contributions and an allocation of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Payment Of Benefits**

Upon termination of service due to death, disability, retirement or any other reason, a participant or beneficiary may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account or a partial payment from the participant's vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum or partial payment distribution.

#### **In-Service Withdrawals**

A participant may also elect to receive an in-service distribution upon attaining age 59 ½ or reach normal retirement age. Participants may also elect an in-service distribution or having incurred a financial hardship as defined by the Plan Document.

#### **Contributions Receivable And Credit Loss Policy**

Amounts due for contributions are stated at the amount management expects to collect from outstanding balances less an allowance for expected credit losses. The expected credit losses amount reflects management's best estimate of amounts that will not be collected. This assessment considers historical experience, current conditions and, when appropriate, reasonable and supportable forecasts.

The Plan has concluded that no allowance for current expected credit losses was necessary at December 31, 2024 or 2023.

**Administrative Expenses**

The Plan pays fees for investment management, investment advisory and recordkeeping services. Investment-related expenses are included in the net change in fair value of investments. Significant administrative expenses of the Plan are paid by the Company. These amounts are not reflected in the financial statements.

**2. Summary Of Significant Accounting Policies**

**Basis Of Accounting**

The financial statements of the Plan have been prepared on the accrual basis of accounting.

**Estimates And Assumptions**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, disclosure of contingent assets at the date of the financial statements, and the reported amounts of additions to and deductions from assets during the reporting period. Actual results could differ from those estimates.

**Investment Valuation And Income Recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned on the accrual basis. Dividends are recorded on the ex-dividend date. The net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment Of Benefits**

Benefits are recorded when paid.

**Subsequent Events**

Management has evaluated subsequent events through the date the financial statements were available for issue, which is the Independent Auditors' Report date.

#### 3. Certified Investment Information

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the years then ended, included throughout the Plan's financial statements and supplemental schedule that was prepared by or derived from information certified by Ascensus, LLC, as Ascensus Trust Company's agent and Newport Trust Company. This information has not been audited by the Plan's independent auditors. The Plan Administrator has obtained certifications from Ascensus, LLC and Newport Trust Company that the information provided to the Plan Administrator related to the following information is complete and accurate. This information has not been audited by the Plan's independent auditors.

Accordingly, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information that appears throughout the financial statements and supplemental schedule related to the following assets as of December 31:

#### 4. Fair Value Measurements

The Plan follows current accounting standards, which establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described below:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value:

#### **Mutual Funds**

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The method described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

## 6. Income Tax Status

The Plan utilizes a pre-approved plan sponsored by Ascensus, Inc. The pre-approved plan has received an opinion letter from the IRS dated June 30, 2020 as to the pre-approved plan's qualified status. The pre-approved plan opinion letter has been relied upon by this Plan. The Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

The Company identified certain operational errors relating to participant and Company contributions. Plan management has developed a plan to take necessary corrective actions to ensure the Plan maintains its tax qualified status.

### **7. Party In Interest Transactions**

Plan investments are managed by the Plan's record-keeper, The Vanguard Group, Inc. (Vanguard). Vanguard has retained Ascensus, Inc. as a subcontractor to provide the services under the record-keeping agreement on behalf of Vanguard, and, therefore, these transactions qualify as party in interest transactions and are exempt from the prohibited transaction rules of ERISA. Fees incurred by the Plan for investment management services are included within the net change in fair value of investments as they are paid through revenue sharing rather than a direct payment.

### **8. Risks And Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
