### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of Yuasa Battery, Inc. Hourly Employees' Pension Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(c) audit). The financial statements comprise the statement of net assets available for benefits in liquidation as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits in liquidation for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

As discussed in Note 1 to the financial statements, the Pension Committee of Yuasa Battery, Inc., the Plan's sponsor, voted on August 10, 2022 to terminate the Plan, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going concern basis of accounting to the liquidation basis of accounting used in presenting the 2024 and 2023 financial statements. All plan assets were distributed during the year ended December 31, 2024. Our opinion is not modified with respect to this matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Note 1 - Description of Plan**

The following description of the Yuasa Battery, Inc. Hourly Employees' Pension Plan (the Plan) provides only general information. Participants should refer to the plan agreement for more complete information.

#### **General and Plan Termination**

The Plan was a noncontributory defined benefit pension plan covering eligible employees of Yuasa Battery, Inc. (the Company) who had at least one year of service. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective December 31, 2007, the Plan was amended to provide that there will be no further accrual of benefits after that date. Benefits accrued through December 31, 2007 will be preserved, but no additional increase in accrued benefits will occur after that date and no new participants will be accepted by the Plan.

On August 10, 2022, the Pension Committee of Yuasa Battery, Inc. voted to terminate the Plan. The Company has received approval from the Pension Benefit Guaranty Corporation (PBGC) (a U.S. Government agency), and has received approval from the IRS. The Company made contributions to the Plan in accordance with minimum funding requirements established by the IRS that would ensure that plan assets are sufficient to pay plan participants' accrued benefits. All plan assets were distributed during the year ended December 31, 2024. In conjunction with the termination of the Plan, a participant either received a lump sum distribution or an annuity was purchased from the Midland National on behalf of the participant.

#### **Funding Policy**

The Company's funding policy was to contribute funds to the Plan in such amounts as were required on an actuarial basis to provide the Plan with assets sufficient to meet the benefits to be paid to plan participants. To the extent that these requirements were fully covered by assets in the Plan, the Company could elect not to make a contribution in a particular year. No participant contributions are permitted.

#### **Pension Benefits**

Employees were eligible for normal retirement benefits at age 65 or the fifth anniversary of participation, if later. The Plan also had provisions for early retirement benefits. The normal retirement pension was payable monthly as long as the participant lives, with payments ceasing upon the participant's death. If the present value of the pension did not exceed \$1,000, a lump-sum payment is automatic. Retirement benefits could also be paid in the form of a lump-sum, joint and survivor annuity, or life annuity within a certain period. An additional lump-sum benefit of \$2,000 was payable upon retirement, provided that the participant's separation from employment occurs after attainment of eligibility for early retirement or normal retirement.

#### **Pension Benefits (continued)**

Upon termination of employment other than by retirement, disability, or death, no payment is available prior to eligible retirement age, unless the present value of the vested accrued benefit is less than \$5,000, in which case, a lump-sum distribution would be made. Such qualifying amounts are distributed as soon as administratively possible after termination of employment. If no election was made and the distribution is less than \$5,000, but greater than \$1,000, the amount would be rolled over into an Individual Retirement Account specified by the Plan. If the distribution is less than \$1,000, a lump-sum payment was automatic. Otherwise, the participant was eligible for payment at the normal retirement date.

Prior to December 31, 2007, a benefit service year was credited for each 12-month period the employee was employed by the Company.

The amount of the monthly pension was equal to certain benefit rates for specified benefit service years as more fully described in the plan document.

#### **Death and Disability Benefits**

Participants were eligible for pre-retirement death benefits if death occurs after five years of credited service. The beneficiary would receive a benefit as though the participant retired on the date of the death and elected a 50% qualified joint and survivor annuity.

Participants were eligible for disability benefits if disability occurs after 15 years of credited service. The benefit would be the participant's accrued benefit to the date of disability.

#### **Vesting**

A participant's normal retirement benefits vest upon completion of five years of service. All participants were fully vested by December 31, 2012.

### **Note 2 - Summary of Significant Accounting Policies**

#### **Basis of Accounting**

Due to the decision to terminate the Plan during 2022, the financial statements for the years ended December 31, 2024 and 2023 have been prepared using the liquidation basis of accounting.

#### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets, liabilities, and the actuarial present value of accumulated plan benefits at the date of the financial statements. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

All investments reported in the statement of net assets available for benefits in liquidation were reported at liquidation value. Fair value approximated the amount the Plan expected to collect at liquidation. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. For the years ended December 31, 2024 and 2023, interest income and dividends were recorded on the liquidation basis, including amounts expected to be earned through the final distribution of plan assets. Net appreciation (depreciation) included the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### **Payment of Benefits**

Benefits were recorded when paid.

#### **Administrative Expenses**

The Plan's expenses were paid either by the Plan or the Company, as provided by the plan document. Expenses that were paid directly by the Company were excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that were paid by the Plan were recorded as deductions in the accompanying statement of changes in net assets available for benefits in liquidation. In addition, certain investment related expenses were included in net appreciation (depreciation) in fair value of investments presented in the accompanying statement of changes in net assets available for benefits in liquidation.

#### **Actuarial Present Value of Accumulated Plan Benefits**

Accumulated plan benefits were those future periodic payments, including lump-sum distributions that were attributable under the Plan's provisions to the service employees had rendered. Accumulated plan benefits included benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of employees who have died, and (c) present employees or their beneficiaries. Benefits under the Plan were based on the benefit unit in effect at the time of retirement or termination, and the number of years of credited service. The accumulated plan benefits for active employees were based on the benefit unit in effect as of the valuation date. Benefits payable under all circumstances; retirement, death, disability, and termination of employment were included to the extent that they are deemed attributable to employee service rendered to the valuation date.

The actuarial present value of accumulated plan benefits was determined by an enrolled actuary from Milliman, Inc. using the projected unit credit actuarial cost method as of January 1, 2022. The actuarial present value of the accumulated plan benefits was that amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment. Due to plan management's decision to terminate the plan in August 2022, the actuarial valuation as of January 1, 2022 was the last actuarial valuation done by the plan actuary for the Plan.

### **Note 3 - Information Certified and Provided by Principal Bank**

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments held and accrued interest receivable at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments and interest and dividends for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Bank (the trustee of the Plan).

### **Note 4 - Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies are valued at the net asset value of shares held by the Plan at year-end.

Interest-bearing cash is valued at cost, which approximates fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Due to the Plan termination, as described in Note 1, there were no investments as of December 31, 2024. The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2023.

#### Note 5 - Tax Status

The IRS has determined and informed the Company by a letter, dated July 10, 2012, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. The Plan is exempt from federal and state income taxes under current regulations.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the U.S. Federal, state, or local tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### Note 6 - Risks and Uncertainties

The Plan invested in various investment securities. Investment securities were exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities would occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits in liquidation.

### **Note 7 - Related Party Transactions and Party-In-Interest Transactions**

Certain plan investments are shares of a bank deposit account managed by Principal Bank. Principal Bank is the trustee as defined by the Plan and; therefore, these transactions qualify as party-in-interest transactions.

Administrative expenses of the trustee paid by the Plan are immaterial for 2024 and 2023. Additionally, certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

During the year ended December 31, 2024, \$14,895 was reverted back to the Company.
