Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Lamar Savings and Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

(1) Description of the Plan

The following description of the Lamar Savings and Profit Sharing Plan (the Plan) is provided for general information. Participants should refer to the plan document for a complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

(a) General

The Plan is a defined-contribution plan established effective January 1, 1988. The Plan was amended and restated effective January 1, 2024. The Plan is administered by the Investment Committee, (the Plan Administrator) which is appointed by the board of directors of the Company. Employees, who are classified by Lamar Media Corp. (the Company) as temporary or seasonal, shall become eligible to participate upon completing one year of service with the Company and attaining the age of 21. Any other employee becomes eligible the later of the first day of becoming an employee or the date he or she attains the age of 21.

(b) Administrative Expenses

The trustee of the Plan is T. Rowe Price Trust Company, a qualified institution (the Trustee). Administrative expenses for each investment fund are deducted by the Trustee before investment earnings or losses are credited to participants' accounts. Expenses in connection with notes receivable from participants are charged to participants' accounts. Total administrative expenses amounted to \$315,610 in 2024. All expenses, except the Trustee expenses, related to the Plan are paid out of the participants' accounts unless paid by the Company. In addition, certain investment-related expenses reduced investment income presented in the accompanying statement of changes in net assets available for benefits.

(c) Contributions and Participation

Each participant's account is credited with the participant's and Company's contributions and allocation of plan earnings and losses. Earnings and losses are allocated by fund based on the ratio of a participant's account invested in a particular fund to all participants' investments in that fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants may contribute an amount equal to any whole or fractional percentage not in excess of 50% of their plan compensation, as defined, for the contribution period subject to certain limitations provided by federal income tax regulations. If an eligible employee has not executed a deferral agreement, within 30 days of becoming a participant, in which the employee affirmatively specifies a percentage deferral of compensation (including a 0% deferral or an affirmative election not to make deferral contributions), the employee will be automatically enrolled for a 5% contribution. If, as of the first day of a plan year, an employee is making deferral contributions (either through an affirmative election or automatic enrollment) of less than 5%, the deferral contribution percentage will automatically be increased to the next higher whole percentage effective as of the first day of that plan year unless (i) the employee has in effect an affirmative election of a 0% deferral of compensation or an affirmative election not to make contributions; (ii) the employee has made an affirmative deferral contribution election within 45 days before the beginning of the plan year; (iii) the employee has in

effect an affirmative election to opt out of automatic increases in the deferral percentage; or (iv) the employee is classified as a temporary or seasonal employee.

The Company may make matching contributions in an amount to be determined by the Company. The Company may also make discretionary nonelective contributions. During 2024, the Company matched 50% of employee contributions up to 5% of plan compensation.

Participants may also make rollover contributions from other qualified plans. Participants direct the investment of their and Company contributions into various investment options offered by the Plan. The Plan currently offers a common/collective trust fund and mutual funds as investment options for participants. Participants for whom investment elections are not received are invested by the Trustee in the various T. Rowe Price Retirement Date funds depending on participants' estimated retirement date. Participant contributions are recorded in the period during which the Company makes payroll deductions from the participant's earnings.

Effective July 1, 2023, Roth contributions were added to the Plan. Roth contributions are made after-tax.

(d) Vesting

Participants are immediately vested in their own contributions plus actual earnings thereon. Vesting in the Company's contribution portion of the participants' account is based on years of services, as defined. A participant becomes 100% vested after three years of service for contributions made on or after January 1, 2002. However, if an active participant dies prior to attaining the normal retirement age, the participant's account becomes 100% vested. If a participant is not 100% vested when he/she receives a distribution, the amount that is not vested is forfeited. After that, forfeitures are used to reduce matching contributions under the Plan. Any remaining forfeitures are used to pay the cost of administering the Plan.

(e) Distributions

On termination of service, disability, or death, a participant will be eligible to receive a lump-sum amount equal to the value of the vested portion of his/her account. Distributions are subject to the applicable provisions of the plan agreement.

(f) Notes Receivable from Participants

Participants may make loans against their account balance in the Plan subject to specific rules as defined by the Plan. Loan amounts may be no less than \$1,000 and the total outstanding loan balance may not exceed the lesser of (1) \$50,000 less the highest outstanding balance of all prior loans during the one-year period ending the day before the new loan is made, or (2) the greater of \$10,000 or one half of the total account balance. The term of the loan cannot exceed 5 years, unless the loan is used to acquire a principal residence, in which case the maximum term is 30 years. A loan is collateralized by the balance in the participant's account and bears interest at one percentage point above the prime rate listed in *The Wall Street Journal* on the origination date of the loan. The interest rate is fixed for the entire term of the loan. Interest rates on outstanding loans ranged from 4.25% to 9.50% at December 31, 2024 with maturities at various dates through March 2053.

Failure to repay a loan will result in a cancellation of the loan and be considered a deemed distribution to the participant. For the year ended December 31, 2024, deemed distributions totaled \$542,706.

(g) Plan Termination

Although it has not expressed any intent to do so, the Company reserves the right to terminate or amend the Plan provided that contributions previously made are not affected. Termination would result in participants becoming 100% vested in their account balances.

(2) Summary of Significant Accounting Policies

(a) Basis of Presentation

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with U.S. generally accepted accounting principles (U.S. GAAP) and under the requirements of ERISA.

(b) Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Realized gains (losses) on the sale of investments and unrealized appreciation (depreciation) in fair value of investments held are shown as net appreciation in fair value of investments in the statement of changes in net assets available for benefits.

(c) Notes Receivable from Participants

Notes receivable from participants are valued at amortized cost, consisting of principal outstanding and any related accrued interest.

(d) Benefit Payments to Participants

Benefits are recorded when paid.

(e) Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(3) Fair Value Measurements

The FASB Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure the fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under ASC Topic 820 are described below:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.
- Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for the investments measured at fair value:

(a) Mutual Funds

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish the daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are, therefore, categorized in Level 1 of the fair value hierarchy.

(b) Common/Collective Trust Fund

Common/collective trust fund is valued at the NAV per share as determined by the manager of the funds multiplied by the number of shares held as of the measurement date. These funds trade on a daily basis at the established NAV, which is available to participants and therefore are classified as Level 1 investments.

(4) Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated October 26, 2017 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code of 1986 (IRC), as amended. Although the Plan has been amended and restated since receiving the determination letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(5) Risks and Uncertainties

The Plan offers a number of investment options to participants that are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term.

(6) Information Certified by the Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for reporting under ERISA. The financial statements of the Plan are prepared based upon information received from and certified as complete and accurate by the Trustee. This information includes a listing of all investments at fair value and notes receivable from participants reported in the accompanying statements of net assets available for benefits and notes to financial statements as of December 31, 2024 and 2023 and Schedule H, part IV, line 4i – Schedule of Assets (held at end of year) as of December 31, 2024, and interest and dividend income, net appreciation in fair value of investments and interest income on notes receivable from participants in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024 and notes to financial statements. The following is a summary of the unaudited information regarding the Plan, included in the Plan's financial statements, notes to financial statements, and supplemental schedule that was certified as complete and accurate by the Trustee.

(7) Related-Party Transactions

(8) Forfeitures

Forfeitures result from nonvested employer contributions remaining in the Plan from terminated employees. The forfeiture reserve of \$210,973 and \$254,495 as of December 31, 2024 and 2023, respectively, is available to offset employer contributions, which would be otherwise payable by the employer. During the year ended December 31, 2024, \$501,949 in forfeitures were used to offset employer contributions.

(9) Subsequent Events

The Plan has evaluated subsequent events through October 10, 2025 the date the financial statements were available to be issued. No events, except an amendment dated January 21, 2025, effective January 1, 2025, to increase the auto enrollment percentage from 5% to 6%, was identified.
