**Scope and nature of the ERISA Section 103(a)(3)(C) audit**

We have performed audits of the financial statements of The Philadelphia Zoo 401(k) Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

#### NOTE A - DESCRIPTION OF THE PLAN

The following description of The Philadelphia Zoo 401(k) Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions, including definitions of key terms.

##### **General**

The Plan sponsor is The Zoological Society of Philadelphia (the "Zoo"). The Plan is a defined-contribution plan covering all full-time employees of the Zoo, as well as seasonal employees who have completed one year of service, defined as 1,000 hours of service during a 12-month period. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

##### **Contributions**

Participants may contribute to the Plan up to 50% of their pre-tax annual eligible compensation as defined in the Plan document. Eligible non-union employees hired on or after July 1, 2007 are automatically enrolled with a 5% salary deferral unless they affirmatively opt out of participation in the Plan. Participants may also elect a deferral percentage other than 5%. Participants may elect to increase or reduce their rate of contribution at any time. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Contributions are subject to certain Internal Revenue Code (the "Code") limitations.

For non-union employees, the Zoo makes a safe-harbor matching contribution, dollar-for-dollar, on deferral contributions that do not exceed 5% of the participant's eligible compensation for the Plan year. For union employees, the Zoo makes a discretionary matching contribution subject to the terms of the collective bargaining agreement; for the year ended December 31, 2024, the Zoo matched, dollar-for-dollar, deferral contributions that did not exceed 5% of a union employee's eligible compensation for the Plan year.

##### **Participant Accounts**

Each participant's account is credited with the participant's contributions, the Zoo's matching contributions and an allocation of investment earnings. Participants' accounts are charged with withdrawals, investment losses and certain administrative expenses that are paid by the Plan and for participant-requested services. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Fund managers' fees are charged to participants' accounts as a reduction of the return earned on each investment option.

Participants direct the investment of their account balances in 1% increments into various mutual funds and a collective trust offered by the Plan and may change their investment options at any time, subject to the terms of the funding vehicles. Plan investment earnings and losses are allocated to participants' accounts daily according to the type of funding vehicle in which balances are invested.

##### **Vesting and Forfeitures**

All participants of the Plan are immediately vested in their elective deferral contributions plus actual earnings thereon.

All participants of the Plan are immediately vested in the Zoo's matching contributions credited to their respective accounts, plus actual earnings thereon. Forfeitures, when applicable, may be used to reduce Zoo contributions or to pay administrative expenses of the Plan. The forfeiture balance was \$3,124 and

\$2,684 as of December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, no forfeitures were used to reduce the Zoo's contributions or to pay administrative expenses.

#### ***Payment of Benefits***

On termination of service due to death, total permanent disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum, or in installment payments over a period not to exceed the life expectancy of the participant or the joint and last survivor life expectancy of the participant and his or her designated beneficiary under the Plan.

In-service withdrawals of all or a portion of a participant's deferral-contributions account may be made by participants who have reached age 59½. Hardship withdrawals are permitted in cases of immediate and heavy financial need as defined in the Plan document. Minimum required distributions for participants who have reached 73 also apply per Internal Revenue Service ("IRS") regulations.

#### ***Notes Receivable From Participants***

The Plan permits participant loans up to the lesser of 50% of the vested balance of a participant's account balance or \$50,000. The minimum loan amount permitted is \$1,000. Loan terms may extend to a period not to exceed five years, or for a reasonable period of time over five years, for the purchase of a primary residence. The loans are secured by balances in the participants' accounts. Interest rates on outstanding loans as of December 31, 2024 and December 31, 2023 ranged from 4.25% to 9.50%. Interest rates are based on local prevailing rates for similar loans at the date the loan is issued. Principal and interest are paid ratably through periodic payroll deductions. All participant loans are considered party-in-interest transactions which are exempt from the prohibited transaction rules.

### **NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

A summary of the Plan's significant accounting policies consistently applied in the preparation of the accompanying financial statements follows.

#### ***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP").

#### ***Use of Estimates***

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies, utilizing information provided by the trustee. See Note D for discussion of fair value measurements and investment valuation.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

#### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid, interest. If a participant ceases to make loan repayments and the participant loan is deemed to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Administrative Expenses**

At the Zoo's discretion, administrative expenses may be paid with Plan assets or by the Zoo. The Zoo pays all administrative expenses except loan origination and loan administration fees, which are paid by the participant borrowers and are expensed as incurred.

#### **NOTE C - INVESTMENTS AND INFORMATION CERTIFIED BY THE TRUSTEE**

The Zoo has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-5(c) of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Vanguard Fiduciary Trust Company ("Vanguard"), the trustee, has certified that the following information included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value, and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, Line 4i - schedule of assets (held at end of year) as of December 31, 2024.

#### **NOTE D - FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to the valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable pricing inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and

- inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual funds* - Valued at the net asset value ("NAV") of shares held by the Plan at year end based upon quoted market prices (Level 1).

*Collective trust* - Valued using the NAV as a practical expedient to fair value provided by the administrator of the fund. The NAV is based on the value of the assets owned by the fund, less the liabilities at year end. While the underlying assets are actively traded on an exchange, the fund is not.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables present information about the Plan's investments measured at fair value on a recurring basis as of December 31, 2024 and 2023, and indicate the fair value hierarchy of the valuation techniques utilized by the Plan to determine such value:

**NOTE E - COLLECTIVE TRUST**

The Vanguard Retirement Savings Trust Fund (the "Trust") is a collective investment trust fund that invests solely in the Vanguard Retirement Savings Master Trust (the "Master Trust"). The Plan is applying the practical expedient as of December 31, 2024 and 2023 to its investment in the Trust, a collective trust fund. Participants' ownership of the Trust is represented as units. Units are issued and redeemed daily at the Trust's constant NAV of \$1 per unit. The Trust allows for daily liquidity, with no additional days' notice required for redemption. It is the policy of the Trust to use its best efforts to maintain a stable NAV of \$1 per unit, although there is no guarantee that the Trust will be able to maintain this value. There are no unfunded commitments as of December 31, 2024 and 2023.

The underlying investments of the Master Trust are primarily in a pool of investment contracts that are issued by insurance companies and commercial banks and in contracts that are backed by high-quality

bonds, bond trusts and bond mutual funds. Investment contracts include traditional Guaranteed Investment Contracts (“GICs”), Synthetic Investment Contracts (“SICs”) and wrapper contracts. GICs are valued based on estimated fair value, computed using discounted cash flows. SICs are valued based on the aggregate market value of the applicable bond trusts, mutual funds, and other investments. Wrapper contracts are valued at estimated fair value based on a replacement cost approach.

#### NOTE F - PLAN TERMINATION

Although it has not expressed any intent to do so, the Zoo has the right under the Plan to discontinue its contributions at any time and to terminate the Plan for non-union participants subject to the provisions of ERISA. Discontinuing contributions or terminating the Plan for union participants is subject to the provisions of a collective-bargaining agreement; the current agreement expired on June 30, 2022 and was renewed on June 30, 2025. In the event of Plan termination, all participants would become 100% vested in all employer contributions.

#### NOTE G - TAX STATUS

The underlying non-standardized volume submitter plan has received an opinion letter from the IRS dated February 21, 2019, stating that the form of the Plan is qualified under Section 401 of the Code and, therefore, the related trust is tax exempt. The Zoo has determined that it is eligible to, and has chosen to rely on, the current IRS volume submitter plan opinion letter. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes the Plan, as amended, is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

U.S. GAAP requires the Plan’s management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no material uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### NOTE H - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

#### NOTE I - PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds and units of a collective trust managed by affiliates of Vanguard. Vanguard is the trustee, as defined by the Plan. The Plan also allows notes receivable from participants. Fees paid by the Plan for the investment management services are included in the net appreciation in fair value of investments. These transactions qualify as party-in-interest transactions that are exempt from the prohibited transaction rules.
