**NOTE 1 - DESCRIPTION OF PLAN**

The following description of League of Conservation Voters, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

League of Conservation Voters, Inc. 401(k) Plan was established on January 1, 1997, as a defined contribution retirement plan. The Plan covers substantially all employees of League of Conservation Voters, Inc. (the Organization), who are age twenty-one. The Plan trustees are responsible for oversight of the Plan. The trustees are responsible for determining the appropriateness of the Plan's investment offerings and monitoring investment performance. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

Participants may elect to make voluntary contributions to the Plan on a pre-tax and after-tax basis up to the limits prescribed by the Internal Revenue Code. Employees may elect to defer an amount up to the annual IRS deferral limits. The Organization makes a safe harbor contribution up to 4% of a participant's compensation. The employer may also elect to make a profit sharing contribution at its discretion. Participants may roll over part or all of an eligible rollover distribution received from an eligible retirement plan. Catch-up contributions are available to participants who obtained age 50 during the Plan year.

**Participant Accounts**

Each participant's account is credited with the participant's contribution, the Organization's contribution, and Plan earnings or losses. Participant accounts are charged with a proportionate allocation of administrative expenses that are paid by the Plan. A participating employee may allocate contributions between any of the funds offered by the Plan in any desired proportion. Participant investment elections are self-directed and the Plan's intent is to comply with section 404(c) of ERISA. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**NOTE 1 - DESCRIPTION OF PLAN (Continued)**

**Vesting**

Participants are fully vested in their contributions and related earnings. Employer safe harbor contributions are also immediately vested and are non-forfeitable. Employer matching and profit sharing contributions vest as follows:

**Notes Receivable from Participants**

The Plan does not permit participant loans.

**Payment of Benefits**

Upon termination of service due to death, disability or retirement, a participant may elect to receive a lump sum distribution equal to the value of the participant's vested interest in their account, or in annual installments. For termination of service for other reasons, a participant may elect to receive the value of the interest in their account as a lump sum distribution. Participants whose vested accounts have never exceeded \$1,000 will receive an immediate lump sum distribution, while all others may elect to withdraw balances in lump sum or installments or may let the balances remain in the Plan until the participant has reached age 70½. The Plan also offers hardship withdrawals for those in need who qualify.

Amounts allocated to participants who have withdrawn from the Plan but have not received a payout of benefits amounted to \$507,538 as of December 31, 2024.

**Forfeited Accounts**

When termination occurs before employer matching contributions are 100% vested, the forfeited amount will first be used to reduce plan administration expenses then to reduce the employer's contribution. Upon complete or partial termination of the Plan, or in the event of complete discontinuance of contributions, the rights of all affected participants to benefits accrued through the date of termination or discontinuance shall become non-forfeitable.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The accompanying financial statements of the Plan are prepared using the accrual basis of accounting.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES** (Continued)

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Those estimates are inherently subject to change and, accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

Investments of the Plan are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Investments are valued daily.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Investment income is reported net of investment fees.

**Payment of Benefits**

Benefits are recorded when paid.

**Operating Expenses**

Certain expenses of maintaining the Plan are paid directly by the Organization and are excluded from these financial statements.

**Federal Income Tax Status**

The Plan operates under a prototype plan document sponsored by Ascensus, Inc. The IRS provided the prototype Plan with a favorable determination letter dated March 31, 2014. Therefore, it is exempt from Federal income taxes under Section 401(k) of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Federal tax returns are subject to audit by taxing authorities, generally for three years after filing, hence the Plan's tax returns for the years 2021 and onward remain open to examination.

**NOTE 3 - FAIR VALUE MEASUREMENTS**

The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are only used when Level 1 or Level 2 inputs are not available.

The three levels of the fair value hierarchy under reporting and accounting standards are described as follows:

*Level 1 Fair Value Measurements:* Fair values are based on unadjusted quoted prices for identical assets or liabilities in active markets. Active markets are defined as a market in which transactions take place with sufficient frequency and volume to provide pricing information on an ongoing basis.

*Level 2 Fair Value Measurements:* Fair values are based on inputs other than quoted price included within level 1 that are observable for valuing the asset or liability, either directly or indirectly (i.e. interest rate and yield curves observable at commonly quoted intervals, default rates, etc.). Level 2 inputs include quoted price for similar assets or liabilities in active or non-active markets, inputs other than quoted market prices that are observable and inputs that are derived principally from or corroborated by observable market data through correlation or other means.

*Level 3 Fair Value Measurements:* Fair values are based on price or valuation techniques that require inputs that are both unobservable and significant to the overall fair value measurement. These valuations, whether derived internally or obtained from a third party, use critical assumptions that are not widely available to estimate market participant expectations in valuing the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the unobservable inputs.

**NOTE 3 - FAIR VALUE MEASUREMENTS** (Continued)

The following are descriptions of the valuation methodologies used for investments measured at fair value:

*Mutual Funds:* Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily NAV and to transact at that price. The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year-end. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE 4 - UNAUDITED INFORMATION CERTIFIED BY THE PLAN TRUSTEE**

The Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, the related Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and the accompanying notes to the financial statements were prepared in part or entirely from information certified by Ascensus Trust Company, the trustee of the Plan, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The information certified includes total investments of \$21,881,853 and \$17,100,621 as of December 31, 2024 and 2023, respectively, and a related net investment income of \$2,608,905 for the year ended December 31, 2024.

**NOTE 5 - RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

The Plan has engaged Raffa Wealth Management, LLC, to act as a registered investment advisor. Raffa Wealth Management, LLC received investment advisory fees of \$48,695 during the year ended December 31, 2024. The Plan also paid Vanguard Group contract administration fees totaling \$26,671 for the year ended December 31, 2024.

**NOTE 6 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 7 - CONCENTRATION OF INVESTMENTS**
