Note 1. Description of the Plan

General

The following is a description of Sunny Sky Products, LLC 401(k) Plan (Plan) and provides only general information. For a more complete description of the Plan's provisions, participants should refer to the Plan Document. The Plan was established on January 1, 2009.

The Plan is a defined contribution plan sponsored by Sunny Sky Products, LLC (Company) and subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Non-excluded employees are eligible to join the Plan following the attainment of age 21 and completion of one month of service. Entry dates are the first day of the month after eligibility requirements are met. Effective January 1, 2024, the Plan was amended to add an additional participating employer, Goodwest Industries LLC 401(k) Plan (see Note 6). Fidelity Management Trust Company (Fidelity) serves as the plan record-keeper and trustee.

Contributions

Each year, participants may contribute up to 100% of pre-tax or Roth annual compensation, as defined in the Plan. Employees who reach the age of 50 by the end of the calendar year are permitted to make additional catch-up contributions. Participants may elect to rollover distributions from a former employer's qualified retirement plan. Effective April 17, 2023, the Plan allows after-tax employee contributions as well as in-Plan Roth rollover contributions.

The Company may elect to make discretionary nonelective employer contributions to the Plan. Participants must be employed by the Company on the last day of the plan year and must have obtained at least 1,000 hours of service during the plan year. There were no discretionary nonelective contributions for the years ended December 31, 2024 and 2023. The Company may also make a 401(k) safe harbor matching employer contribution equal to 100% of the first 1% of eligible participant's compensation contributed to the Plan and 50% of the next 5% of the eligible participant's compensation contributed to the Plan.

Participant Investment Account Options

Each participant has the option of directing their contributions into any of the various investment options offered by the Plan and may change the allocation daily.

The plan document also includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation, and their contributions are invested in a designated fund until elected otherwise by the participant. Unless elected otherwise by the participant, deferrals are automatically increased annually on the anniversary of enrollment by 1% up to 10%.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's contributions, and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Participants are vested 100% in the 401(k) safe harbor matching employer contributions and related earnings or losses thereon after two years of service. Participants vest 20% per year after two years of service, and each year thereafter, and are fully vested after six years of service in the Company's discretionary nonelective contributions and related earnings or losses thereon.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000 reduced by the balance of any outstanding loans. Such loans are secured by the participant's vested account balance. All loans must be repaid within a period of five years, unless the loan is used to purchase a principal residence, in which case the loan must be repaid within a reasonable period of time not to exceed 10 years. The loan bears interest at a rate commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions for current employees and remitted directly to the trustee. A participant may have a maximum of 2 loans outstanding at any time.

Benefit Payments

A participant is eligible to receive benefit payments in the amount equal to the value of the participant's vested account upon termination of service due to retirement, death, disability, resignation, or discharge. A participant may elect to receive either a lump-sum distribution or a single sum distribution of a portion of their vested account balance payable in cash or rolled over into a qualified retirement plan. In-service withdrawals of vested balances may be elected by participants who have reached 59½ years of age. The Plan also permits withdrawals of active participants' contributions only in amounts necessary to satisfy financial hardship as defined by the plan document.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$109,536 and \$86,023, respectively. The account is used to first pay plan administrative expenses and next to reduce future employer contributions. For the years ended December 31, 2024 and 2023, \$23,582 and \$129, respectively, was used to reduce plan administrative expenses and there was \$12,549 and \$0, respectively, used to reduce employer contributions.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that may affect the reported amounts of net assets, changes in net assets, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The investments are reported at fair value. Quoted market prices, if available, are used to value investments at fair value. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end as quoted on a nationally recognized stock exchange.

The Plan's interest in the common collective trust is valued based on information reported by the investment advisor using the audited financial statements of the common collective trust at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Contributions

Contributions from plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable From Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

Note 3. Certification of Plan Trustee

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income on notes receivable from participants as shown in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the accompanying financial statements and ERISA-required supplemental schedule.

Note 4. Related-Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such employer or employee association, or relatives of such persons.

Certain plan investments are managed by an affiliate of Fidelity. Fidelity is the trustee, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. The Plan paid \$33,331 and \$25,445 of record-keeping fees to the trustee during 2024 and 2023, respectively. Individually nonmaterial expenses paid to parties in interest aggregated \$69,335 and \$34,864 during the years ended December 31, 2024 and 2023, respectively. The Company provides certain administrative services at no cost to the Plan.

Note 5. Disclosures About Fair Values of Plan Assets and Liabilities

Fair value is the price that would be received to sell an asset, or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value.

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and significant to the fair value of the assets or liabilities

Recurring Measurements

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. Level 1 securities include mutual funds. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. Level 2 securities include a common/collective trust. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. The Plan held no investments that should be classified as Level 2 or Level 3 securities.

Investments Measured Using the NAV per Share Practical Expedient

The following table summarizes investments for which fair value is measured using the NAV per share practical expedient as of December 31, 2024 and 2023. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

Note 6. Transfer of Plan Assets

On January 1, 2024, Goodwest Industries LLC was acquired by the Company. The Goodwest Industries LLC 401(k) Plan was terminated and participant balances were merged into the Plan effective April 15, 2024. An aggregate of \$2,113,008 was rolled into the Plan during the year ended December 31, 2024 and is included as a transfer on the accompanying statements of changes in net assets available for benefits.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

Note 8. Tax Status

The Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by FMR LLC. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible, given the level of risk associated with investment securities, that changes in the values of the investments in the near term could materially affect a participant's account balance and the amounts reported in the accompanying statements of net assets available for benefits.

Note 11. Nonexempt Transactions

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the Company's general assets, but no later than the 15th business day of the month following the month in which the participant contributions are withheld by the Company. While the Company remitted all participant contributions to the Plan, contributions of \$58,131 were not remitted within the required time period for the year ended December 31, 2024. Lost earnings are in the process of being calculated and remitted to the Plan as of the report date.

Note 12. Subsequent Events

On January 1, 2025, the Plan was amended and restated to include a partial merger from the SuccessWise Pooled Employer Plan with assets attributable to Lemon x Corporation dba Bevolution Group. Participant balances were merged into the Plan effective February 14, 2025. An aggregate of \$8,105,030 was rolled into the Plan.

Subsequent events have been evaluated through October 13, 2025, which is the date the financial statements were available to be issued.
