### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Businessolver 401-K Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

### Basis for Opinion

**NOTE 1 PLAN DESCRIPTION**

The following description of the Businessolver 401-K Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering substantially all employees of Businessolver.com, Inc. and its wholly owned subsidiary BSC Agency, LLC (collectively, the Company or Plan Sponsor) who are age 21 or older and have completed one month of service. Employees represented by a bargaining unit that has bargained with the Plan Sponsor in good faith regarding retirement benefits and interns are not eligible for participation in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

Participants may make an elective deferral contribution up to the lesser of 87% of their annual pre-tax compensation, as defined by the Plan, or the maximum contribution allowed by the Internal Revenue Service (IRS). Participants also have the option to contribute post-tax compensation through Roth contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company makes matching contributions each pay period on behalf of each eligible participant in an amount equal to 100% of the first 3% of eligible compensation. The Company can elect to make an additional discretionary profit sharing contribution. No such additional discretionary profit sharing contributions were made for the years ended December 31, 2024 and 2023. Contributions are subject to certain limitations.

**Participant Accounts**

Each participant's account is credited with the participant's contribution, the Company's matching contribution, and an allocation of (a) the Company's discretionary profit sharing contributions and (b) Plan earnings (losses), and is charged with an allocation of administrative expenses. The Company's discretionary profit sharing contributions are allocated based on the participant's eligible compensation, as defined in the Plan agreement. Plan earnings (losses) and administrative expenses are allocated based on the participant's account balance. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary profit sharing contribution portion of their accounts plus actual earnings thereon is based on years of continual service. A participant vests 33% each year of service, as defined, and is 100% vested after three years of service.

**Investment Options**

Participants direct the investment of employee and employer contributions into a variety of investment choices as more fully described in the Plan's literature. The Plan currently offers mutual funds, self-directed brokerage accounts, and a collective investment trust. Participants may change their investment options at any time.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the vested balance in the participant's account and bear interest at rates ranging from 5.25% to 10.50%. Principal and interest are paid ratably through semi-monthly payroll deductions over a period generally not to exceed five years. If the loan is for a principal residence, it may be repaid over a term established by the Plan Administrator at the time of the loan.

**Notes Receivable from Participants (continued)**

In accordance with the Plan agreement, loans are considered to be in default if any scheduled loan repayment is not made by the end of the calendar quarter following the calendar quarter in which the missed payment was due. Defaulted loans will be reported as taxable distributions in the year in which default occurs. During the years ended December 31, 2024 and 2023, deemed distributions in the amount of \$27,365 and \$-0-, respectively, were reported in benefits paid to participants in the accompanying statements of changes in net assets available for benefits.

**Distribution of Benefits**

Participants and their beneficiaries are eligible for benefits upon the earlier of retirement, death, disability, or termination due to any other reason. If the value of the vested account balance is less than \$5,000, the participant will receive a lump sum payment. If the vested balance is greater than \$5,000, the participant may elect to roll over the benefit into another qualified plan, or receive the benefit as a lump sum, as installment payments, or through the purchase of an annuity contract.

The Plan allows for hardship withdrawals to participants who meet an immediate and heavy financial need. Hardship withdrawals are limited to a participant's vested account balance.

**Forfeitures**

Forfeitures from nonvested account balances may first be used to reduce future employer contributions, including corrective contributions, then to pay administrative expenses. At December 31, 2024 and 2023, nonvested account balances available for future use were approximately \$140,000 and \$86,000, respectively. During the years ended December 31, 2024 and 2023, approximately \$75,000 and \$150,000, respectively, from forfeited nonvested account balances was used to reduce employer contributions.

**Transfer of Assets to the Plan**

During the year ended December 31, 2024, the Plan received a transfer of assets totaling \$2,597,596 from another plan. This transfer resulted from the acquisition of a company by the Plan Sponsor on February 16, 2024. In connection with the acquisition, eligible employees of the acquired company became participants in the Plan. The total amount transferred consisted primarily of participant account balances and investments and was allocated to the individual accounts of the newly eligible participants based on their respective balances under the acquired plan as of the transfer date. The amount is reported as transfer of assets to the Plan in the accompanying statements of changes in net assets available for benefits.

**NOTE 2 SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received upon the sale of an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Investment Valuation and Income Recognition (continued)**

Management fees charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees are reflected as a reduction of investment return for such investments.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**Payment of Benefits**

Benefits are recorded when paid. At December 31, 2024 and 2023, there were no amounts that had been allocated to accounts of persons who had elected to withdraw from the Plan but had not yet been paid.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported changes in net assets available for benefits during the reporting period. Accordingly, actual results could differ from those estimates.

**Uncertain Tax Positions**

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) for an uncertain position taken that more likely than not would not be sustained upon examination by the Internal Revenue Service. Plan management has evaluated their material tax positions and determined there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**Administrative Expenses**

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Certain other administrative expenses are paid directly by the Plan Sponsor. Recordkeeper fees are paid by the Plan and allocated to participant accounts on a per capita basis.

**NOTE 4 FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB Accounting Standards Codification (ASC) 820 are described as follows:

Level 1—Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

Level 2—Inputs other than quoted prices included within Level 1 that are observable for the asset, either directly or indirectly, such as:

- quoted prices for similar assets in active markets;
- quoted prices for identical or similar assets in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset.

Level 3—Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

*Mutual funds*—Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Self-directed brokerage accounts*—Self-directed brokerage accounts consist of money market funds, common stock, and mutual funds that are valued on the basis of readily determinable market prices.

*Collective investment trust*—The collective investment trust consists of a stable value fund which seeks current income by investing primarily in insurance contracts issued by insurance companies and investments from financial institutions which offer stability of principal. The collective investment trust is valued at the net asset value of the issuer's collective trust. The net asset value is used as the practical expedient to estimate the fair value.

**NOTE 5 TAX EXEMPT STATUS**

The Plan adopted a non-standardized form of a prototype plan document sponsored by Merrill Lynch, Pierce, Fenner, & Smith, Inc. and is relying on the prototype sponsor's opinion letter from the Internal Revenue Service dated June 30, 2020. The letter states that the prototype and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The prototype sponsor and Plan administrator believe that the Plan is designed, and is currently being operated, in compliance with applicable requirements of the IRC. Accordingly, no provision for income taxes has been included in the accompanying financial statements.

**NOTE 6 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their account balances.

**NOTE 7 RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Fees paid to Merrill Lynch, Pierce, Fenner & Smith Incorporated, a division of Bank of America, N.A., the trustee of the Plan, and allocated to participant accounts during the years ended December 31, 2024 and 2023 amounted to \$222,321 and \$200,580, respectively.

Employees of the Plan administrator participate in the Plan.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE 8 RISKS AND UNCERTAINTIES**

Participants invest their account balances in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 9 SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through October 9, 2025, the date which the financial statements were available to be issued. There were no subsequent events required to be accrued or disclosed.
