Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of the HUBER+SUHNER (North America) Corporation 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for plan benefits for the years then ended, and the related notes to the financial statements.

(1) Description of the Plan

The following description of the HUBER+SUHNER (North America) Corporation 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

- (a) General – The Plan is a defined contribution plan established by HUBER + SUHNER (North America) Corporation (“the “Company”) on July 26, 1988. The Plan covers all employees of the Company. There are no age or service requirements for employee or employer contributions. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
- (b) Contributions – Participants may make elective deferrals to the Plan in any percentage or a set amount of their eligible compensation, subject to Internal Revenue Service (IRS) limitations. Deferrals are made through payroll deductions. Participants may increase, decrease, or terminate their elective deferral percentages at any time, effective the first day of each month.

The Company may contribute a matching contribution for each participant. The decision to make matching contributions and the amount of such contributions are made each year by the Company. During 2024, the Company contributed a 70% match on the first 6% of each participant’s elective deferrals, compared to a 50% match on the first 6% in 2023.

The Plan also includes a safe-harbor provision. Under this provision, the Company’s safe-harbor contribution is equal to the first 3% of employee’s eligible compensation.

The Company may also make additional profit sharing contributions. In 2024 and 2023, the Company’s profit sharing contribution was 2% of eligible compensation for employees employed on the last day of each quarter with more than 1 year of service and 5% for employees with less than 1 year of service.

- (c) Participant Accounts – The Company maintains recordkeeping accounts in the name of each participant. Each participant’s account is increased by the participant’s contributions, an allocated share of Company contributions and investment earnings. The account is decreased by any participant withdrawals and an allocated share of investment expenses. Participants allocate contribution amounts to various investment choices offered by the Plan.
- (d) Vesting – Participants are immediately vested in their voluntary contributions, rollovers, plus actual earnings thereon. Participants are 100% vested in Company safe-harbor contributions after 12 months of service. Vesting in the remainder of their account is based on years of continuous service. Vesting increases by 20% with each year of service. A participant is 100% vested after five years of credited service.
- (e) Notes Receivable – Participants are permitted one outstanding loan. Participants may borrow from a minimum of \$1,000, up to 50% of their vested account balance, provided the loan does not exceed \$50,000. All loans require approval by the Plan Administrator. The term of each loan is not to exceed five years except in the case of a loan for the purpose of acquiring a principal residence of the participant. Interest is charged at a reasonable rate as defined by the Plan. Loans are collateralized by the participant’s account.

Description of the Plan (continued)

- (f) Hardship Withdrawals – A participant may elect to receive an early distribution for financial hardship. Requests must be in writing and are subject to spousal consent requirements. Valid reasons for hardship withdrawals are specified in the Plan document.
- (g) Payment of Benefits – The full value of a participant’s vested account balance is payable at the normal retirement age of 65 or upon termination of service with the Company. Such balance is to be distributed in the form of a single lump sum cash payment as soon as practicable or as of a future date elected by the participant. Every participant with benefits may designate a person or persons who are to receive benefits under the Plan in the event of their death. In such a case, the full value of the participant’s account is payable to the beneficiary in a lump sum.
- (h) Forfeited Accounts – Forfeitures shall be applied to reduce the Company’s contribution for the Plan year upon the request of the Company. Unused forfeitures amounted to \$1,740 and \$2,072 at December 31, 2024 and 2023, respectively. The Company used forfeitures of \$103,852 and \$92,059 in 2024 and 2023, respectively.
- (i) Administrative Expenses – Recordkeeping and custodial expenses are paid by the Plan. All other administrative expenses are paid by the Company.

(2) Summary of Significant Accounting Policies

- (a) Basis of Accounting – The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.
- (b) Investment Valuation and Income Recognition – The Plan's investments are stated at fair value except for fully benefit-responsive investment contracts which are reported at contract value. Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for that portion of the net assets available for plan benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the term of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

- (c) Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.
- (d) Benefit Payments – Benefits are recorded when paid.

- (e) Risks and Uncertainties – The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.
- (f) Notes Receivable – Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.
- (g) Subsequent Events – The Plan evaluated subsequent events as of October 10, 2025, which is the date that the financial statements were available to be issued.

(3) Plan Termination

Although it has not expressed any intent to date, the Company has the right to amend, modify, or terminate the Plan at any time. In no event will an amendment have the effect of reducing participant vested account balances. In the event of Plan termination, participant will automatically become fully vested in their account balances.

(4) Information Certified by the Plan's Custodian

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Delaware Charter Guarantee & Trust d/b/a Principal Trust Company, the custodian of the Plan, has certified as being complete and accurate the investments reflected on the statements of net assets available for plan benefits as of December 31, 2024 and 2023, the investment activity reflected in the statements of changes in net assets available for plan benefits, and the investment information included in the supplemental schedule of assets held at December 31, 2024. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information certified as complete and accurate by the Plan's custodian.

(6) Fair Value Measurements

Generally accepted accounting principles in the U.S. establish a framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the closing price reported on the active market on which the individual securities are traded. Mutual funds totaled \$41,003,309 and \$34,545,031 at December 31, 2024 and 2023, respectively, and were classified as Level 1.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(7) Investment Contract with Insurance Company

The Plan has entered into a fully benefit-responsive investment contract. Because the investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract.

Investment Contract with Insurance Company (continued)

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) violation of a material obligation under the contract, (d) a material misrepresentation. The Plan Administrator does not believe that any events that would limit the Plan's ability to transact at contract value with plan participants are probable of occurring.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis for resetting.

The investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

(8) Income Taxes

The Plan was formed based on a prototype plan. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to December 31, 2021.

(8) Related Party Transactions

The Plan has a number of service providers. Such parties are considered parties-in-interest under ERISA.
