Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We were engaged to perform audits of the financial statements of Indiana University Foundation, Inc. 403(b) Defined Contribution Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

Disclaimer of Opinion

We do not express an opinion on the accompanying financial statements of the Plan. Because of the significance of the matters described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

Basis for Disclaimer of Opinion

The Plan has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the accompanying financial statements may have been affected by these conditions.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our responsibility is to conduct an audit of the Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditor's report. However, because of the matters described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits.

Other Matter—Supplemental Schedule Required by ERISA

The supplemental Schedule H, line 4i—schedule of assets (held at end of year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. Because of the significance of the matters described in the Basis for Disclaimer of Opinion section of our report, it is inappropriate to and we do not express an opinion on the supplemental schedule referred to above.

Notes to Financial Statements

Note 1. Description of the Plan

The following description of the Indiana University Foundation, Inc. (the Foundation or Plan Administrator) 403(b) Defined Contribution Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General: The Plan is a defined contribution plan covering substantially all salaried and hourly employees that meet eligibility requirements. The Indiana University Foundation Section 403(b) Annuity Plan Committee (the Committee) administers the Plan and oversees the management of the Plan's assets. Teachers Insurance and Annuity Association (TIAA), College Retirement Equities Fund (CREF) (collectively TIAA-CREF), American United Life Insurance Company (AUL), and Variable Annuity Life Insurance Company (VALIC) serve as the custodians of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective September 1, 2014, custodian changes were made as follows: (1) existing employer contributed Plan assets held at AUL were transferred to TIAA-CREF, (2) all future employee salary reduction contributions were limited to TIAA-CREF and (3) existing Plan assets accumulated through employee salary reduction held at AUL and VALIC may be transferred to TIAA-CREF at the request of the participant.

Contributions: Each year, the Foundation makes contributions as allowed by the Plan on behalf of each eligible participant in an amount equal to a base percentage of 10% of compensation, up to the Integration Level for such plan year as defined below, plus 15% of such participant's compensation in excess of the Integration Level for such plan year. "Integration Level" means 100% of the maximum amount of earnings that may be considered wages for a year under code section 3121(a)(1).

The Foundation also transfers tax deferred funds allowed by the Plan in the amount specified under the salary reduction agreement entered into between the Foundation and each participant. Effective January 1, 2019, the Plan enrolls new employees with an automatic 5% salary reduction agreement election, unless the employee specifically elects otherwise. The Foundation may reduce the amount of a participant's salary reduction contribution, or make such other modifications as necessary, so that the Plan complies with applicable provisions of the Internal Revenue Code (the Code). No participant will be permitted to have salary reduction contributions made under this Plan, or elective deferrals made under any other qualified plan maintained by the Foundation during any taxable year, in excess of the dollar limitation contained in code section 402(g) in effect for such taxable year, except to the extent permitted under code section 414(v).

The Plan may accept rollover contributions and/or direct rollovers of distributions from a previous employer for the following types of plans: (1) a qualified 401(a) or 403(a) plan (this includes a 401(k) plan); (2) a 403(b) annuity contract; (3) an eligible 457(b) plan which is maintained by a state, political subdivision of a state, or any agency or instrumentality of a state or political subdivision of a state; or (4) an individual retirement account (IRA).

Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Investment options: Upon enrollment in the Plan, a participant may direct all contributions to selected investments as made available and determined by the Plan Administrator in 1% increments. Participants may change their investment options daily.

Eligibility: An individual employed by the Foundation who is receiving compensation, excluding independent contractors and employees who normally perform fewer than 20 hours of service per week, is eligible to participate in the Plan.

Note 1. Description of the Plan (Continued)

Participant accounts: Individual accounts are maintained for each Plan participant. Each participant selects a funding vehicle (an annuity contract, mutual fund custodial account or pooled separate account) to which contributions by the Foundation or salary reduction contributions will be made. Each participant's account is credited with contributions, participant forfeitures and individual account earnings and losses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting: A participant shall have a 100% nonforfeitable interest in their account attributable to the Foundation contributions immediately upon death or disability or after completing two years of vesting service. A participant shall at all times have a 100% nonforfeitable interest in their account attributable to salary reduction contributions. In order to facilitate the movement of employees to and from Indiana University, the Foundation has amended the Plan to recognize and credit additional years of service, solely for vesting purposes for those individuals who: (1) terminate employment with the Foundation and are immediately thereafter employed by Indiana University; or (2) terminate employment with Indiana University and are immediately thereafter employed by the Foundation. For the year ended December 31, 2019, Plan amendments, effective January 1, 2019, provided for immediate vesting upon employee death or disability, mandatory distributions.

Effective July 1, 2024, the Plan was amended to change vesting for employees. All Foundation employees, including part-time staff paid on an hourly basis may contribute to the Plan and are eligible for employer-paid contributions after 1,000 hours of service. Additionally, employees hired after the effective date will have a three-year cliff vesting schedule, 0% vested until three years of employment have been met, where vesting will increase to 100%. Employees hired prior to the effective date will remain under their two-year vesting schedule.

Participant loans: Participant loans are not allowed under the Plan.

Hardship withdrawals: Under certain circumstances, as defined in the Plan, a participant may withdraw part or all the salary reduction contributions credited to their account, but not earnings thereon, prior to their termination of employment.

Payment of benefits: A participant may elect from among optional forms of benefit, including a lump sum, a single life annuity, or any other annuity options or payment forms provided by the participant's funding vehicle.

Mandatory distributions: The Plan provides for mandatory distributions for terminated employee participants with account balances less than \$5,000. Account balances less than \$1,000, may receive a cash distribution, otherwise account balances will be distributed to a participant directed IRA.

Forfeited accounts: If an employee terminates employment with the Foundation prior to being fully vested in their account, the amount of their account attributable to employer contributions will be forfeited and placed in the custodian repurchase account to be used against future employer contributions. At December 31, 2024 and 2023, balances in forfeited nonvested accounts totaled \$11,055 and \$27,247, respectively. These accounts will be used to reduce future employer contributions. During the year ended December 31, 2024, employer contributions were reduced by \$108,487 from forfeited nonvested accounts.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The accompanying financial statements have been prepared under the accrual method of accounting.

The custodians were unable to provide the Plan Administrator information regarding certain contracts and custodial accounts issued to certain current and former employees prior to January 1, 2009. Accordingly, the Plan Administrator has excluded certain of those contracts and custodial accounts and the related activity from the accompanying financial statements for purposes of the ERISA annual reporting requirements, in accordance with the transition relief provided by Department of Labor (DOL) Field Assistance Bulletin 2009-02, Annual Reporting Requirements for 403(b) Plans (FAB 2009-02).

FAB 2009-02 states that the DOL will not reject a 403(b) plan Form 5500 on the basis of a qualified, adverse, or disclaimed opinion, if the accountant expressly states that the sole reason for such an opinion was because such pre-2009 contracts and custodial accounts were not covered by the audit or included in the plan's financial statements. The Plan has not maintained sufficient accounting records and supporting documents relating to certain contracts and custodial accounts issued to certain current and former employees prior to January 1, 2009. Accordingly, the extent to which the financial statements and supplemental schedule may have been affected by these conditions is not determinable.

The Plan Administrator has made a good faith effort to comply with the Plan's reporting requirements to provide accurate and complete financial information regarding its Plan participant records, including account balances, investment schedules and contribution and disbursement schedules by establishing internal controls over the Plan's financial reporting processes to ensure proper authorization and recordkeeping of Plan transactions, including investments, contributions, benefit payments, participant data and administrative expenses. The Committee is responsible for the administration of the Plan and the oversight of the Plan's investment assets. The Committee ensures the Plan: (1) has an up to-date written plan document and investment policy; (2) includes provisions relating to eligibility, benefits, distribution availability and other limitations; and (3) has an investment policy describing investment options and sets forth an evaluation methodology for monitoring and evaluating investments, investment performance and objectives. The Committee also ensures: (1) the review of the administrative service provider and investment advisor; (2) the review and implementation of all required legal and or regulatory changes that affect the Plan; and, (3) its compliance with tax exemptions and compliance with requisite Internal Revenue Service (IRS) rules, including salary deferrals, contributions, universal availability and coverage, nondiscrimination, compensation testing, and minimum required distributions and transfers to an IRA or other eligible plan.

The Plan Administrator engages outside ERISA counsel to provide expertise and counsel on matters involving compliance with the legal and regulatory requirements of the Plan and outside investment advisory service to assist the Committee in effectively selecting, monitoring and evaluating investment alternatives made available to Plan participants.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities, net assets and changes therein and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and uncertainties: The Plan utilizes various investment instruments, including mutual funds, annuities, and a pooled separate account. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of these investments will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

Note 2. Summary of Significant Accounting Policies (Continued)

Investment valuation and income recognition: Except for fully benefit-responsive fixed annuity contracts held by TIAA-CREF, as described in Note 4, the Plan's investments are stated at fair value. The fair value of an investment is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Committee determines the Plan's valuation policies utilizing information provided by the investment custodians. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Plan service revenue: TIAA-CREF may receive revenue sharing payments from mutual funds in which the Plan assets are invested. The administrative services agreement between the Plan and TIAA provides that to the extent revenue sharing payments received by TIAA-CREF exceed administrative fees charged to the Plan by service providers, the excess may be used for Plan administrative expenses and/or to reimburse Plan participant accounts for investment fee expenses. For the year ended December 31, 2024, the Plan earned \$4,451 under the agreement and \$146 in investment earnings. As of December 31, 2024 and 2023, the suspense account's balance which holds these revenue sharing payments totaled \$2,050 and \$4,826, respectively.

Administrative expenses: Certain expenses of maintaining the Plan are paid directly by the Foundation and are excluded from these financial statements. Administrative expenses include certain recordkeeping fees paid by the Plan. Investment related expenses are included in net appreciation in fair value of investments. Administrative expenses of the Plan are paid by the Plan or the Foundation, as provided in the Plan document.

Payment of benefits: Benefit payments to participants are recorded upon distribution.

Excess contributions payable: The Plan is required to return contributions received during the plan year in excess of the Code limits. For the years ended December 31, 2024 and 2023, there were no excess contributions payable.

Note 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Accounting Standards Codification (ASC) 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Variable annuities (CREF funds): Valued at the daily unit value published on NASDAQ. The fund is not traded on this exchange. The value of the unit holder's investment rises and falls with the returns on the underlying assets in the fund.

Pooled separate account (TIAA Real Estate Account): Valued at the daily unit value published on NASDAQ. The fund is not traded on this exchange. The value of the unit holder's investment rises and falls with the return on the underlying assets in the account.

Nonbenefit-responsive fixed annuity contracts: Nonbenefit-responsive fixed annuity contracts are reported at contract value which approximates fair value (see Note 4). This determination is based on TIAA-CREF's credit rating and yield during 2024 and 2023 being comparable to similar alternative investments and the interest rate being comparable to a 10-year treasury bond.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Transfers in and out of Level 3 resulted from participant-directed interfund asset rebalancing. There were no issues of assets or liabilities for the year ended December 31, 2024.

Changes in fair value levels: To assess the appropriate classifications of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another.

The Plan evaluates the significance of transfers in and out of Level 3 assets based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. Transfers in and out of Level 3 assets are noted in the table above.

Note 4. Investment Contract With Insurance Company

Certain Plan investments are in fixed-dollar annuities, an investment product offered by TIAA-CREF, referred to as the TIAA Traditional and Stable Value Annuities. Investments in the TIAA Traditional and Stable Value Annuities are secured by the general assets of TIAA-CREF and backed by TIAA-CREF's claims-paying ability. The TIAA Traditional and Stable Value Annuity contracts are either nonbenefit-responsive or benefit-responsive.

Nonbenefit-responsive annuities: Nonbenefit-responsive annuities are those annuities where the Foundation makes contributions to retirement accounts as allowed by the Plan on behalf of each eligible participant. Fair value is the relevant measure for nonbenefit-responsive contracts subject to certain liquidity restrictions, including restrictions on transfers and distributions. Distributions must be made over a period of up to 20 annual installments. The Plan's investment in the TIAA Traditional Annuities is unitized for earnings calculations.

Interest credited to nonbenefit-responsive TIAA Traditional Annuities includes a guaranteed rate based upon a formula that may not be less than 0%, plus additional amounts that are established on a year-by-year basis. The guaranteed annual interest rate is between 1% and 3% then between 2% and 2.5% once annuity benefits commence. At December 31, 2024 and 2023, the value of the nonbenefit-responsive contracts totaled \$7,290,649 and \$7,684,629, respectively.

Benefit-responsive annuities: Benefit-responsive annuities are those made by an employee through a supplemental TIAA Traditional or TIAA Stable Value annuity contract. These contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. No liquidity restrictions apply to the benefit-responsive annuities. The contract value equals the accumulated cash contributions and interest credited to the Plan's contracts, less any withdrawals.

Note 4. Investment Contract With Insurance Company (Continued)

Interest credited to benefit-responsive TIAA Traditional Annuities includes a guaranteed rate based upon a formula that may not be less than 0%, plus additional amounts that are established on a year-by-year basis. The guaranteed annual interest rate is between 1% and 3% then between 2% and 2.5% once annuity benefits commence. Interest credited to benefit-responsive TIAA Stable Value Annuities includes a guaranteed rate between 1% and 3% subject to change every six months. At December 31, 2024 and 2023, the value of the benefit-responsive contracts totaled \$5,306,665 and \$4,685,810, respectively.

Certain events limit the ability of the Plan to transact at contract value with TIAA-CREF. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the Plan Administrator or other Plan Administrator events (for example, divestitures or spin-offs of a subsidiary) that cause significant withdrawal from the Plan; or (4) the failure of the underlying trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

Note 5. Exempt Party-in-Interest Transactions

Certain Plan investments are managed by the custodians, TIAA-CREF, AUL and VALIC; therefore, these transactions qualify as exempt party-in-interest transactions. The custodians receive compensation through their arrangements with the various custodian investment funds, which are offered as investment options to the Plan participants. Investment fees related to management and operation of the investment funds are charged to participants based on the funds invested in and in proportion to the amount of the investment. These fees are not deducted directly from participant accounts; they are paid indirectly through what is known as an expense ratio. An expense ratio is the percentage of assets an investment provider charges each year in exchange for its services. It goes toward expenses to run the fund, accounting and legal fees, fund manager's compensation and advertising. An expense ratio is deducted from the fund's assets and participants' total returns are "net" of these fees. Participants' returns are calculated after these fees have been deducted from the fund. Fees paid by the Plan for investment management services are included as a reduction of the return earned on each fund. Net Plan fees and compensation paid to the custodians totaled \$76,024 for the year ended December 31, 2024. Direct fees paid by the Plan to the custodians totaled \$197,747 for the year ended December 31, 2024. The Foundation provides certain accounting, administrative and investment management services to the Plan for which it receives no compensation.

Note 6. Plan Termination

Although it has not expressed any intention to do so, the Foundation reserves the right at any time and in its sole discretion to amend or terminate the Plan subject to the provisions of ERISA. If the Foundation were to terminate the Plan, affected participants of the Plan would become fully vested in their account balance.

Note 7. Federal Income Tax Status

Effective January 1, 2019, the Plan adopted a volume submitter plan sponsored by TIAA. The volume submitter plan provider has received an advisory letter from the IRS as to the volume submitter plan's qualified status. The volume submitter advisory letter has been relied on by the Plan. The Plan has been amended since the volume submitter received the advisory letter.

Note 7. Federal Income Tax Status (Continued)

The Plan Administrator believes that the Plan is currently designed and operating in accordance with the applicable requirements of Section 403(b) of the Code and, therefore, believes the Plan is qualified and the related custodial accounts and tax-deferred annuities are tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements. The Plan operates, for income tax purposes, on the basis of plan years as defined in the Plan. For federal income tax purposes, the Plan must meet the requirements for exemption from such taxes for each such plan year.

Note 8. Information Certified by the Custodians

The following is a summary of the unaudited financial information regarding the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included in the Plan's financial statements and ERISA-required supplemental schedule, that was obtained by management and prepared by or derived from information certified by the custodians of the Plan and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the custodians that such information is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information that appears throughout the financial statements and ERISA-required supplemental schedule related to the following.
