To Hospice of Wichita Falls, Inc., the Plan Administrator of the  
**403(b) Thrift Plan of Hospice of Wichita Falls, Inc.**

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

I have performed audits of the accompanying financial statements of 403(b) Thrift Plan of Hospice of Wichita Falls, Inc., an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of 403(b) Thrift Plan of Hospice of Wichita Falls, Inc.'s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), my audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

#### ***Opinion***

In my opinion, based on my audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting described in Note 2.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

I conducted my audits in accordance with auditing standards generally accepted in the United States of America. My responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of my report. I am required to be independent of 403(b) Thrift Plan of Hospice of Wichita Falls, Inc. and to meet my other ethical responsibilities in accordance with the relevant ethical requirements relating to my audits. I believe that the audit evidence I have obtained is sufficient and appropriate to provide a basis for my ERISA Section 103(a)(3)(C) audit opinion.

### ***Basis of Accounting***

I draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements and supplemental schedules are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. My opinion is not modified with respect to that matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2; this includes determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about 403(b) Thrift Plan of Hospice of Wichita Falls, Inc.'s ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of my report, my objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes my opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, I:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. - Conclude whether, in my judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about 403(b) Thrift Plan of Hospice of Wichita Falls, Inc.'s ability to continue as a going concern for a reasonable period of time.

My audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

I am required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that I identified during the audit.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules (modified cash basis), other than that agreed to or derived from the certified investment information, have been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in

accordance with generally accepted auditing standards. For information included in the supplemental schedules (modified cash basis) that agreed to or are derived from the certified investment information, I compared such information to the related certified investment information.

In forming my opinion on the supplemental schedules (modified cash basis), I evaluated whether the supplemental schedules (modified cash basis), other than the information agreed to or derived from the certified investment information, including its form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In my opinion:

- the form and content of the supplemental schedules (modified cash basis), other than the information in the supplemental schedules (modified cash basis) that agreed to or are derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedules (modified cash basis) related to assets held by and certified to by a qualified institution agrees to, or are derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

### Note 1 - DESCRIPTION OF THE PLAN

The following description of the **403(b) Thrift Plan of Hospice of Wichita Falls, Inc.** (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

Hospice of Wichita Falls, Inc. (Company) established the Plan for the benefit of its employees. The Plan is a defined contribution plan that is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

#### **Administration**

Mutual of America Life Insurance Company (Mutual of America) serves as the asset custodian and investment manager for the Plan's funds and executes all investment actions at the discretion of the Plan's participants. Recordkeeping responsibilities are maintained by Mutual of America.

#### **Eligibility**

All employees of the Company, except employees who are (i) nonresident aliens with no United States source income and (ii) all employees who are eligible to make salary reduction contributions to another plan of the Company described in Section 401(k), 403(b) or 457(b) of the IRC, are eligible to participate in the salary reduction portion of the Plan. The Plan further provides that employees must be at least 18 years of age and have one year of service with the Company to participate in the Plan with respect to employer matching contributions and employer base contributions. Plan entry dates for salary reduction and employer contributions are the first day of each calendar month coinciding with or immediately following the date the participant has met the eligibility requirements.

#### **Contributions**

Each year, participants may contribute pretax annual compensation (as defined by the Plan) up to the maximum permitted by the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants who have completed 15 years of service with the Company are eligible to make a special catch-up contribution. Participants may also make rollover contributions representing distributions from certain other eligible retirement plans.

The Company contributes a matching contribution equal to 50% of the salary deferral amount the participant contributed during the Plan year while the participant satisfied the participation requirements for matching contributions, and that do not exceed 6% of the participant's compensation received during the Plan year while the participant satisfied the participation requirements for matching contributions. The Company also contributes an employer base contribution equal to 1% of each participant's compensation received during that Plan year while the participant satisfied the participation requirements for employer base contributions. Contributions are subject to certain limitations. Forfeitures of participant's accounts may be used to reduce the Company's contribution or pay plan administrative expenses.

## Note 1 - DESCRIPTION OF THE PLAN (CONT'D.)

### Investment Options

Upon enrollment in the Plan, participants direct the investment of all contributions and earnings into various interest and investment alternatives available under the group annuity contract issued by Mutual of America Life Insurance Company. The group annuity contract offers a General Account - Interest Accumulation Account and Separate Account investment mutual fund options.

### Participant Accounts

As applicable, each participant's account is credited with the participant's salary reduction and rollover contributions and allocations of (a) the Company's matching contribution, (b) the Company's employer base contribution, and (c) Plan income, as well as charged with withdrawals and an allocation of the Plan's losses and administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Vesting

Participants are immediately vested in their salary reduction contributions and rollover contributions, plus actual earnings thereon. Vesting in the Company's matching contribution and employer base contribution portion of their accounts is based on years of continuous service. Employer matching contributions, employer base contributions, and related earnings are subject to the following vesting schedule: 0% at 0-1 years, 20% at 2 years, 40% at 3 years, 60% at 4 years, 80% at 5 years and 100% at 6 or more years of service. Participants become immediately and fully vested at age 59 ½ or upon death or total and permanent disability.

### Notes Receivable from Participants

Plan loans are available to participants, subject to certain limitations. Plan loans are issued directly from the General Account of Mutual of America Life Insurance Company and loan proceeds are not removed from a participant's account balance. However, a portion of a participant's accrued benefit invested in Mutual of America's General Account - Interest Accumulation Account is reserved, or held in collateral. Mutual of America requires 120% of the outstanding loan amount for the period of time the loan is outstanding. Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans must be repaid to the insurance company by the participant in accordance with the repayment terms of the agreement. Loan terms range from one to five years, unless for the purchase of a principal residence. In the event of default, foreclosure on the participant's account balance will not occur until a distributable event occurs in the Plan. At December 31, 2024 and 2023, loans totaled approximately \$372,810 and \$278,747, respectively. These amounts are included in the investment balances reported in the accompanying Statements of Net Assets Available for Benefits (Modified Cash Basis).

### Payment of Benefits

Participants may receive a distribution of their vested account balance upon termination of service, death or disability. Hardship distributions may be made from the Plan while the participant is still employed based on specific Plan provisions. Single sum payments, monthly payments and annuities may be available to participants as permitted by the contract from which the distribution is made.

#### **Forfeited Accounts**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1 and \$1, respectively. During 2024, the Company's contributions were reduced by \$17,620 from forfeited non-vested accounts

### Note 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### **Basis of Accounting**

The accounts of the Plan are maintained, and the accompanying financial statements have been prepared, on the modified cash basis of accounting. Employer and participant contributions and investment income are recognized when received, and disbursements are recognized when made. Additionally, investments are reflected at fair value. Accordingly, the financial statements are not intended to present the net assets available for benefits and changes in net assets available for benefits of the Plan in accordance with accounting principles generally accepted in the United States of America.

#### **Use of Estimates**

The preparation of financial statements in accordance with the modified cash basis of accounting requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies. See Note 3 for discussion of fair value measurements. Investment income is recognized when received by the Plan. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Participants are responsible for their own loan and distribution fees.

#### **Plan Amendments**

The Plan has implemented provisions of the Setting Every Community Up for Retirement Enhancement (SECURE) Act of 2019, the SECURE 2.0 Act of 2022, and the Coronavirus Aid, Relief, and Economic Security Act (the CARES Act) of 2020, related to minimum required distributions, participant distributions, and participant loans. Any required written amendments to the Plan to reflect these operational changes will be adopted at a later date in accordance with applicable law and IRS guidance.

### Subsequent Events

The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

## Note 3 - FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Level 1 Fair Value Measurements:* Mutual of America Life Insurance Company Group Annuity Contract Separate Account is valued at the published net asset value (NAV) as determined by Mutual of America based on the fair value of the actively traded underlying mutual fund shares that are determined by quoted market prices.

*Level 3 Fair Value Measurements:* The Mutual of America Life Insurance Company Group Annuity Contract General Account – Interest Accumulation Account is not actively traded and is commingled with the general assets of Mutual of America. Therefore, significant observable inputs are not available. This account is valued at the Plan's contract value which approximates fair value, as determined by Mutual of America. Contract value equals contributions and credited interest less funds to pay withdrawal benefits and administrative expenses.

### Note 5 - GROUP ANNUITY CONTRACT WITH MUTUAL OF AMERICA LIFE INSURANCE COMPANY

The Plan is invested in a group annuity contract with Mutual of America Life Insurance Company (Mutual of America). The contract holder is the Company, and certain employees and former employees of the Company are participants under the contract. Amounts held in connection with this contract may be held in Mutual of America's General Account – Interest Accumulation Account (General Account) and/or the Separate Account that Mutual of America maintains in connection with this contract and certain other contracts. The contract is included in the financial statements at fair value as reported to the Plan by Mutual of America. The General Account consists of an interest-bearing account to which all or a portion of the amounts held under the contract may be allocated. The General Account is valued at the Plan's contract value which approximates fair value. Mutual of America, in its own discretion, may change from time to time the current rate of interest paid on amounts allocated to the General Account. Mutual of America uses an overall portfolio approach for determining credited interest rates. The credited interest rate, when declared, is applied on a daily basis to all funds accumulated in the General Account. The credited interest rate may not be less than the minimum rate set forth in the contract. The General Account is guaranteed as to principal and has a rate of interest that results in an effective annual yield during 2024 of 2.85%. The Separate Account consists of investment mutual funds that own shares of the corresponding funds or portfolios of the underlying investment company. The underlying investment companies are management investment companies registered under the Investment Company Act of 1940. The amounts held in the Separate Account are not guaranteed as to fixed dollar amounts and increase or decrease in value based upon investment results of the underlying investments in the Separate Account.

In the event the insurer is unable to fulfill its contractual obligation under this contract, the contract holder is not protected by an insurance guaranty fund or other solvency protection arrangement. This contract is a contract under which the risk is borne by the contract holder.

### **Note 6 - RELATED-PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS**

All the Plan investments are held and invested in a group annuity contract with Mutual of America Life Insurance Company. Mutual of America Life Insurance Company is the Issuer, as defined by the Plan, and the service provider, and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to Mutual of America Life Insurance Company amounted to \$2,089 for the year ended December 31, 2024.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

### **Note 7 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become fully vested in their employer contributions.

### **Note 8 - TAX STATUS**

Mutual of America Life Insurance Company received an opinion letter from the Internal Revenue Service (IRS) dated March 31, 2017, which stated that the prototype non-standardized plan document is acceptable under section 403(b) of the IRC and may be relied upon as provided in Rev. Proc. 2013-22. The Company adopted this 403(b) prototype document on March 31, 2020. Although the Plan has been amended since receiving the opinion letter, the Company believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

The modified cash basis of accounting requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 9 - RISKS AND UNCERTAINTIES**

The Plan invests in an insurance company group annuity contract that offers a General Account - Interest Accumulation Account and various mutual funds through a pooled Separate Account. These investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with these investments, it is at least reasonably possible that changes in the values of these investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits (modified cash basis).
