As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate to the best of their knowledge.

Disclaimer of Opinion

We do not express an opinion on the accompanying financial statements of the Plan. Because of the significance of the matters described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

Basis for Disclaimer of Opinion

The Plan has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the accompanying financial statements may have been affected by these conditions.

Further, as described in Note 6 to the financial statements, the Plan has excluded from investments in the accompanying statements of net assets available for benefits certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009, as permitted by the DOL's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*. The investment income and distributions related to such accounts have also been excluded in the accompanying statement of changes in net assets available for benefits. The amount of these excluded annuity contracts and custodial accounts and the related income and distributions are not reasonably determinable. Accounting principles generally accepted in the United States of America (U.S. GAAP) require that these accounts and the related income and distributions be included in the accompanying financial statements.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our responsibility is to conduct an audit of the Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditor's report. However, because of the matters described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits.

Other Matter—Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. Because of the significance of the matters described in the Basis for Disclaimer of Opinion section of our report, it is inappropriate to and we do not express an opinion on the supplemental schedule referred to above.

Note 1. Description of Plan

The following description of The JF&CS Partnership 403(b) Plan (the Plan), adopted by Jewish Family & Children's Service (the Company or the Plan Sponsor), provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General and eligibility: The Plan is a defined contribution plan covering all eligible employees of the Company. The Plan was established on February 1, 2006 and subsequently amended and restated. Employees become eligible to make elective deferrals upon employment. Employees become eligible for employer discretionary match contributions when the employee is age 18 and has completed one year of service, as defined. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan was most recently amended effective October 1, 2024 to update the automatic rollover provisions, applying them to all involuntary cash-out distributions and including rollover contributions when determining the cash-out threshold.

Plan administration: Lincoln Financial Group Trust Company, Inc. (Lincoln or Trustee) is the trustee and custodian of the Plan. The Chief Financial Officer, acting as the Plan Administrator, controls the management, operation and general administration of the Plan.

Participant contributions: Each year, participants may contribute up to 100% of their eligible compensation, as defined, up to the Internal Revenue Service (IRS) limitations (\$23,000 in the calendar year ended 2024). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions (up to \$7,500 in the calendar year ended 2024). Eligible employees who are scheduled to work at least 29 hours or more per week and who have not entered into a salary reduction agreement are automatically enrolled in the Plan with a deferral rate set at 3% of eligible compensation and their contributions are invested in a designated fund until changed by the participant.

Employer contributions: Employer matching contributions are discretionary. For the year ended December 31, 2024, the Company matched 33% of the participant's elective deferral contribution, up to a maximum employer contribution of 2% of the participant's eligible compensation, as defined.

In addition, discretionary contributions may be made for each Plan year as determined by the Plan Sponsor. The Company did not make additional discretionary contributions for the year ended December 31, 2024.

Rollover contributions: The Plan may receive any amounts received by an employee as a distribution from another qualified plan, provided that the receipt of such amounts does not adversely affect the qualified tax status of the Plan. Participants are fully vested in these amounts.

Participant investment options: Participants direct the investment of their individual account among a guaranteed annuity contract and a selection of registered investment companies. Contributions may be diversified among one or more of the options in increments of 1%. Each participant has the ability to change his or her investment allocations at any time.

Participant accounts: Each participant's account is credited with the participant's contribution and employer matching contribution and allocations of (a) the Company's other contributions and (b) plan earnings, and (c) charged with an allocation of administrative expenses. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1. Description of Plan (Continued)

Vesting: Participants are vested immediately in their contributions plus actual earnings thereon. A participant's account balance derived from employer contributions plus actual earnings thereon is subject to the following vesting schedule:

Less than 1	0%
1	25%
2	50%
3 or more	100%

Notes receivable from participants: Participants may borrow an amount up to the lesser of 50% of their vested account balance or \$50,000, reduced by the highest outstanding loan balance during the preceding 12-month period. The minimum loan amount is \$1,000. Each loan is secured by the remaining balance of the participant's account and bears a reasonable rate of interest as determined by the Plan Administrator. Loan repayment terms may not exceed five years, unless the loan is used to acquire a principal residence, in which case the loan repayment terms may not exceed fifteen years. A participant can only have one loan outstanding at a time. Principal and interest is paid ratably through payroll deductions.

Payment of benefits: Notwithstanding the above, employees become 100% vested upon attaining normal retirement age, or upon termination of service due to death or disability. Upon termination of service, participants may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, an annuity, or installments. Participants may also withdraw funds from participant contributions upon certain hardship situations, as defined by the Plan, or from all vested funds upon attaining age 59 ½. Employees who have account balances of \$5,000 or less will be automatically rolled over to an individual retirement account (IRA) following severance from employment.

Forfeited accounts: Forfeitures of non-vested employer contributions will be used to reduce future matching employer contributions. For the year ended December 31, 2024, forfeitures generated amounted to \$3,284, and \$0 were used to reduce employer contributions. Forfeitures remaining as of December 31, 2024 and 2023, to be applied in future years were \$11,396 and \$8,112, respectively.

The Plan maintains an Expense and Conversion Account. During the year ended December 31, 2024, \$47,225 of investment fees were returned to the Plan and \$41,169 of this balance were used to pay plan expenses. The balance of the account was \$16,336 and \$10,280 as of December 31, 2024 and 2023, respectively.

Administrative expenses: For the year ended December 31, 2024, all reasonable expenses related to the plan administration were paid from Plan assets. Plan expenses include, but are not limited to, all reasonable costs, charges and expenses incurred in connection with the administration of the Plan. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The financial statements have been prepared in accordance with accounting standards set by the Financial Accounting Standards Board (FASB). The FASB sets generally accepted accounting principles in the United States (U.S. GAAP) to ensure net assets available for benefits and changes in net assets available for benefits are consistently reported. References to U.S. GAAP issued by the FASB in these footnotes are to the FASB Accounting Standards Codification (FASB ASC). The financial statements of the Plan are prepared on the accrual basis of accounting.

Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of estimates: The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a terminated participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded in accordance with Plan provisions.

Payment of benefits: Benefit payments to participants are recorded when paid.

Income taxes: U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan, and recognize a tax liability (or asset) if the Plan has taken any uncertain tax positions that more likely than not would not be sustained upon examination by a tax authority. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax exempt status and had taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. federal, state, or local tax authorities for years before 2021.

Note 3. Fair Value Measurements

The Plan follows guidance within FASB ASC 820 - Fair Value Measurements and Disclosures, which defines fair value, and establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023

Registered investment companies: Valued at the quoted market price of the funds and are classified as Level 1 at December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4. Investments with Insurance Company

The Plan invests in a fully benefit-responsive guaranteed annuity contract with The Lincoln National Life Insurance Company (Lincoln Life). Lincoln Life maintains the contributions in their general account. The account is credited with interest in accordance with the terms of the guaranteed annuity contract and charged for participant withdrawals and administrative expenses. Lincoln is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

As described in Note 2, because the guaranteed annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed annuity contracts. Contract value, as reported to the Plan by Lincoln, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their annuity investment at contract value.

The crediting interest rate is based on a formula agreed upon with Lincoln Life, but it may not be less than 1.50%. The interest rate is reviewed on a quarterly basis for resetting. There are no reserves against contract value for the credit risk of Lincoln Life or otherwise.

Certain events limit the ability of the Plan to transact at contract value with Lincoln, the most significant of which is a restriction on the ability of the Plan to transfer assets from the annuity contract into a competing fund, as defined in the contract. Such events are not expected to occur.

Certain events allow Lincoln Life to terminate the contract, the most significant of which is the failure of the Plan to qualify for special tax treatment under certain IRS code sections, defined by the contract. Such termination may result in settling at amounts that differ from contract value.

Note 5. Information Prepared and Certified by the Trustee

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedule, obtained by management and agreed to or derived from information certified as complete and accurate to the best of their knowledge by the Trustee and furnished to the Plan Administrator.

The Trustee also certified to the completeness and accuracy of \$811,819 of net appreciation in fair value of investments, \$421,025 of interest and dividends related to the aforementioned investments, and \$1,876 of interest income related to notes receivable from participants for the year ended December 31, 2024.

Note 6. Excluded Contracts

The Plan Administrator may have excluded from investments certain annuity and custodial accounts that may have been issued to current and former employees without the Plan Administrator's knowledge prior to January 1, 2009, as permitted by the Department of Labor's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*. The investment income and distributions related to such accounts have also been excluded from the statement of changes in net assets available for benefits. U.S. GAAP requires that these accounts and the related income and distributions be included in the accompanying financial statements. The Plan Administrator is not able to determine the amount of these excluded annuity and custodial accounts and the related income and distributions because records relating to these are not available or do not exist.

Note 7. Notes Receivable from Participants

The Plan permits its participants to obtain loans against their account balance. The loans are administered by Lincoln and are collateralized by the respective participant's remaining account balance. Also, certain restrictions apply to participant loans, as defined in the plan document. As of December 31, 2024 and 2023, interest rates on outstanding notes receivable from participants ranged from 4.25% to 9.50%, maturing through 2028. As of December 31, 2024 and 2023, total loans outstanding were \$25,536 and \$48,181, respectively.

During the year ended December 31, 2024, interest earned on such loans was \$1,876.

Note 8. Income Tax Status

The Plan terms have been drafted in reliance on the sample language provided by the IRS in Revenue Procedure 2007-71. The Plan is required to operate in conformity with the Internal Revenue Code (the Code) to maintain the exclusion from tax for Plan participants. Plan management believes the Plan is currently designed and operated in compliance with the applicable requirements of the Code.

Note 9. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 10. Party-in-Interest Transactions

The investment in the guaranteed annuity contract was issued by Lincoln Life. Lincoln Life is an affiliate of the Trustee and, therefore, these investment transactions, including fees paid to the Trustee, qualify as exempt party-in-interest transactions, as that term is defined in Section 3(14) of ERISA. Notes receivable issued to participants also qualify as exempt party-in-interest transactions.

Note 11. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

Approximately 12% and 11% of the Plan's assets are held in the group annuity contract investment as of December 31, 2024 and 2023, respectively, which is backed by the general assets of Lincoln Life. As such, this is considered to be a concentration of credit risk.
