### (1) Description of Plan

The following description of the Savings Plan for Employees of American Water Works Company, Inc. and Its Designated Subsidiaries (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering full and part-time employees of American Water Works Company, Inc. and Subsidiary Companies (the Company). Eligible participants may enroll as soon as administratively possible. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan is administered by the Company's Benefits Administration Committee (the Committee). The Committee was established by the Company's compensation committee, which is a committee of the board of directors of the Company. The Committee has overall responsibility for the operation and administration of the Plan. The Retirement and Benefit Plans Investment Committee (the Investment Committee) determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Company's compensation committee.

#### **Contributions**

Participants may contribute up to 50% of their annual compensation and 100% of their annual performance bonus (when included in eligible deferral compensation), as defined by the Plan, not to exceed the limits of the Internal Revenue Code (IRC). Participants may elect to have their deferrals be either pre-tax contributions or Roth contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan the first pay period beginning 45 days after their employment commencement date unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balance fund until changed by the participant.

The Company matches a percentage of certain employees' contributions based on the participants' eligible compensation. The match will vary based on an employee's employee group, hire date, rehire date, union affiliation, employment status, and any pre-existing collective bargaining agreement, as defined in the Plan document. In addition to the Company match, most regulated union employees hired or rehired on or after January 1, 2001 and most regulated nonunion employees hired or rehired after December 31, 2005 receive an employer defined contribution equal to 5.25% of their eligible compensation.

### (1) Description of Plan, Continued

#### *Contributions, Continued*

Effective July 1, 2018, non-regulated nonunion employees hired or rehired on or after January 1, 2006, other than nonunion employees of Tolt WA, receive an employer defined contribution equal to 5.25% of their eligible compensation. Any employee currently accruing a benefit under the Pension Plan is not eligible to receive the 5.25% employer contribution.

The Plan allows the Company to make discretionary profit sharing contributions on behalf of certain employee groups, as defined in the Plan document. The Company made discretionary profit sharing contributions of \$183,110 and \$189,083 in 2024 and 2023, respectively. Additionally, a one-time profit sharing allocation of \$600,000 was contributed to a newly acquired entity in 2025 related to the 2024 plan year. Contributions from plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

#### *Rollovers*

In addition to accepting rollovers from other qualified plans and conduit IRAs, the Plan accepts eligible rollover contributions from 403(b) custodial accounts or tax-sheltered annuities and government section 457 plans.

#### *Participant Accounts*

Participants may elect to have their contributions invested in any of the investment options offered in multiples of 1%. Each participant's account is credited with the participant's contribution and Company's matching contribution and defined contribution (if applicable), as well as an allocation of the plan earnings. Participant accounts may also be charged with an allocation of certain administrative expenses in addition to a flat per capita fee. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### *Vesting*

Participants are 100% vested in their employee deferral contribution, rollover contributions, employer matching and profit sharing contribution, qualified non-elective contribution, qualified matching contribution, and after-tax transfer contribution accounts at all times. Employer contributions attributed to the 5.25% employer defined contribution account benefit previously discussed are 100% vested after one year for all prior and future contributions.

### (1) Description of Plan, Continued

#### ***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000 reduced by the highest outstanding loan balance during the preceding twelve month period. Loan terms are for a period not to exceed five years unless it is for the purchase of the participant's principal residence, in which case the loan repayment period may not extend beyond 15 or 30 years, depending upon the date of issuance. The loans are secured by the balance in the participants' accounts and bear interest at rates that range from 4.25% to 9.50%, based on the prime rate at the date of loan issuance plus 1.00%. Participants on military leave who have an outstanding loan must have the interest rate capped at 6% while on leave. Principal and interest are paid ratably through payroll deductions.

#### ***Hardship Withdrawals***

Participants may withdraw all or part of their pre-tax or Roth after-tax contributions (excluding earnings) under certain hardship conditions. A hardship withdrawal may only be requested after all other permissible distributions and loans from the Plan, unless obtaining such loan would increase the severity of the Participant's hardship. Hardship withdrawals cannot be returned to the Plan.

#### ***Other Withdrawals***

Qualified birth and adoption distributions may be made from the Plan to participating employees in an amount up to \$5,000 per child. The distribution must be made within one year of the birth of the child or the finalization of the adoption. The individual may repay a qualified birth or adoption withdrawal within three years of the distribution date.

In addition, qualified disaster recovery distributions may be made from the Plan to participating employees in an amount up to \$22,000 and is repayable within three years of the distribution date. If the participant chooses not to repay the Plan, the taxes may be spread pro-rata over three years.

#### ***Payment of Benefits***

Upon separation of service, retirement, death, disability, or attainment of age 59 ½ as an active employee, a participant may elect to receive either a lump sum, partial payout, or installment amount equal to the value of the participant's vested interest in their account or a partial distribution of the participant's vested account balance.

#### ***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$278,130 and \$116,010, respectively. These accounts will be used to pay administrative expenses related to the Plan or reduce future employer contributions. During 2024 and 2023, forfeitures in the amount of \$201,290 and \$86,633, respectively, were used to pay administrative expenses and reduce employer contributions.

## (2) Summary of Significant Accounting Policies

### ***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

### ***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies utilizing information provided by the investment adviser and plan trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent loans are treated as distributions based upon the terms of the plan document.

### ***Benefit Payments***

Benefits are recorded when paid.

### ***Expenses***

Investment management expenses are paid by participants through a percentage of their assets invested in an investment option (expense ratio). General administrative service expenses (not related to investment expenses), including recordkeeping fees, are charged per capita and assessed in quarterly installments directly to participant accounts. Some of the expenses associated with administering or maintaining the Plan are paid by the Company. Fees related to the issuing of notes receivable from participants and distribution fees are paid by the Company. Fees paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

#### *Subsequent Events*

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

### (3) Financial Information Certified by Qualified Institutions

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments at fair value and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from the information certified as complete and accurate by Prudential Bank and Trust FSB (Prudential) and Empower Trust Company, LLC (Empower), the qualified institutions. Prudential executed investment transactions for the period January 1, 2023 to March 31, 2023. Empower held the Plan's investment assets as of December 31, 2023 and 2024 and executed investment transactions for the period April 1, 2023 to December 31, 2024.

### (4) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

**(4) Fair Value Measurements, Continued**

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Money market funds and registered investment companies:* Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

*Common collective trusts:* Valued at the NAV of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

There were no significant transfers among investment levels during the years ended December 31, 2024 and 2023.

**(5) Related Party Transactions and Party-In-Interest Transactions**

Fees incurred by the Plan for investment management services are included in net appreciation in fair value of the investment, as they are paid through a percentage of the participants assets invested in that investment, rather than a direct payment.

**(6) Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in their accounts.

**(7) Income Tax Status**

The Internal Revenue Service has determined and informed the Company by a letter dated February 14, 2018, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

**(7) Income Tax Status, Continued**

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**(8) Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.


