NOTES TO FINANCIAL STATEMENTS
DECEMBER 31, 2024**

1. Plan Description

The following brief description of A Square Group LLC 401k Profit Sharing Plan, referred to as the Plan, is provided for general information purposes only. Participants should refer to the plan document for more complete information.

(a) General

The plan is a voluntary defined contribution retirement plan for eligible employees of A Square Group LLC, referred to as ASG or the Company. All eligible employees become participants unless they elect not to participate. The Vanguard Group, Inc., referred to as Vanguard, serves as the recordkeeper for the plan. The Plan is subject to the provision of the Employee Retirement Income Security Act of 1974, referred to as ERISA.

(b) Contributions

Participants contributions

Each year, participants may make pre-tax and/or Roth 401(k) contributions to the Plan of up to limits imposed by Code section 401(k), 402(g), 404 and 315, as defined in the plan document. Participants aged 50 and above are permitted to make Catch-up Contributions up to a maximum of \$7,500.

Employer contributions

The Plan is operated as a Safe Harbor 401(k). In the previous year, all eligible participants were entitled to receive a Safe Harbor Non-Elective Contribution equal to 3% of their eligible wages. As of 1 January 2024, the Plan has switched from a Safe Harbor Non-Elective Contribution equal to 3% of their eligible wages to a Safe Harbor Employer Match. The Safe Harbor Employer Match will start at 3%, with an auto escalation of 1% on 1 January of each year, up till a maximum of 10%. The Company will match the employee deferral up to 4% at 100% and all deferral amounts between 5% to 10% at 50%.

In addition, the Company may make matching contributions by way of Discretionary Match and Employer Profit Sharing Contribution based on the Matching Contribution Computation and Employer Profit Sharing Contributions Formula as defined in the Plan documents respectively.

An Employer Profit Sharing Contribution of \$36.44 was made for the year ended 31 December 2024 (No Employer Profit Sharing Contribution was made for the year ended 31 December 2023).

1. Plan Description (continued)

(c) Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company contributions and Plan earnings, and charged with the participant's withdrawals, Plan losses and an allocation of administrative expenses. Allocations are based on participant contributions, account balances, or compensation, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participants vested account.

(d) Vesting

Participants are 100% vested in their voluntary contributions and actual earnings. Vesting in the employer's contribution is as follows:

(e) Investment Options

Plan investments are participant directed. Upon enrollment in the Plan, a participant may direct their entire individual account to any of the investment fund options managed by Vanguard. Participants may change or transfer their investment option at any time via telephone or a secure internet website.

1. Plan Description (continued)

(f) Loans to Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lower of 50% of their vested account balance, or \$50,000 as limited by restrictions in the Plan document. Loan terms shall not be for more than five years. Participants are allowed a maximum of two active loans. Loans are secured by the balance in the participant's account. The interest rate for participant loans is computed using the prime rate (as specified in the Wall Street Journal) plus 1%. Participants may not take loans from Roth Deferrals and earnings. Principal and interest are paid ratably through payroll deductions.

(g) Payments of Benefits

Upon termination, a participant is entitled to request a distribution from the Plan. The Plan has a cashout level of \$5,000. Participants with less than \$1,000 will be cashed out of the Plan if the participant does not make a request to distribute out. \$1,000 to \$5,000 participants must take the vested balance from the Plan, or the Plan Administrator will roll it over to an IRA. Balances greater than \$5,000, participants are not required to take payment from the Plan.

(h) Expenses

Expenses relating to the purchase or sale of investments are included in the cost or deducted from the proceeds, respectively. Direct charges and expenses, including investment manager fee attributable to specific investment funds, may be charged against that investment fund. Administrative expenses such as trustee, auditor, general plan recordkeeping and Internal Revenue Service user fee may be paid directly from the Plan.

(i) Forfeitures

When a participant terminates employment prior to full vesting, the Company's cumulative nonvested matching contributions from the participant's account are transferred to the Company's forfeiture account. Forfeitures are used to reduce future employer contributions. Certain forfeitures may be restored if the participant is reemployed before accruing five consecutive break-in-service years, as defined in the plan document.

2. Summary of Significant Accounting Policies

(a) Basis of Accounting

The accompanying financial statements of the Plan have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

(b) Investment Valuation

Investments are valued at fair value. Kindly refer to Note 4 of the financial statement for detailed disclosure of fair value measurement.

The investment contracts are included in the financial statements at contract value after adjustment from fair value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

(c) Income Recognition

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The Plan has entered into a pooled separate account and various fully benefit-responsive investment contracts with investment companies, which maintain the contributions in general account. The accounts are credited with earnings on the underlying investment and charged for participant withdrawals and administrative expenses.

(d) Use to Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affected the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimated. The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risk, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonable possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

(e) Payment of Benefits

Benefits are recorded when paid.

4. Fair Value Measurement

The fair value of assets and liabilities is determined by using a fair value hierarchy that distinguish between market participant assumptions based on market data obtained from sources independent of the reporting entity, and the reporting entity's own assumptions about market participants assumptions based on the best information available in the circumstances.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date, essentially an exit price.

The three level of the fair value hierarchy are described as follows:

Level 1 –	Inputs are quoted prices, unadjusted, in active markets for identical assets or liabilities that the reporting entity has the ability access at the measurement date.
Level 2 –	Inputs are other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly. At Level 2 input must be observable for substantially the full term of the asset or liability.
Level 3 –	Inputs are unobservable and reflect the reporting entity's own assumption about the assumption that market participants would use in pricing the asset or liability.

4. Fair Value Measurement (continued.)

Mutual funds, at level 1 of the fair value hierarchy, are valued at the closing price reported on the active market on which the individual securities are traded. Common/collective trust funds, at level 2 of the fair value hierarchy, are valued using the net asset value, referred to as NAV, provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, less its liabilities, and then divided by the number of shares outstanding. The NAV is a quoted price in a market that is not active.

5. Income Tax Status

The Company believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and the Plan and related trust continue to be tax exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax position taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrators have analyzed the tax position taken by the Plan and have concluded that as of 31 December 2024, there are no uncertain position taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements (31 December 2023: there are no uncertain position taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements). The Plan is subject to routine audit by taxing jurisdiction; however, there are currently no audit for any tax period in progress.

6. Plan Termination

Although it has not expressed any intent to do so, the ASG Employee Benefit Committee has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, the Plan provides that the net assets are to be distributed to participating employees in amounts equal to their respective interest in such assets.

7. Subsequent Events

In preparing these financial statements, the management has evaluated subsequent events and transactions for potential recognition or disclosure after the statement of financial position date of 31 December 2024 through 3 October 2025, the date the financial statements were available to be issued. There were no subsequent events that required recording or disclosure in the financial statements.
