NOTE 1 - DESCRIPTION OF PLAN

The following brief description of the FreedomRewards 401(k) Plan is provided for general information purposes only. Participants should refer to the Plan document and Summary Plan Description for more complete information.

General: The Plan is a defined contribution plan covering all eligible employees of CWGS Group, LLC, and Subsidiaries (the Company) as outlined in the participating employers section of the Plan agreement. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) as amended (participants include all eligible employees who have reached age 18).

Contributions: The Plan features an Eligible Automatic Contribution Arrangement (EACA) wherein an employee is automatically enrolled at a default four percent deferral election into a Qualified Default Investment Alternative (QDIA), unless they affirmatively elect not to participate in the Plan. The Plan also features an automatic escalation provision for participants automatically enrolled at hire who have made no investment changes nor directed their investments to automatically increase their deferral by one percent each year until a maximum of eight percent is achieved. Generally, participants can contribute between 1% and 75% of their compensation during the Plan year. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan allows participants to direct after-tax contributions into a Roth 401(k) account. Participants may also contribute amounts representing distributions from other defined contribution plans (rollovers).

Match: The Company, in its discretion, may make a matching contribution. To be eligible for the discretionary matching contribution, the employee must be working for the Company on the last day of the Plan Year, have one year of service, and make less than \$200,000 gross per year. For the plan year ended December 31, 2024, the Company approved a discretionary employer match contribution of \$307,385. The contribution was funded in 2025 from amounts available in the plan's forfeiture account. The Company may, at its discretion, make additional profit-sharing contributions to the Plan on an annual basis. No profit-sharing contributions were or will be made for the current Plan year. Profit-sharing contributions of \$2,750,000 were made in 2024 for the 2023 Plan year. Contributions are subject to certain limitations.

Investment Options: Participants may change their investment options at any time and may direct contributions among various investment options.

Retirement, Death or Disability: A participant is entitled to 100% of his or her account balance upon retirement, death, or disability.

Payment of Benefits: Upon separation of employment, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or choose a direct transfer to another qualified plan that accepts transfers, or request installment distributions, if eligible. In certain circumstances, participants may take "hardship withdrawals" as defined in the Plan. Active participants may also take in-service distributions from the Plan upon attainment of age 59½.

Participant Accounts: Each participant's account is credited with the participant's contribution and Plan earnings/(losses) and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Vesting: Participants are immediately vested in their contributions and rollovers plus actual earnings thereon. Under the Plan, employees acquire a vested and non-forfeitable interest in a percentage of their account attributable to the Company's contributions as determined based on years of continuous service. A participant vests at 20% per year starting after two years and is fully vested after six years of credited service.

Forfeitures: Participant forfeitures of employer contributions remain in the plan and are used to pay plan expenses and to reduce future discretionary employer match and profit-sharing contributions. As of December 31, 2024 and 2023, there were \$230,251 and \$178,861 of forfeitures available, respectively.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions and earnings thereon.

Notes Receivable from Participants: Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at rates one percent above prime. All loans are covered by demand notes and are repayable through payroll deductions or directly to the Plan. Loan original fees associated with notes receivable from participants are paid by the individual participant.

Administrative and Investment Management Expenses: The Plan's record-keeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses of the Plan. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan. The Plan set up an Expense Budget Account (EBA), which collects basis points from participants, and is used to cover qualified administrative, legal, audit, and investment advisory services fees. All other expenses of the Plan are paid by the Company.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through October 13, 2025, which is the date the financial statements were available to be issued.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The Plan's financial statements are prepared under the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses when they are incurred.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, credit, and risks pertaining to a global pandemic. Due to the level of risk associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Investment Valuation and Income Recognition: The Plan's investments, other than fully benefit responsive contracts, are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Contract value is the relevant measure for the Plan's fully benefit-responsive investment contracts because contract value is the amount Members generally receive when executing transactions under the terms of the contract and Plan provisions.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

NOTE 3 – CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by State Street Bank and Trust Company (the trustee of the Plan).

NOTE 4 – FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (level 1 measurements) and gives the lowest priority to unobservable inputs (level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

NOTE 4 – FAIR VALUE MEASUREMENTS (Continued)

Level 2: Significant other observable inputs other than level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy. Transfers between hierarchy measurement levels are recognized by the Plan as of the end of the reporting period.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

Mutual funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (level 1 inputs).

Collective trust funds: The fair values of participation units in collective trust funds are based upon the net asset values of such funds. The Northern Trust funds held at December 31, 2023, generally provide for daily redemptions by the Plan at reported net asset value per share. Units are issued and redeemed as of the latest net asset value, with no advance notification requirements. The State Street and Great Gray Collective Trust funds, held at December 31, 2024, generally provide for daily redemptions by the Plan at reported net asset value per share. Units are issued and redeemed as of the latest net asset value, with no advance notification requirements. The T. Rowe Price funds issue units that are redeemed only on a valuation date and at net asset value per unit computed on that date. Under the terms of the Declaration of Trust, unit holders may be required to provide up to 30 days advance written notice to the trustee prior to redemption of trust units; the notice period may be shortened or waived by the trustee in its sole discretion.

Self-directed brokerage accounts: Accounts primarily consist of common stocks that are determined by obtaining quoted prices on nationally recognized exchanges (level 1 inputs).

Money market: Fair values of money market deposit account balances have been determined based upon their quoted redemption prices and recent transaction prices of \$1.00 per share (level 2 inputs), with no discounts for credit quality or liquidity restrictions. The Plan's investments in money market deposit accounts occasionally exceed federally insured balances.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 – GUARANTEED INVESTMENT CONTRACT

The Plan holds a fully benefit-responsive investment contract (traditional guaranteed investment contract or “GIC”) with New York Life Insurance Company (“NY Life”), also referred to as the Stable Value Account, that is reported at contract value. NY Life manages this investment and maintains the contributions in its pooled separate account (branded as the “Anchor Account”). The assets of the Anchor Account are owned by NY Life. The Anchor Account is credited with earnings on the underlying investment and is charged for participant withdrawals and administrative expenses. Participants ordinarily may direct the withdrawal or transfer of all or a portion of their investments at contract value. The contract has no maturity date, but contract year begins on January 1 of each year. Under the terms of the contract, interest will accrue daily, be credited monthly and the rate cannot be less than zero percent. The daily rate fluctuates based on the underlying investments. Realized gains and losses are amortized over the target duration.

Restrictions: Participant-initiated transactions are those transactions allowed by the Plan, including withdrawals for benefits, loans, or transfers to noncompeting funds within a plan, but excluding withdrawals that are deemed to be caused by the actions of the Plan Sponsor. No direct transfers to competing investment options are permitted under the GIC. Any transfers out of the GIC must first go through a non-competing investment option and reside there for at least 90 days before transfer to a competing option, directed-brokerage account, or a mutual fund window. However, the GIC shall not be subject to a market value adjustment if the Plan provides at least 12 months advance written notice to NY Life. The following employer- initiated events may limit the ability of the Plan to transact at contract value.

- A failure of the Plan or its trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA;
- Any communication given to Plan participants designed to influence a participant not to invest in the GIC or to transfer assets out of the GIC;
- The establishment of a defined contribution plan that competes with the Plan for employee Contributions; and
- Complete or partial termination of the Plan or its merger with another plan.

Plan management believes that the occurrence of an event that would cause the Plan to transact contract distributions at less than contract value is not probable.

NOTE 6 - TAX STATUS

The Internal revenue service issued an opinion letter dated June 30, 2020, indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, Plan management believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor Regulations as any fiduciary of the Plan, any party rendering services to the Plan, the employer, and certain others. The Plan holds a reserve account with State Street Bank and Trust Company (State Street), the trustee, Collective Trust Funds managed by State Street, and institutional personal choice funds with Charles Schwab which provides security broker services to the Plan. Fees paid by the Plan to the Trustee for investment management services and Charles Schwab for security broker services are party-in-interest transactions, for which there is an exemption. Notes receivable from participants also constitute a party-in-interest transaction, for which there is an exemption.

In addition, fees paid by the Plan for record-keeping services, audit services, investment management services, and administrative expenses are party-in-interest transactions, for which there is an exemption. These fees are included as part of the administrative expenses in the Statement of changes in net assets available for benefits. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company.
