Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Adult and Pediatric Urology P.C. Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of the report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Notes to Financial Statements

December 31, 2024 and 2023

1. Plan Description

The following brief description of the Adult and Pediatric Urology P.C. Retirement Plan (the Plan) is provided for general informational purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan provides retirement benefits for the employees of Adult and Pediatric Urology P.C. (the Company).

Employees, excluding union employees, are eligible to make pre-tax and designated after-tax Roth salary deferral contributions after attaining age 21 and completing one year with 1,000 hours of service. Eligible employees may become participants on January 1st or July 1st on which entry requirements were fulfilled. Participants are eligible to receive Company safe harbor and discretionary profit-sharing contributions after attaining age 21 and completing one year with 1,000 hours of service. In order to receive Company discretionary profit-sharing contributions, a participant is required to be employed by the Company on the last day of the Plan year and have worked 1,000 hours during the Plan year. This condition does not apply to participants who are deceased, become disabled or have retired after meeting normal retirement age of 65 during the Plan year.

The Retirement Committee of the Plan voted to terminate the Plan effective June 30, 2025 (see Note 6).

Contributions

Participants may make voluntary pre-tax and designated after-tax Roth salary deferral contributions up to 100% of their eligible compensation as defined by the Plan, up to the maximum dollar limits allowable by law. Company safe harbor contributions are 3% of participant's eligible compensation. The Company may make discretionary profit-sharing contributions. Participants who are eligible to make deferral contributions and who are projected to attain age 50 before the close of the calendar year are eligible to make catch-up contributions. Contributions are subject to certain limitations. Participants may also contribute amounts representing distributions from other qualified plans.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of a) the Company's safe harbor contributions b) the Company's discretionary profit-sharing contributions c) Plan earnings and losses and d) Plan expenses. The Company's safe harbor and discretionary profit-sharing contributions are allocated among employees on the basis of the participant's eligible compensation. Plan earnings or losses are allocated on the basis of actual results of investments held in participant accounts. Participant directed investments are maintained in individual member accounts managed by Matrix Trust Company (Matrix).

Vesting

Participants are immediately vested in their voluntary contributions and Company safe harbor contributions plus actual earnings thereon. The Company's discretionary profit-sharing contributions are vested based on years of continuous service. A participant is 20% vested after two years of credited service and vesting increases 40% per year until a participant is 100% vested after four years of credited service. A year of credited service is defined as 1,000 hours of service during the Plan year. Participants hired prior to September 1, 2005 are 100% vested in all employer contributions. As a result of the Plan terminating effective June 30, 2025, all participants become fully vested in their account balances (see Note 6).

Payment of Benefits

Upon retirement, termination, disability, or death or attainment of age 65, the participant or beneficiary may receive partial withdrawals or a single lump sum payment equal to the value of the vested funds allocated to the participant's account. Distributions under \$7,000 (\$5,000 prior to January 1, 2024) will be paid out to the participant or automatically rolled to an individual retirement account in the event the participant does not elect a payout option. Participants may also receive in-service distributions, as permitted in the Plan document. Benefits are recorded when paid.

Forfeitures

Upon a participant's termination of employment before normal retirement, disability, or death, the portion of the Company contributions not then vested shall be forfeited. The forfeited portion of any participant's account may be used to pay administrative expenses or to reduce the Company's contributions. As of December 31, 2024 and 2023, there were \$16,016 and \$5,090 of forfeited amounts remaining, respectively. For the years ended December 31, 2024 and 2023, forfeitures of \$6,335 and \$313,976, respectively, were used to pay administrative expenses and reduce Company contributions.

2. Summary of Significant Accounting Policies

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis and in conformity with accounting principles generally accepted in the United States of America.

Presentation of Participant-Directed Funds

The Plan's presentation of participant-directed investments is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, Plan Accounting – Defined Contribution Pension Plans.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an investment in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Other

Investment management and recordkeeping expenses are paid by the Plan and are included in administrative expenses. Other certain expenses specifically incurred by or attributable to individual participants are paid from the applicable participants' accounts. Audit fees are paid by the Company and are excluded from these financial statements.

Subsequent Events

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through October 13, 2025. See Note 6 for a description of a subsequent event.

4. Fair Value Measurements

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual Funds and Money Market Fund: Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value (NAV) and to transact at that price. Funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Tax Status

The Plan is qualified as a profit sharing plan under Section 401(a) of the Internal Revenue Code and is exempt from federal income taxation under Section 501(a) of the Internal Revenue Code.

The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

6. Plan Termination

The Retirement Committee of the Plan voted to terminate the Plan effective June 30, 2025. As a result, management determined liquidation was imminent. Upon Plan termination, plan participation was frozen, all participants became fully vested and the assets of the Plan, including any previously unallocated amounts, were allocated to participant accounts and distributed to participants and beneficiaries as soon as administratively feasible following the termination date. Effective July 1, 2025, participants had the following options related to their accounts in the Plan: 1) participants could elect to rollover their balance to The Urology Center P.C. 401(k) Plan and Trust; 2) participants could elect to rollover their balances to an individual retirement account of their choosing; or 3) participants could elect to receive a lump sum distribution, subject to applicable taxes. The final liquidation payments will be paid in 2025, and the Plan will be fully terminated.
