INDEPENDENT AUDITOR'S REPORT

To the Trustees and Participants in the
Chanel, Inc. Savings and Investment Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Chanel, Inc. Savings and Investment Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Basis for Opinion

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Chanel, Inc. Savings and Investment Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General: The Plan is a voluntary defined contribution plan established by Chanel, Inc. (“Chanel” and the “Plan Sponsor”) as of January 1, 1980, and is administered by the Committee appointed by Chanel’s Board of Directors (the “Committee”). Fidelity Management Trust Company is the trustee of the Plan. An employee is eligible to become a member of the Plan on the enrollment date following his/her date of hire. Currently, employees of Chanel, Moussecentral Limited, Chanel S.A.R.L. (NY Branch), and Litor Limited (collectively, the “Employer”) may participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions: A participant may contribute annually to the Plan an amount between 1% and 75% of his or her compensation, as defined in the Plan, subject to certain Internal Revenue Code (“IRC”) limitations. Such amount is credited to his or her individual account A (before-tax and Roth contribution account). Employees are automatically enrolled in the Plan at a contribution level equal to 4% of eligible compensation unless, within 60 days from their hire date, they elect to contribute a different whole percentage or zero. The Plan also has a supplemental savings feature whereby a participant may contribute an additional 1% to 10% of his or her compensation, which amount is credited to his or her individual account D (after-tax contribution account). Any participant making contributions to the Plan may elect to have his or her contributions automatically increased by 1% each year, until the participant reaches a maximum of 10% of compensation per pay period or he or she opts out of the automatic increases. The annual matching contribution required by the Employer is equal to 50% of the participant’s contribution to his or her account up to 6% of the participant’s eligible compensation. Effective June 1, 2024, the Chanel, Inc. Pension Plan (the “Pension Plan”) froze to new employees. All employees hired from this date onward will be eligible to enter the Plan with an enhanced employer matching contribution equal to 100% of the participant’s contribution to his or her account up to 6% of the participant’s eligible compensation plus an additional non-elective company contribution equal to 3% of the participant’s eligible compensation. Employees become eligible for the non-elective company contribution after one year of service and must be employed on the last day of the plan year. The non-elective company contribution is paid during the first quarter of the following year. Contributions are allocated to the investment accounts at the discretion of the individual participant.

A participant who has attained or will attain age 50 before the close of the plan year, is eligible to make “catch-up” contributions. Catch-up contributions are treated as elective deferral contributions and are allocated to a participant’s elective deferral contribution account.

Participant Accounts: Individual accounts are maintained for each Plan participant. Each participant’s account is credited with the participant’s contribution, the Employer’s matching contribution, and Plan earnings, and charged with withdrawals and an allocation of Plan losses and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investments: Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan offers mutual funds, collective trusts, and a fully benefit-responsive investment contract as investment options for participants.

Vesting: Participants are vested immediately in their contributions plus actual earnings thereon. Effective June 1, 2024, vesting in the Employer Matching contribution portion of their accounts is immediate. A participant is 100% vested in their non-elective company contributions account after two years of credited service.

Notes Receivable from Participants: Under the terms of the Plan, a participant may apply for a loan not to exceed the lesser of \$50,000 (reduced by the highest outstanding loan balance during the one-year period prior to the loan date) or fifty percent of the amount in which the participant is vested. The loans are secured by the balance in the participant's account and bear interest rates commensurate with local prevailing rates at the time the funds are borrowed. Principal and interest is paid ratably through payroll deductions. Each loan must be repaid in full before any subsequent loans are granted. Principal and interest payments shall be credited to the account of the participant to whom the loan is granted in the same manner as the loan was charged and shall be invested in accordance with the participant's current investment election.

Payment of Benefits: Upon retirement or other termination, participants with a vested benefit of less than \$1,000 will receive a lump sum payment within 60 days of the valuation date subsequent to the termination. Participants with a vested benefit of more than \$1,000 may elect to receive funds either in a lump sum payment within 60 days of the valuation date subsequent to the termination, or in an annuity. If the participant's vested account balance is equal to or less than \$7,000 the participant's account balance will be fully distributed as an automatic cashout. Any such distribution that is greater than \$1,000 but less than or equal to \$7,000 will be rolled over to an individual retirement account. Pursuant to the Setting Every Community Up for Retirement Enhancement (SECURE) Act enacted in December 2019 and effective January 1, 2020, the age at which required minimum distributions must begin was increased from 70½ to 73 for participants born after July 1, 1949.

Withdrawals: Certain withdrawals of participant and Employer's contributions, including hardship withdrawals and participant loans, are subject to certain restrictions.

Forfeitures: Forfeited employer contributions are used to offset future employer contributions. At December 31, 2024, and 2023, forfeited nonvested accounts totaled \$110,685 and \$468,267, respectively. During the years ended December 31, 2024 and 2023, forfeitures of \$705,645 and \$8,533, respectively, were used to reduce employer matching contributions.

Administrative and Investment Management Expenses: Loan origination fees associated with notes receivable from participants and the Plan's record keeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses of the Plan. Investment management fees are charged to the Plan as a reduction of the investment return and included in the investment income (loss) reported by the Plan. All other expenses of the Plan are paid by Chanel.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Risks and Uncertainties: The Plan utilizes various investment instruments, including mutual funds and a fully benefit-responsive investment contract. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, liquidity risk, and overall market volatility. Due to the level of risk associated with certain investment securities and the sensitivity of certain fair value estimates to change in valuation assumptions, Plan management believes it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and amounts reported in the financial statements.

Investment Valuation: The Plan's investments, other than fully benefit responsive investment contract, are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contract, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions.

Income Recognition: Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances.

Payment of Benefits: Employee withdrawals are recorded upon distribution. At December 31, 2024 and 2023, there were no amounts allocated to accounts of persons who have elected to withdraw from the Plan but have not yet been paid.

NOTE 3 - RIGHTS UPON PLAN TERMINATION

The Employer intends to continue the Plan indefinitely. The Employer reserves the right, however, to discontinue further contributions to the Plan or to withdraw from or terminate the Plan at any time subject to the provisions of ERISA. In such event, participants would become 100% vested in their employer contributions and earnings thereon.

NOTE 4 - CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan).

NOTE 5 - FAIR VALUE MEASUREMENTS

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

Mutual funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Collective trusts: The fair value of participation units held in the collective trusts is valued at net asset value of the shares, as determined by the underlying investments held by the Plan at year-end and reported by the fund managers. The collective trusts provide for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirement.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 6 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan holds a fully benefit-responsive investment contract (guaranteed investment contract or “GIC”) with New York Life Insurance Company (“NY Life”), also referred to as the investments that are reported at contract value. NY Life manages this investment and maintains the contributions in its pooled separate account (branded as the “Anchor Account.”). The assets of the Anchor Account are owned by NY Life. The Anchor Account is credited with earnings on the underlying investments and is charged for participant withdrawals and administrative expenses. Participants ordinarily may direct the withdrawal or transfer of all or a portion of their investments at contract value. There are no reserves against contract value for credit risk of NY Life or otherwise. The contract has no maturity date, but contract years begin on January 1 of each year.

Under the terms of the contract, interest will accrue daily, be credited monthly and the rate cannot be less than zero percent. The daily rate fluctuates based on the underlying investments. Realized gains and losses are amortized over the target duration.

NOTE 6 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT (Continued)

The Plan's group annuity contract specifies certain conditions under which distributions from the contract would be payable at amounts below contract value. Such circumstances include Plan termination, Plan merger, premature contract termination initiated by the Company, and certain other Company-initiated events that result in distributions exceeding a set amount. The contract limits the circumstances under which NY Life may terminate the contract. Examples of circumstances which would allow NY Life to terminate the contract include the Plan's loss of its qualified status, uncured material breaches of responsibilities, or material and adverse changes to the provisions of the Plan. If one of these events were to occur, NY Life could terminate the contract at an amount less than contract value. Currently, management believes that the occurrence of an event that would cause the Plan to transact contract distributions at less than contract value is not probable.

NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain Plan investments are shares of mutual funds offered by an affiliate of Fidelity Management Trust Company ("Fidelity"). Fidelity was the trustee as defined by the Plan, and therefore, these investments and transactions qualify as exempt party-in-interest transactions. Payment of trustee fees, record keeping fees, loan origination fees, and investment management fees to Fidelity qualify as party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned by the Plan and are also considered party-in-interest transactions. Certain employees and officers of the Employer, who may also be Plan participants, perform administrative services to the Plan at no cost to the Plan. In addition, the Plan allows for loans to be made to participants from their accounts which result in notes receivable from Plan participants. These qualify as exempt party-in-interest transactions.

NOTE 8 - FEDERAL INCOME TAX STATUS

Effective November 1, 2021, the Plan was restated on a prototype document that has received an opinion letter from the Internal Revenue Service dated June 30, 2020. Although the Plan has been amended from the original prototype document, Plan management believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
