### **Independent Auditor's Report**

#### **Opinion**

We have audited the accompanying financial statements of the Southern California Plastering Institute Group Benefit Trust Fund (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA) which comprise the statements of net assets available for benefits and of benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in plan benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits and plan benefit obligations of the Southern California Plastering Institute Group Benefit Trust Fund as of December 31, 2024 and 2023 and changes in net assets available for benefits and plan benefit obligations for the years then ended in accordance with accounting principles generally accepted in the United States of America.

## NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

### 1. DESCRIPTION OF THE PLAN

The following brief description of the Southern California Plastering Institute Group Benefit Trust Fund (Plan) is provided for general information purposes only. Participants should refer to the Summary Plan Description for more complete information regarding the Plan's provisions.

#### General

The Agreement creating this Plan was entered into as of August 4, 1952, between the Operative Plasterers and Cement Masons International Association, Local 200 and certain associations of contractors in Southern California. The Plan provides health benefits covering all eligible participants. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The disbursements of the Plan are under the joint control of labor and management trustees.

#### Medical, Dental and Vision Benefits

The Plan provides health (including hospital, surgical, major medical, dental, vision, and life) benefits for eligible participants and their dependents who have credited to their hour bank account at the end of the applicable work period, a total of at least 300 covered hours.

#### Retiree Benefits

The only benefits provided to retirees are medical, if the retiree is under age 65, and death benefits, which does not have any age limit.

#### Contributions

The Plan agreement provides for signatory contractors to contribute the amount specified in the collective bargaining agreement for each hour worked by covered employees. The Plan receives the majority of its income from construction contractors working mainly in the various counties in the Southern California area. For each hour worked by covered employee, employers contributed \$9.63 and \$9.63 as of December 31, 2024 and 2023, respectively.

#### Priorities Upon Termination

In the event this Plan is terminated by mutual consent of the Employers and the Union, any monies remaining in the Plan after the payment of all expenses shall be used for the continuance of plan benefits in accordance with ERISA and other applicable laws.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Basis of Accounting

The Plan's audited financial statements are prepared on the accrual basis of accounting, in conformity with accounting principles generally accepted in the United States of America.

#### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, premiums payable, eligibility credits, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### Employer Contributions Receivable

These amounts represent contributions due from employers for December or prior hours worked. Most of these contributions were received by the Plan during January. Management believes all contributions receivable are collectible and no allowance for uncollectible accounts has been provided.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

#### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation/(depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year and is reflected as the difference between cost and fair value. For Form 5500 reporting, realized and unrealized gains and losses are computed using the investments' fair values as of the beginning of the year. For investments purchased during the year, realized and unrealized gains and losses are presented in the same manner for financial statement purposes and Form 5500 purposes.

#### Estimated Future Benefits Based on Participants' Accumulated Eligibility

The accrued liability for future benefits is based on the months of eligibility as of December 31, multiplied by the estimated monthly cost of benefits.

### 3. INVESTMENTS – FAIR VALUE MEASUREMENTS

In accordance with U.S. GAAP, fair value is defined as the price the Plan would receive to sell an asset or pay for a liability in an orderly transaction between market participants. A three-tier hierarchy has been established for presenting valuations, based on the transparency of inputs into valuation techniques used to measure fair valuation. The inputs may be observable or unobservable and refer broadly to the assumptions that market participants would consider significant to value an asset or liability, based on the best information available in the circumstances. Investments with readily-available active quoted prices or for which fair value can be measured from actively quoted prices in an orderly market will generally have a higher degree of market price observability and a lesser degree of judgment used in measuring fair value.

Investments measured and reported at fair value are classified and disclosed in one of the following categories based on inputs:

- Level 1 – Quoted prices for active markets for identical securities. An active market for the security is a market in which transactions occur with sufficient frequency and volume to provide pricing information on an ongoing basis. A quoted price in an active market provides the most reliable evidence of fair value.
- Level 2 – Other significant observable inputs (including quoted prices for similar securities, interest rates, prepayment speeds, credit risk, etc.), or quoted prices for identical or similar assets in markets that are not active. Inputs that are derived principally from or corroborated by observable market data. An adjustment to any observable input that is significant to the fair value may render the measurement a Level 3 measurement.

### 3. INVESTMENTS – FAIR VALUE MEASUREMENTS (CONTINUED)

The inputs or methodology used for valuing securities are not necessarily an indication of the risk associated with investing in those securities. The Plan's assets or liabilities fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. Management's assessment of the significance of a particular input to the fair value measurement in its entirety requires judgment and considers factors specific to the investment and the state of the marketplace. Although management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's investment assets and liabilities, if any, are reported at fair value in the accompanying statements of net assets available for benefits and their inputs for the years ended December 31, 2024 and 2023, respectively, are summarized as follows:

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

#### Level 1 Measurements

The fair values of the mutual funds are determined by reference to the fund's underlying assets. Shares held in the mutual funds are traded on national exchanges and are valued at the net asset value on the last business day of each period presented.

Cash equivalents are held in a money market fund. The money market fund has a quoted net asset value that represents the fair value of the fund.

### 4. FEDERAL INCOME TAX STATUS

The IRS has determined and informed the Plan sponsor by a letter dated September 23, 2015, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Management has adopted guidance on accounting for uncertainty in income taxes issued by the Financial Accounting Standards Board. Management believes that the Plan has taken no uncertain tax positions as of December 31, 2024 and 2023 that require adjustment to or disclosure in the financial statements in order to comply with the provisions of this guidance. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

### 5. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### 6. CONCENTRATION OF CREDIT RISK

The Federal Deposit Insurance Corporation (FDIC). The FDIC is an independent agency of the United States government that provides deposit insurance for protection against the loss of insured deposits if an FDIC insured bank or savings association fails. The Plan's cash in financial institution accounts exceeded the current FDIC insurance limits by \$283,326 and \$339,970 for the years ended December 31, 2024 and 2023, respectively.

### 8. RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS

The Plan shares certain administrative expenses with the Southern California Plastering Institute Pension Trust Fund ("Pension Trust Fund"), the Southern California Plastering Institute Vacation Trust Fund and other affiliated entities. On a monthly basis, these expenses are initially paid by the Pension Trust Fund and a pro-rata portion of the expenses are allocated to the other associated plans and entities and subsequently reimbursed to the Pension Trust Fund. These shared expenses are based on allocation percentages agreed upon by the Board of Trustees.

The Plan paid certain expenses related to plan operations and investment activity to various service providers.

The transactions noted prior qualify as party-in-interest transactions which are exempt from the prohibited transaction rules of ERISA.

### 9. SUBSEQUENT EVENTS

An evaluation of subsequent events through September 25, 2025 the date the financial statements were available to be issued, has determined no additional items required recognition or disclosure.
