Basis for Opinion

NOTES TO THE FINANCIAL STATEMENTS

NOTE 1—DESCRIPTION OF PLAN

The following description of Total Wine & More 401(k) Plan (the “Plan”) provides only general information. Interested parties should refer to the Plan document for a more complete description of the Plan’s provisions.

General – The Plan is a participant-directed defined-contribution plan covering all regular full-time and part-time employees of Retail Services & Systems, Inc. and its subsidiaries and affiliated companies (collectively, the “Company”) who are age 20 ½ or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Employees become eligible to provide voluntary compensation deferrals on the first day of employment, with service requirements in order to become eligible for Company matching contributions.

Fidelity Management Trust Company is the custodian and non-discretionary trustee for the Plan. The Plan’s 401(k) committee is responsible for oversight of the Plan and determining the appropriateness of the Plan’s investment offerings and for monitoring the Plan’s investment performance.

Contributions –Participants may contribute up to a maximum percentage of their pretax annual compensation allowable, not to exceed the limits of IRS Code Section 401(k), 402(g), 404, and 415. The contribution limit was \$23,000 for 2024 and \$22,500 for the 2023 plan years. In addition, catch-up contributions of \$7,500 were allowed for participants 50 years of age and older for the 2024 and 2023 plan years, respectively. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan and may change their investment options at any time.

The Company makes a matching contribution, equal to 50% of each participant’s contribution, on up to 6% of the participant’s compensation. Additional profit-sharing amounts may be contributed at the option of the Company’s board of directors. Contributions are subject to certain limitations as defined in the Plan agreement and as limited by statute. Additional contributions of \$240,772 and \$0 were made during the years ended December 31, 2024 and 2023, respectively.

Participant Accounts – Each participant’s account is credited with the participant’s contributions and allocations of (a) the Company’s matching contributions and (b) Investment earnings (losses) and is charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested balance.

Vesting – Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company contribution portion of their accounts, plus actual earnings thereon, is based on years of continuous service, with at least 1,000 hours of service required to be credited for a year of service.

The vesting schedule is as follows:

Notes Receivable from Participants – Participants may borrow from their account a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Such borrowings are secured by the balance in the participant’s account and bear interest at a fixed rate of interest that is

one percent (1%) above the prime interest rate. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits – Participants are eligible to receive distributions upon disability, death, or termination of employment with the Company. A participant or beneficiary may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account or to leave the balance in the Plan. The Plan allows for automatic distributions of such participant account balances that do not exceed \$5,000.

Pre-Retirement Distributions – Hardship distributions are allowed by the Plan.

Forfeited Accounts – Any portion of a participant's account which is not vested is forfeited upon the participant's termination of service. Forfeitures of employer contributions may be used to pay administrative expenses or to reduce employer contributions.

During 2024 and 2023, forfeitures of \$619,201 and \$163,526, respectively, were reallocated to the remaining active participants by reducing employer matching contributions. At December 31, 2024 and 2023, the forfeiture account balances for future reallocation were \$4,477 and \$186,529, respectively.

Plan Expenses and Costs – Certain administrative expenses are paid for by the Company and are excluded from these financial statements, while others are paid for by the Plan. Fees related to the administration of participant accounts and benefit payments are charged directly to the participants' accounts and are included in administrative expenses in the Statements of Changes in Net Assets Available for Benefits. Investment-related expenses are included in net appreciation in fair value of investments.

NOTE 2—SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that could affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value, including the common/collective trust, which holds indirect investments in fully benefit-responsive investment contracts. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 3 for further discussion and disclosures related to fair value measurements.

Net appreciation or depreciation in fair value of investments includes realized gains and losses on investments sold during the year, as well as the current-year change in unrealized appreciation and depreciation of investments.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest is recorded as earned.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid, interest. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits paid to participants are recorded when paid.

Income Taxes

The Plan has adopted a pre-approved profit sharing plan document sponsored by Fidelity Management & Research Company. The IRS has determined by a letter dated June 30, 2020, that the plan document is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Management has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in these financial statements.

The Plan is subject to routine audits by taxing jurisdictions. There are currently no audits in progress for any tax periods. Management believes that it is no longer subject to informational return examinations for years prior to 2021.

NOTE 3—FAIR VALUE MEASUREMENTS (UNAUDITED, SEE NOTE 4)

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2* Inputs to the valuation methodology include:
- Quoted Prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Shares of registered investment companies (Mutual Funds) are reported at fair value based on the quoted market price of the fund, which represents the net asset value of the investments held by the fund at year-end. The Mutual Funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The Mutual Funds held by the Plan are considered to be actively traded.

Stable Value Common/Collective Trust Fund: This fund is valued at the net asset value of units of the collective trust, as determined by the issuer. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months notification in order to ensure that securities liquidations will be carried out in an orderly business manner. The collective trust's primary investment objectives are to seek the preservation of principal and to provide interest income reasonably obtained under prevailing market conditions and rates, consistent with seeking to maintain required liquidity. There are no unfunded commitments and the redemption frequency is daily.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4—INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE (UNAUDITED)

The trustee of the Plan, Fidelity Management Trust Company, has certified that certain information disclosed in the accompanying financial statements and supplemental schedule is complete and accurate as of and for the years ended December 31, 2024 and 2023, in accordance with Section 2520.103-5 of DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information includes the composition, cost, and current value of all cash, investments, and notes receivable from participants, as reported in the Statements of Net Assets Available for Benefits and Supplemental Schedule and the interest and dividends and net appreciation (depreciation) in fair value of investments and interest on notes receivable from participants, as reported in the Statements of Changes in Net Assets Available for Benefits.

NOTE 5—AMENDMENT AND TERMINATION

It is the intention of the Company to continue the Plan indefinitely and to make contributions as herein provided. The Company reserves the right, in its sole discretion, by written action of the Plan Committee, to amend the Plan, terminate the Plan, or to reduce or cease contributions at any time. Notwithstanding any other provision of this Plan, no action to amend or terminate the Plan may have the effect of decreasing, denying, or otherwise adversely affecting any benefit to a participant that is a "protected benefit" within the meaning of Code Section 411(d)(6) and the Treasury Regulations thereunder. In the event of Plan termination, participants will become 100% vested in amounts attributed to the Company's contributions.

The Plan was last amended effective December 9, 2024 to change the Plan's legal name.

NOTE 6—RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

NOTE 7—RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under DOL Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Company, and certain others.

Notes receivable from Plan participants qualify as party-in-interest transactions, which are exempt from the prohibited transactions rules.

During the years ended December 31, 2024 and 2023, administrative fees of \$273,337 and \$208,951, respectively, were paid by the Plan to the trustee, which qualify as party-in-interest transactions. The Plan sponsor also pays certain fees and expenses of the Plan.

NOTE 8—SUBSEQUENT EVENTS

Management has evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements as of the date of the independent auditor's report, which is the date the financial statements were available to be issued. There were no subsequent events requiring adjustments to the financial statements or disclosures, as stated herein.
