## Independent Auditor's Report

To the Trustees  
The Altenheim 401(k) Plan

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements***

We have performed an audit of the financial statements of The Altenheim 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.



### 1. DESCRIPTION OF PLAN

The following description of the The Altenheim 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**General** - The Altenheim 401(k) Plan (the Plan) is a 401(k) profit sharing plan that covers all eligible employees of West Side Deutscher Frauen Verein dba The Altenheim (the Organization and Plan Sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The plan is a defined contribution plan established effective November 1, 2008, as restated August 24, 2020. The Organization's Board of Trustees is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

There were law and operational changes impacting plans due to the passing of the Coronavirus Aid, Relief, and Economic Security Act. Any optional features from the recent law changes that were adopted by the Plan requires written amendments before December 31, 2025, in accordance with applicable law and Internal Revenue Service (IRS) guidance.

**Contributions** - Participants may elect to contribute a percentage of their compensation into the plan on a pre-tax or post-tax basis. The amount participants can contribute on an annual basis is limited to the amount set by the IRS. The post-tax contributions by participants are Roth contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contributions plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. Participants must be 21 years of age and complete six months of service in order to be eligible to participate in the Plan.

The Organization may make discretionary contributions based on a percentage of participants' compensation and provides for 100 percent safe harbor matching contributions on a maximum of 4 percent of participant elective deferrals. Employer matching contributions totaled \$176,282 in 2024.

Additional employer discretionary contributions may be made by the Organization. The Organization did not make any additional employer discretionary contributions in 2024. These contributions would be allocated among the participants based upon annual compensation.

## Notes to the Financial Statements

December 31, 2024 and 2023

**Participant accounts** - Each participant's account is credited with the participant's contribution, Company contributions and an allocation of the Plan's earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participants vested account.

**Vesting** - Participants are immediately vested in the value of their account attributable to the participant contributions, employer contributions and investment earnings/losses.

Forfeitures of nonvested accounts are retained in the Plan and used to offset administrative expenses or reduce future employer contributions. No forfeitures were used to reduced employer contributions during 2024. Unallocated forfeitures amounted to \$12,092 and \$11,548 at December 31, 2024 and 2023, respectively.

Payment of benefits - Participants who suffer serious financial hardship, as defined by the Plan, may withdraw a portion of their vested account in order to meet their financial needs. Once participants attain age 59-1/2, they may also elect to withdraw from their account, any amount not to exceed their vested portion. All accounts are subject to distribution upon the participant's termination, retirement or death and will be distributed as a single lump sum. Participants may defer receipt of benefits until a later date. However, If the vested account balance is \$7,000 or less in which case the Plan Administrator will direct the trustee that any account exceeding \$1,000 be distributed to an Individual Retirement Account or Annuity (IRA).

**Investment options** - Upon enrollment in the Plan, a participant may direct participant contributions, including the employer's portion, into a number of investment options. Participants may change their investment elections daily.

## 2. SUMMARY OF ACCOUNTING POLICIES

**Basis of accounting** - The financial statements of the Plan are prepared under the accrual method.

**Use of estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts in the financial statements and accompanying notes. Actual results could differ from those estimates and assumptions.

## Notes to the Financial Statements

**Investment valuation and income recognition** - The Plan's investments are recorded at fair value, which is determined by net asset values of the mutual funds and face value of the money market fund at December 31, 2024 and 2023. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transactions between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net increase (decrease) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Administrative expenses** - Certain expenses of maintaining the Plan are paid directly by the Organization and are excluded from these financial statements. Investment-related expenses are included in net increase in fair value of investments in the statement of changes in net assets available for benefits.

**Payment of benefits** - Benefits are recorded when paid.

**Subsequent events** - Subsequent events were evaluated through October 13, 2025, the date the financial statements were available to be issued.

### 3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification, *Fair Value Measurement*, are described as follows:

Level 1 - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

## Notes to the Financial Statements

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

*Money market funds:* Valued at the quoted net asset value (NAV) of shares held by the Plan at year end.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**4. INFORMATION CERTIFIED BY TRUSTEE**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Fidelity Management Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of all investments reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

**5. TAX STATUS**

The Plan adopted a pre-approved plan offered by FMR LLC. The pre-approved plan received an IRS Opinion Letter dated June 30, 2020, which stated that the Plan and related trust are designed in accordance with the applicable sections of the IRC. The Plan administrator believes that the plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023 there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**6. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the individual accounts of the affected participants become nonforfeitable and fully vested.

**7. RISKS AND UNCERTAINTIES**

The Plan invested in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

**8. RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS**

Certain administrative functions of the Plan are performed by officers or employees of the Organization. No such officer or employee receives compensation from the Plan. Additionally, certain administrative expenses are paid by the Plan Sponsor.

Certain investments are managed by Fidelity Investments Institutional Operations Company, Inc., who is an affiliate of Fidelity Management Trust Company and, therefore, these transactions qualify as party in interest transactions.

**9. DELINQUENT PARTICIPANT CONTRIBUTIONS**

For the year ended December 31, 2024, the Organization did not remit certain participant contributions to the Plan on a timely basis as defined by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Untimely remittances identified on the Schedule of Delinquent Participant Contributions, which totaled \$20,000, were not corrected in 2024. Additionally, the Organization will be compensating participants for lost earnings resulting from the delay in contributions.

## Independent Auditor's Report

To the Trustees  
The Altenheim 401(k) Plan

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements***

We have performed an audit of the financial statements of The Altenheim 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.



### 1. DESCRIPTION OF PLAN

The following description of the The Altenheim 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**General** - The Altenheim 401(k) Plan (the Plan) is a 401(k) profit sharing plan that covers all eligible employees of West Side Deutscher Frauen Verein dba The Altenheim (the Organization and Plan Sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The plan is a defined contribution plan established effective November 1, 2008, as restated August 24, 2020. The Organization's Board of Trustees is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

There were law and operational changes impacting plans due to the passing of the Coronavirus Aid, Relief, and Economic Security Act. Any optional features from the recent law changes that were adopted by the Plan requires written amendments before December 31, 2025, in accordance with applicable law and Internal Revenue Service (IRS) guidance.

**Contributions** - Participants may elect to contribute a percentage of their compensation into the plan on a pre-tax or post-tax basis. The amount participants can contribute on an annual basis is limited to the amount set by the IRS. The post-tax contributions by participants are Roth contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contributions plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. Participants must be 21 years of age and complete six months of service in order to be eligible to participate in the Plan.

The Organization may make discretionary contributions based on a percentage of participants' compensation and provides for 100 percent safe harbor matching contributions on a maximum of 4 percent of participant elective deferrals. Employer matching contributions totaled \$176,282 in 2024.

Additional employer discretionary contributions may be made by the Organization. The Organization did not make any additional employer discretionary contributions in 2024. These contributions would be allocated among the participants based upon annual compensation.

**Participant accounts** - Each participant's account is credited with the participant's contribution, Company contributions and an allocation of the Plan's earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participants vested account.

**Vesting** - Participants are immediately vested in the value of their account attributable to the participant contributions, employer contributions and investment earnings/losses.

Forfeitures of nonvested accounts are retained in the Plan and used to offset administrative expenses or reduce future employer contributions. No forfeitures were used to reduced employer contributions during 2024. Unallocated forfeitures amounted to \$12,092 and \$11,548 at December 31, 2024 and 2023, respectively.

Payment of benefits - Participants who suffer serious financial hardship, as defined by the Plan, may withdraw a portion of their vested account in order to meet their financial needs. Once participants attain age 59-1/2, they may also elect to withdraw from their account, any amount not to exceed their vested portion. All accounts are subject to distribution upon the participant's termination, retirement or death and will be distributed as a single lump sum. Participants may defer receipt of benefits until a later date. However, If the vested account balance is \$7,000 or less in which case the Plan Administrator will direct the trustee that any account exceeding \$1,000 be distributed to an Individual Retirement Account or Annuity (IRA).

**Investment options** - Upon enrollment in the Plan, a participant may direct participant contributions, including the employer's portion, into a number of investment options. Participants may change their investment elections daily.

## 2. SUMMARY OF ACCOUNTING POLICIES

**Basis of accounting** - The financial statements of the Plan are prepared under the accrual method.

**Use of estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts in the financial statements and accompanying notes. Actual results could differ from those estimates and assumptions.

**Investment valuation and income recognition** - The Plan's investments are recorded at fair value, which is determined by net asset values of the mutual funds and face value of the money market fund at December 31, 2024 and 2023. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transactions between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net increase (decrease) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Administrative expenses** - Certain expenses of maintaining the Plan are paid directly by the Organization and are excluded from these financial statements. Investment-related expenses are included in net increase in fair value of investments in the statement of changes in net assets available for benefits.

**Payment of benefits** - Benefits are recorded when paid.

**Subsequent events** - Subsequent events were evaluated through October 13, 2025, the date the financial statements were available to be issued.

### 3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification, *Fair Value Measurement*, are described as follows:

Level 1 - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

*Money market funds:* Valued at the quoted net asset value (NAV) of shares held by the Plan at year end.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**4. INFORMATION CERTIFIED BY TRUSTEE**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Fidelity Management Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of all investments reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

**5. TAX STATUS**

The Plan adopted a pre-approved plan offered by FMR LLC. The pre-approved plan received an IRS Opinion Letter dated June 30, 2020, which stated that the Plan and related trust are designed in accordance with the applicable sections of the IRC. The Plan administrator believes that the plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023 there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**6. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the individual accounts of the affected participants become nonforfeitable and fully vested.

**7. RISKS AND UNCERTAINTIES**

The Plan invested in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

**8. RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS**

Certain administrative functions of the Plan are performed by officers or employees of the Organization. No such officer or employee receives compensation from the Plan. Additionally, certain administrative expenses are paid by the Plan Sponsor.

Certain investments are managed by Fidelity Investments Institutional Operations Company, Inc., who is an affiliate of Fidelity Management Trust Company and, therefore, these transactions qualify as party in interest transactions.

**9. DELINQUENT PARTICIPANT CONTRIBUTIONS**

For the year ended December 31, 2024, the Organization did not remit certain participant contributions to the Plan on a timely basis as defined by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Untimely remittances identified on the Schedule of Delinquent Participant Contributions, which totaled \$20,000, were not corrected in 2024. Additionally, the Organization will be compensating participants for lost earnings resulting from the delay in contributions.

## Independent Auditor's Report

To the Trustees  
The Altenheim 401(k) Plan

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements***

We have performed an audit of the financial statements of The Altenheim 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.



### 1. DESCRIPTION OF PLAN

The following description of the The Altenheim 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**General** - The Altenheim 401(k) Plan (the Plan) is a 401(k) profit sharing plan that covers all eligible employees of West Side Deutscher Frauen Verein dba The Altenheim (the Organization and Plan Sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The plan is a defined contribution plan established effective November 1, 2008, as restated August 24, 2020. The Organization's Board of Trustees is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

There were law and operational changes impacting plans due to the passing of the Coronavirus Aid, Relief, and Economic Security Act. Any optional features from the recent law changes that were adopted by the Plan requires written amendments before December 31, 2025, in accordance with applicable law and Internal Revenue Service (IRS) guidance.

**Contributions** - Participants may elect to contribute a percentage of their compensation into the plan on a pre-tax or post-tax basis. The amount participants can contribute on an annual basis is limited to the amount set by the IRS. The post-tax contributions by participants are Roth contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contributions plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. Participants must be 21 years of age and complete six months of service in order to be eligible to participate in the Plan.

The Organization may make discretionary contributions based on a percentage of participants' compensation and provides for 100 percent safe harbor matching contributions on a maximum of 4 percent of participant elective deferrals. Employer matching contributions totaled \$176,282 in 2024.

Additional employer discretionary contributions may be made by the Organization. The Organization did not make any additional employer discretionary contributions in 2024. These contributions would be allocated among the participants based upon annual compensation.

## Notes to the Financial Statements

**Participant accounts** - Each participant's account is credited with the participant's contribution, Company contributions and an allocation of the Plan's earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participants vested account.

**Vesting** - Participants are immediately vested in the value of their account attributable to the participant contributions, employer contributions and investment earnings/losses.

Forfeitures of nonvested accounts are retained in the Plan and used to offset administrative expenses or reduce future employer contributions. No forfeitures were used to reduced employer contributions during 2024. Unallocated forfeitures amounted to \$12,092 and \$11,548 at December 31, 2024 and 2023, respectively.

Payment of benefits - Participants who suffer serious financial hardship, as defined by the Plan, may withdraw a portion of their vested account in order to meet their financial needs. Once participants attain age 59-1/2, they may also elect to withdraw from their account, any amount not to exceed their vested portion. All accounts are subject to distribution upon the participant's termination, retirement or death and will be distributed as a single lump sum. Participants may defer receipt of benefits until a later date. However, If the vested account balance is \$7,000 or less in which case the Plan Administrator will direct the trustee that any account exceeding \$1,000 be distributed to an Individual Retirement Account or Annuity (IRA).

**Investment options** - Upon enrollment in the Plan, a participant may direct participant contributions, including the employer's portion, into a number of investment options. Participants may change their investment elections daily.

## 2. SUMMARY OF ACCOUNTING POLICIES

**Basis of accounting** - The financial statements of the Plan are prepared under the accrual method.

**Use of estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts in the financial statements and accompanying notes. Actual results could differ from those estimates and assumptions.

**Investment valuation and income recognition** - The Plan's investments are recorded at fair value, which is determined by net asset values of the mutual funds and face value of the money market fund at December 31, 2024 and 2023. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transactions between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net increase (decrease) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Administrative expenses** - Certain expenses of maintaining the Plan are paid directly by the Organization and are excluded from these financial statements. Investment-related expenses are included in net increase in fair value of investments in the statement of changes in net assets available for benefits.

**Payment of benefits** - Benefits are recorded when paid.

**Subsequent events** - Subsequent events were evaluated through October 13, 2025, the date the financial statements were available to be issued.

### 3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification, *Fair Value Measurement*, are described as follows:

Level 1 - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

*Money market funds:* Valued at the quoted net asset value (NAV) of shares held by the Plan at year end.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**4. INFORMATION CERTIFIED BY TRUSTEE**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Fidelity Management Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of all investments reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

**5. TAX STATUS**

The Plan adopted a pre-approved plan offered by FMR LLC. The pre-approved plan received an IRS Opinion Letter dated June 30, 2020, which stated that the Plan and related trust are designed in accordance with the applicable sections of the IRC. The Plan administrator believes that the plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023 there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**6. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the individual accounts of the affected participants become nonforfeitable and fully vested.

**7. RISKS AND UNCERTAINTIES**

The Plan invested in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

**8. RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS**

Certain administrative functions of the Plan are performed by officers or employees of the Organization. No such officer or employee receives compensation from the Plan. Additionally, certain administrative expenses are paid by the Plan Sponsor.

Certain investments are managed by Fidelity Investments Institutional Operations Company, Inc., who is an affiliate of Fidelity Management Trust Company and, therefore, these transactions qualify as party in interest transactions.

**9. DELINQUENT PARTICIPANT CONTRIBUTIONS**

For the year ended December 31, 2024, the Organization did not remit certain participant contributions to the Plan on a timely basis as defined by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Untimely remittances identified on the Schedule of Delinquent Participant Contributions, which totaled \$20,000, were not corrected in 2024. Additionally, the Organization will be compensating participants for lost earnings resulting from the delay in contributions.
