Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Retirement Plan for Employees of Southern California Presbyterian Homes (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"). The financial statements comprise the statements of net assets available for benefits (In Liquidation) as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits (In Liquidation) for the years then ended, and the related notes to the financial statements (In Liquidation).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis-of-Matter - Plan Termination and Liquidation Basis of Accounting

As discussed in Notes 1, 2 and 6 to the financial statements, the Board of Trustees of the Plan approved a plan of liquidation on October 27, 2022, and management determined liquidation is imminent. As a result, the Plan changed its basis of accounting from the going concern basis to the liquidation basis used in presenting the 2024 and 2023 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a significant likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Notes to Financial Statements (In Liquidation) December 31, 2024 and 2023

Note 1 - Plan description

The following description of Retirement Plan for Employees of Southern California Presbyterian Homes (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Retirement Plan for Employees of Southern California Presbyterian Homes is a defined benefit plan covering substantially all employees of HumanGood SoCal (formerly Southern California Presbyterian Homes, dba be.group) (the "Company" or "Plan Sponsor"). The Plan provides for retirement and death benefits. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Board of Directors is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Directors. The Plan Sponsor has agreed to contribute such amounts as are necessary to provide assets sufficient to meet the benefits to be paid to the Plan's participants. The Plan has met the minimum funding requirement under ERISA for each of the years ended December 31, 2024 and 2023. The Plan's recordkeeper is Transamerica Retirement Solutions, LLC ("TransAmerica").

Certain officers and employees of the Plan Sponsor serve as the Plan's administrator and on its Investment Committee. The Plan's Investment Committee has full responsibility for interpreting and administering the Plan. No officer or employee of the Plan Sponsor receives compensation from the Plan.

On October 27, 2022, it was resolved by the Board of Directors to terminate the Plan. The Plan Sponsor has terminated the Plan effective February 28, 2023 ("Termination Date"). All participants shall be fully vested as of the Termination Date. The Plan offered a voluntary limited-time option to elect an immediate lump sum payment of the entire vested accrued pension benefit under the Plan or to select an annuity payment option already available under the Plan.

Principal Life Insurance Company (the "Insurer") and the Plan Sponsor entered into a contract whereby the Insurer shall provide a nonparticipating single premium group annuity contract (the "Contract"), supported by its general account, to the Plan Sponsor, as sponsor of the Plan. The annuity premium payment of \$16,726,325 was paid by the Plan for purchasing the Contract. The Plan was terminated effective December 30, 2024 and \$6,243,223 was refunded to the Plan Sponsor.

Eligibility

Prior to December 31, 2009, employees who were at least 21 years of age were eligible to participate following the completion of one year of service, provided 1,000 hours of service had been completed during such 12-month period.

Effective December 31, 2009, the Plan was frozen to new participants. All benefits that had accrued under the Plan were retained, but future salary increases will not be taken into account in computing retirement benefits.

Vesting and benefits

For employees who met eligibility requirements for participation prior to December 31, 2009, those with five or more years of service are entitled to annual pension benefits beginning at normal retirement age (65) equal to 1.48% of average earnings up to covered compensation, plus 2.13% of average earnings in excess of covered compensation times credited service up to a maximum of 30 years. Average earnings are an average of the earnings for three consecutive Plan years of highest earnings during the last five years of service prior to retirement, limited to earnings through December 31, 2009. The covered compensation is the average of the maximum amount of earnings subject to social security tax during the 35-year period ending in the calendar year of attainment on the participant's social security retirement age. The maximum compensation level used for the year ended December 31, 2009, the last year of accrued benefits to the Plan, was limited to \$265,000 as required by federal law.

The Plan was amended in 2014 to allow participants who terminate employment to elect lump-sum payment options under the Plan.

The Plan permits early retirement at ages 55 to 64 with a reduced benefit. Employees may elect to receive their pension benefit in the form of a joint and survivor annuity. Employees generally receive the value of their accumulated benefits as a life annuity payable monthly from the date of retirement. Monthly annuity payments are subject to an annual cost of living adjustment, with no annual increase or decrease to exceed 3%.

If a vested employee dies and has been married for at least one year, his or her spouse will be entitled to receive 50% of the accrued pension less 0.5% for each year (if any) that the spouse was more than five years younger than the employee. However, the pension benefit will never be less than \$120 per year or 40% of the accrued pension.

For more comprehensive information regarding the vesting and benefit provisions and the Pension Benefit Guarantee Corporation's ("PBGC") benefit guarantee, please refer to the Plan agreement.

Funding policy

Contributions to provide benefits under the Plan are made solely by the Plan Sponsor. The Plan Sponsor's funding policy is to make cash contributions to the Plan in amounts determined by the Plan's independent actuary, TransAmerica. The Plan Sponsor was not required to make contributions for the years ended December 31, 2024 and 2023. The Plan Sponsor has met the minimum funding requirements of ERISA for both years ended December 31, 2024 and 2023.

Administrative expenses

Administrative expenses of the Plan have been paid by the Plan Sponsor except for service charges paid for investment management, which are charged to the Plan.

Plan termination

On October 27, 2022, it was resolved by the Board of Directors to terminate the Plan. As a result of the Plan termination, in accordance with accounting principles generally accepted in the United States of America ("GAAP"), the financial statements are presented on the liquidation basis of accounting (see Note 2).

Note 2 - Summary of significant accounting policies

Basis for presentation

In accordance with GAAP, due to the Plan Sponsor's decision to terminate the Plan on October 27, 2022, the financial statements as of and for the years ended December 31, 2024 and 2023 were prepared using the liquidation basis of accounting to determine the amounts at which Plan assets are stated.

Use of estimates

The preparation of financial statements in conformity with GAAP require management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, disclosure of contingent assets and liabilities and the actuarial present value of accumulated Plan benefits at the date of the financial statements and changes therein. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, trustee and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Interest and dividend income are included in net appreciation (depreciation) in fair value of investments. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits

Benefits payments to participants are recorded upon distribution.

Expenses

Expenses of maintaining the Plan that are paid directly by the Company are excluded from these financial statements. Certain administrative expenses paid by the Plan (see Note 1) are recorded as deductions in the accompanying statements of changes in net assets available for benefits (in liquidation). In addition, certain investment related expenses are included in net appreciation (depreciation) in fair value of investments in the accompanying statements of changes in net assets available for benefits (in liquidation).

Subsequent events

The Plan has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

Note 3 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of fair value hierarchy under Financial Accounting Standards Board ("FASB") issued Accounting Standards Codification ("ASC") 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Common/collective trusts: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Note 4 - Actuarial present value of Accumulated Plan benefits

Accumulated Plan benefits are those estimated future periodic payments that are attributable under the Plan's provisions to service rendered by the participants up to and including the valuation date. Accumulated Plan benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries or employees who have died, and (c) present employees or their beneficiaries.

The actuarial present value of accumulated Plan benefits is determined by an independent actuary and is measured using the Unit Credit Actuarial Cost Method. The actuarial present value of accumulated Plan benefits is that amount that results from applying the actuarial assumptions to adjust the accumulated Plan benefits earned by the participants to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death or retirement) for the period between the valuation date and the expected date of payment. The Plan Sponsor terminated the Plan, hence no computations of the actuarial present value of accumulated Plan benefits was prepared for the years ended December 31, 2024 and 2023.

Note 5 - Related party and party-in-interest transactions

Certain Plan assets are invested in mutual funds and collective trusts managed by State Street Bank and Trust Company. Transactions involving these investments are considered to be party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. Administrative fees paid by the Plan to the Plan's recordkeeper were \$16,550 and \$78,863 for the years ended December 31, 2024 and 2023, respectively.

Note 6 - Plan termination

As discussed in Note 1, the Plan Sponsor made the decision to terminate the Plan effective February 28, 2023, subject to the provisions of ERISA. All net assets of the Plan were allocated, as prescribed by ERISA and its related regulations.

Note 7 - Income tax status

The Internal Revenue Service ("IRS") has determined and informed the Plan Sponsor by a letter dated January 22, 2021, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC").

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 - Certified investments

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments held at December 31, 2024 and 2023, and investment income (loss) for the years then ended, which are disclosed in the accompanying financial statements and supplemental schedule, were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by State Street Bank and Trust Company, the trustee of the Plan.

Note 9 - Reconciliation of financial statements to Form 5500
