## Notes to the Financial Statements

---

### (1) Description of Plan

The following description of the A to Z Drying, Inc. Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering all employees of A to Z Drying, Inc. (Company) who have completed six months of service and are age 18 or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan adopted a prototype plan document that was provided by Minnesota Life Insurance Company (Minnesota Life). The Plan's prototype plan document received its latest opinion letter dated June 30, 2020, in which the Internal Revenue Service stated that the plan, as then designed, was acceptable under Section 401 of the Internal Revenue Code for use by employers for the benefit of their employees. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with all applicable requirements of the Internal Revenue Code. Therefore, it believes that the Plan was qualified and the related trust was tax exempt as of the financial statement date. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

#### Contributions

The Plan allows participants to make pretax contributions, Roth contributions or a combination of both up to 100% of their eligible compensation, subject to amounts allowed by IRS regulations. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover contributions). Participants who have attained age 50 before the end of the plan year are also eligible to make catch-up contributions.

Effective January 1, 2023, the Plan utilizes an automatic enrollment feature, enrolling participants in pretax elective deferrals at a rate of 3% of eligible compensation in the absence of an election otherwise.

The Company may make discretionary matching contributions and/or profit sharing contributions. For both of the years ended December 31, 2024 and 2023, the Company elected to match employee deferrals up to 6% of eligible compensation at a rate of 25%, resulting in a maximum employer matching contribution of 1.5% of eligible compensation. The Company did not make any profit sharing contributions for either of the years ended December 31, 2024 or 2023.

#### Participant Accounts

Each participant's account is credited with the participant's elective contributions, rollover contributions, discretionary matching contributions made by the Company and an allocation of Plan earnings and charged with an allocation of administrative expenses. Allocation of the Company's discretionary matching contributions is based on participant contributions.

Because all accounts are 100% participant directed, Plan earnings are attributable to the investments selected by each participant and allocated to each participant in a manner that reflects the investment experience of each participant's directions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

As of December 31, 2024 and 2023, there were no amounts allocated to the accounts of terminated participants who had requested distributions but had not yet been paid.

# Notes to the Financial Statements

## (1) Description of Plan

### Vesting

Participants are immediately vested in their elective deferral, rollover contributions plus earnings thereon. Vesting in the employer matching and profit sharing contributions plus earnings thereon is based on years of service as shown in the following schedule.

Years of Service	Vested Percentage
Less than 3.....	0%
3 or more.....	100%

Forfeitures of employer contributions may be used to reduce employer contributions or to pay Plan administrative expenses. During 2024 and 2023, total forfeitures were \$5,315 and \$1,398, respectively. Forfeitures of \$1,424 and \$0, respectively, were used to reduce the employer contribution and forfeitures of \$0 and \$698 were used to pay administrative expenses during the years ended December 31, 2024 and 2023, respectively. As of December 31, 2024 and 2023, there were \$4,638 and \$716, respectively, unallocated Plan assets resulting from forfeitures.

### Investment Options

Participants can direct the investment of their contributions among several pooled separate accounts and a stable value fund offered by the Plan. Participants may change their investment elections between the various options as often as they wish.

### Participant Notes Receivable

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account. Loan transactions are treated as a transfer to (from) the participant-directed investments from (to) the participant notes receivable. Participants may only have two loans outstanding at any time. Principal and interest is to be paid ratably through weekly payroll deductions.

### Payment of Benefits

Upon termination of service, a participant may elect to receive a lump-sum amount equal the value of his or her account, substantially equal installments or a partial withdrawal.

In-service distributions may be taken only after the participant has reached age 59-1/2.

Hardship distributions are allowed from the fully vested portions of participant accounts.

### Administrative Expenses

Certain expenses incurred in connection with the general administration of the Plan are paid by the Plan and recorded in the accompanying statements of changes in net assets available for plan benefits as administrative expenses. These administrative expenses are charged to participant accounts.

### Third-Party Fee Agreements

In addition to the administrative fees deducted from net assets on the face of the statements of changes in net assets available for plan benefits, the various investment providers to the Plan retain investment earnings to help cover the cost of operating the funds. These fees, which were less than 1% of investments for the years ended December 31, 2024 and 2023, have been netted against investment income.

## (1) Description of Plan

### Subsequent Events

Management has evaluated subsequent events through October 10, 2025, the date which the financial statements were available to be issued.

## (2) Summary of Significant Accounting Policies and Other Matters

### Basis of Accounting

The Plan prepares its financial statements on the accrual basis of accounting.

### Use of Estimates

The Plan Administrator uses estimates and assumptions in preparing financial statements. Those estimates and assumptions affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities and the reported changes in net assets available for plan benefits.

### Financial Instruments and Concentration of Credit Risk

The Plan's investments subject the Plan to concentrations of credit risk in that substantially all of those investments are held in a group annuity contract with Minnesota Life. Following customary practices, the Plan does not hold collateral for investments made through this source. The maximum potential credit loss to the Plan is limited to total Plan investments as shown on the accompanying statements of net assets available for plan benefits.

### Valuation of Investments

The Plan has a traditional fully benefit-responsive guaranteed investment contract with Minnesota Life. Minnesota Life maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 3%. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Minnesota Life, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

## Notes to the Financial Statements

### **(2) Summary of Significant Accounting Policies and Other Matters**

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (a) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA or (e) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (a) an uncured violation of the Plan's investment guidelines, (b) a breach of material obligation under the contract, (c) a material misrepresentation or (d) a material amendment to the agreement without the consent of the issuer.

Purchases and sales of securities are recorded on a trade-date basis. Realized gains and losses from security transactions are reported on the historical cost method. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

Gains and losses (realized and unrealized) are reported in net appreciation (depreciation) in value of investments on the statements of changes in net assets available for plan benefits.

Dividend income is to be separately stated. However, dividend income is included with the net appreciation in value of investments on reports obtained from the record keeper and detail was not available to permit segregation of dividend income. Therefore, dividend income has been included with the net appreciation in value of investments on the statements of changes in net assets available for plan benefits and on Form 5500.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Income Tax Status**

Plan management is required to evaluate tax positions taken by the Plan and disclose a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, as of December 31, 2024 and 2023, there were no audits for any tax periods in progress.

### (3) Certified Investment Information

The investment information and participant notes receivable presented in the accompanying statements of net assets available for plan benefits as of December 31, 2024, all investment income information presented in the statements of changes in net assets available for plan benefits for the year ended December 31, 2024 and the investment information in the supplemental schedule of assets (held at end of year) as of December 31, 2024 was provided by management and agreed to or derived from information certified as complete and accurate by Standard Insurance Company, the insurance carrier.

The investment information and participant notes receivable presented in the accompanying statements of net assets available for plan benefits as of December 31, 2023, and all investment income information presented in the statements of changes in net assets available for plan benefits for the year ended December 31, 2023 was provided by management and agreed to or derived from information certified as complete and accurate by Minnesota Life Insurance Company, the investment custodian.

### (5) Related-Party and Party-in-Interest Transactions

The Plan Sponsor paid certain administrative and auditing fees for the Plan which were approximately \$13,600 for both of the years ended December 31, 2024 and 2023. In addition, the Plan Sponsor provides participant data services to the Plan at no charge.

The Plan directly enters into party-in-interest transactions with service providers, including third-party administrators, investment advisors and auditors. Such transactions resulted in administrative fees as reflected in the statements of changes in net assets available for plan benefits. In addition, certain Plan investments are sponsored by Minnesota Life Insurance Company. Therefore, these transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules.

Two members of the Plan Sponsor's Board of Directors are participants in the Plan and also serve as Plan trustees.

### **(6) Risk and Uncertainties**

The Plan invests in various pooled separate accounts and a stable value fund. These investments are exposed to various risks such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such a pandemic or international conflict. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for plan benefits.

### **(7) Plan Termination**

Although it has not expressed any intent to do so, the Company has the right at any time to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.
