### **NOTES TO FINANCIAL STATEMENTS**

**December 31, 2024 and 2023**

#### **NOTE A - PLAN DESCRIPTION**

The following brief description of the Delta Dental of Wisconsin, Inc. Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

Effective January 1, 2024, the Plan's eligibility and vesting provisions were amended as disclosed throughout the financial statements.

#### ***General***

The Plan is a defined contribution plan covering qualified employees of Delta Dental of Wisconsin, Inc. (the Employer or Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The Company's Retirement Plan Committee is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Company's Board of Directors.

#### ***Eligibility***

Prior to January 1, 2024, employees regularly scheduled to work at least 1,000 hours per year were eligible to participate if they had completed three months of service and were 21 years of age. Employees scheduled to work less than 20 hours per week were eligible to participate if they had completed one year of service and were 21 years of age. A year of service for purposes of eligibility was a consecutive 12-month period during which the employee had 1,000 or more hours of service. Employees entered the Plan on the first day of January, April, July, or October, coinciding with or following the date they satisfied the Plan's eligibility requirements. Effective, January 1, 2024, except for excluded employees, any employee who is 18 years of age or older is eligible to enter the Plan on the first day of the month following the date of hire. Following the January 1, 2024 amendment, all prior eligibility requirements were removed.

#### ***Contributions***

Participants can contribute up to 75% of their eligible compensation, as defined by the Plan. Contributions are subject to certain Internal Revenue Code (IRC) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan allows participants to designate contributions as Roth 401(k) contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). The Company contributes a discretionary match each year. For the years ended December 31, 2024 and 2023, if an employee contributed at least \$4,250, the Company contributed a maximum of \$4,250, per participant. The Company is required to make a contribution equal to 6.50% of the participant's eligible compensation as defined by the Plan document. The contributions are made and allocated each payroll period. No other discretionary contributions were made for the years ended December 31, 2024 and 2023.

All newly eligible employees and all active participants without a deferral election are automatically enrolled in the Plan, unless otherwise elected by the participant. Elective contributions are initially established at a pre-tax rate of 6% of eligible compensation and are directed into the Plan's default investment option. Participants may subsequently change these deferral and investment elections at any time.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contribution, the Company's discretionary match and required match, and an allocation of Plan earnings or losses. Participants' accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant's

earnings or losses or account balances, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Investment Options***

Participants direct the investment of all employee and employer contributions plus actual earnings thereon into various investment options offered by the Plan. Participants may change their investment options daily.

***Vesting***

Prior to January 1, 2024 participants were vested immediately in their contributions, plus actual earnings thereon. Participants vested in their Company matching and Company discretionary contributions at 20% for each year of continuous service until becoming fully vested upon completion of five years of continuous service. Effective January 1, 2024, participants continue to vest immediately in their contributions, plus actual earnings thereon, and now also vest immediately in Company matching contributions, plus actual earnings thereon. Participants vest in their Company discretionary contributions at 20% for each year of continuous service until becoming fully vested upon completion of five years of continuous service.

Employees will become fully vested upon termination of employment due to becoming disabled.

***Forfeitures***

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$86,254 and \$86,415, respectively. In 2024 and 2023, employer contributions were reduced by \$99,747 and \$66,021, respectively, from forfeited non-vested accounts.

***Notes Receivable from Participants***

Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, whichever is less. Participants may only have two loans outstanding at any given time. The notes receivable are secured by the balance in the participant's account and bear interest at a rate commensurate by commercial lenders for loans made under similar circumstances determined by the Plan Administrator. The interest rate and the loan term are fixed at the inception of each loan based on the requirements in the Plan agreement, with loan terms not to exceed five years unless the loan is used for the purchase of a primary residence. Principal and interest are paid ratably through monthly payroll deductions.

***Benefit Payments***

Participants may elect to receive either a lump-sum amount equal to the value of their vested interest, or annual installments as defined in the Plan document upon retirement, termination of employment, death, or disability. A terminated employee with a balance of less than \$1,000 may be automatically paid out by the Plan upon termination. Any terminated participants with a balance between \$1,000 to \$5,000 can still be automatically paid out if their balance is rolled into a qualified Individual Retirement Account. Distributions may be made at the participant's election prior to termination upon attainment of age 59 1/2, or hardship, as defined by the Plan document.

***Death Benefits***

The designated beneficiary is entitled to a death benefit distribution equal to the participant's vested account balance.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

***Investment Valuation and Income Recognition***

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Notes receivable from participants outstanding at December 31, 2024 and 2023 bear interest at rates ranging from 3.25% to 8.50% in both 2024 and 2024. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent notes receivable from participants are reclassified as benefit payments based upon the terms of the Plan.

***Payment of Benefits***

Benefits paid to participants are recorded when paid.

***Administrative Expenses***

Plan expenses are paid by either the Plan or the Company, as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. In addition, certain investment related expenses are deducted from net appreciation in fair value of investments presented in the accompanying statements of changes in net assets available for benefits.

***Use of Estimates***

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE C - FAIR VALUE MEASUREMENTS**

There is a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value and their classification in the valuation hierarchy as of December 31, 2024 and 2023.

*Mutual funds* - Valued at the net asset value (NAV) of shares held by the Plan at year end, which is obtained on an active market.

*Collective trust funds* - Valued based on the fair value of the collective trusts' underlying investments. The NAV, as provided by Principal Trust Company (Principal Trust), which is obtained on an active market.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE F - PLAN TERMINATION**

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts and distributions to participants will be made in accordance with the provisions of the Plan.

**NOTE G - TAX STATUS**

The Plan uses a pre-approved Plan document sponsored by Principal Trust, which received an advisory letter from the Internal Revenue Service (IRS) dated September 24, 2015, stating that the pre-approved document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS and has been amended subsequent to the issuance of the advisory letter; however, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

U.S. GAAP require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE H - SUBSEQUENT EVENTS**

The Plan evaluated its December 31, 2024 financial statements for subsequent events through October 13, 2025, the date the financial statements were available to be issued. The Plan is not aware of any subsequent events which would require recognition or disclosure in the financial statements, except as disclosed below.

Effective February 1, 2025, the Plan was amended to add an auto-escalation feature for all participants who were not yet contributing 10% of their eligible compensation. The automatic elective deferral contribution will increase by 1% on April 1<sup>st</sup>, up to a maximum automatic elective deferral contribution of 10%.
