Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Philadelphia Inquirer, PBC 401(k) Retirement Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of The Philadelphia Inquirer, PBC 401(k) Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about The Philadelphia Inquirer, PBC 401(k) Retirement Plan's ability to continue as a going concern within one year after the date that these financial statements are available to be issued.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting in error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Note 1. Description of Plan

The following description of The Philadelphia Inquirer, PBC 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan, established on June 29, 2006, is a single-employer, defined contribution plan covering eligible employees of The Philadelphia Inquirer, PBC (Plan Sponsor or the Company). The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974*, as amended (ERISA).

Eligibility

All nonunion employees and employees under all the Company's collective bargaining agreements (CBAs) (union employees) are eligible to participate in the Plan as of date of hire, regardless of full-time or part-time status.

Contributions

Employees who elect to participate in the Plan may elect to defer an amount up to 80% of their compensation, as defined in the Plan, as pre-tax, Roth, and/or after-tax contributions. Participant pre-tax and Roth contributions are limited to the maximum amount allowable under the Internal Revenue Code of 1986, as amended (IRC). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions up to the maximum amount allowable under the IRC. Participants may also contribute amounts representing eligible rollover distributions from other qualified defined benefit or contribution plans. The Plan has an auto enrollment feature. New employees have a default elective deferral percentage of 5% of compensation, unless they opt out or elect otherwise. Each year, the elective deferral amount will increase by 1% of compensation up to a maximum of 10%.

Company matching contributions are provided to non-union employees and members of certain collective bargaining units. These eligible employees must first complete six months of eligibility service before receiving a matching contribution at a rate of 50% of eligible participant contributions, not in excess of the first 6% of eligible compensation, each payroll period. During 2023 the Plan was amended effective the first payroll period occurring on or after September 1, 2023, to reduce the eligibility period from one year to six months before receiving a matching contribution. Eligible employees who are members of certain other collective bargaining units are allocated a non-elective employer contribution and may receive a supplemental contribution in accordance with the terms of the applicable CBA. These non-elective amounts are generally defined as a fixed amount per shift worked.

Participant Accounts

Participants have the ability to direct the investment of their account balances into any of the various investment options available under the Plan. Upon enrollment, participant account balances are invested in the appropriate target date fund based on the participant's normal retirement age, unless directed otherwise. Participants may change their investment options on a daily basis. Each participant's account is credited with the participant's contributions and related matching, non-elective and supplemental contributions, and allocations of Plan earnings. Participant accounts are charged with respective managed account fees, administrative fees, loan fees, and qualified domestic relation orders ("QDRO") fees, if applicable. Allocations are based on participant earnings, account balances, or a per capita basis, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

All participant contributions and actual earnings thereon are fully vested and non-forfeitable at all times. Company matching contributions are 100% vested after five years based on a graduated schedule as follows:

Non-elective and supplemental employer contributions are 100% vested. Additionally, participants become 100% vested in their account balances at age 65.

Forfeitures

Forfeitures of non-vested accounts are used to restore previously forfeited amounts for re-employed participants, to reduce Company contributions, and may also be used for Plan administrative expenses. During 2024, \$76,711 of forfeitures were used for these purposes. As of December 31, 2024 and 2023, forfeited non-vested amounts available to the Company totaled \$52,318 and \$52,670, respectively.

Notes Receivable from Participants

Participants may borrow up to one-half of their vested account balance subject to a minimum limitation of \$1,000 and a maximum limitation of \$50,000. A participant may have no more than two loans outstanding at any time. The loans are collateralized by the participant's account and bear interest at the prime rate, as reported by Reuters, at the date of loan approval, which remains fixed during the life of the loan. Loans outstanding at December 31, 2024, bear interest at rates ranging from 3.25% to 8.50%. Interest and principal are repaid in equal installments over the life of the loan, ranging from one to five years, through after-tax payroll deductions, unless the loan is used to acquire a participant's principal residence, upon which the life of the loan may be extended to 15 years. Loans may be repaid in full at any time without penalty.

Benefit Payments

Benefit payments are permitted in the event of death, disability, termination of employment, a proven hardship, retirement, or attainment of age 59½ while still employed. Effective January 1, 2023, the Plan was amended to permit benefit payments in the event of a qualified birth or adoption. Additionally, all or part of any after-tax contributions or rollovers can be withdrawn, without penalty. Participants may withdraw rollover contributions at any time. Benefits are paid in either lump sums or partial distributions.

Administrative Expenses

The Plan's administrative expenses are paid by either the Company or the Plan as provided in the Plan Document.

Note 2. Summary of Significant Accounting Policies

This summary of significant accounting policies of the Plan is presented to assist in understanding the Plan's financial statements. The financial statements and notes are representations of the Plan's management who are responsible for their integrity and objectivity. These accounting policies conform to accounting principles generally accepted in the United States of America and have been consistently applied in the preparation of the financial statements.

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of Plan additions and deductions from net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Interest is included in income when earned, based on the terms of the investments and the periods during which the investments are owned. Dividends are recorded on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. The Plan presents, in the statement of changes in net assets available for benefits, the net change in the fair value of its investments which consists of the realized gains or losses and the unrealized appreciation or depreciation on those investments bought and sold as well as held during the year.

The Plan does not maintain any insurance contracts or other investments that are excluded from Plan assets.

Payment of Benefits

Benefit payments are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

Risks and Uncertainties

The Plan provides for investment options in various investment securities that, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 3. Information Certified by the Plan's Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, certain information regarding investments and notes receivable from participants was obtained from or derived from information provided by Vanguard Fiduciary Trust Company (the Trustee) to the plan administrator. The Trustee of the Plan has certified the following information as complete and accurate:

- Investments at fair value and notes receivable from participants included in the statements of net assets available for benefits as of December 31, 2024 and 2023 .
- The supplemental schedule of assets (held at end of year) as of December 31, 2024.
- Investment activity and interest on notes receivable from participants included in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

Note 4. Fair Value Measurements

Financial accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

- Registered investment companies: Shares are valued using quoted market prices in an active market.
- Stable value collective trust fund: Composed of units of an underlying trust which primarily is composed of fully-benefit responsive investment contracts and is valued at the net asset value (NAV) of units of the underlying trust. The fund seeks stability of income by diversifying investments amongst those designed to smooth gains and losses over time with an average maturity of 2-4 years. The NAV is used as a practical expedient to estimate fair value. The practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reporting NAV. Participant transactions (purchases and sales) may occur daily. There are no participant redemption restrictions.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Tax Status

The Internal Revenue Service (IRS) has determined and informed the Company, by letter dated February 7, 2014, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. Although

the Plan has been amended since receiving the determination letter the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan administrator believes that it is no longer subject to income tax examinations for years prior to 2021.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its matching contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 7. Party-in-Interest

The Plan's investments include registered investment companies and a common/collective trust managed by an affiliate of the Trustee of the Plan. Therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for these services amounted to approximately \$119,000 for the year ended December 31, 2024.
