Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of *Hospital Buen Samaritano Retirement Plan* (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) audit. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of *Hospital Buen Samaritano Retirement Plan's* financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, stating that the certified investment information, as described in Note 10 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. 1. DESCRIPTION OF THE PLAN

The following brief description of ***Hospital Buen Samaritano Retirement Plan*** (the Plan), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Hospital Comunitario Buen Samaritano, Inc. (the Company), who have completed six (6) months of continuous service and have reached the minimum age of twenty-one (21) years. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions and allocations

Each year, participants may contribute pretax annual compensation, as defined in the Plan, not to exceed \$15,000. Participants may also contribute amounts representing distributions from other qualified plans. The Company shall make matching contributions equal to twenty five cents (25¢) for each dollar (\$1.00) of participant's matchable contributions without exceeding 3% of the participants compensation. The Company may also make profit sharing contributions to the Plan in such amount as it may determine (if any). Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant accounts

Each participant's account is credited with the participant's contribution and an allocations of (a) the Company's contribution and, (b) Plan earnings (loss), and charged with an allocation of administrative expenses. Allocations are based on participant's earnings, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. As of December 31, 2024 and 2023 there were 263 and 314 respectively, participants with account balances in the Plan.

Vesting

Participants' pre-tax and after-tax contributions and earnings thereon are always 100% vested. Participants are 100% vested as to profit sharing, matching contributions and earnings thereon after completing three (3) years of service.

Participant Withdrawals and Payment of Plan benefits

Participants may withdraw funds from their accounts if the Trustee determines that a withdrawal is necessary to avoid certain financial hardships, as permitted under the Code, or death, disability or for any reason after reaching age 59 1/2. Distribution of Plan benefits begins when the earliest of the following have occurred: (1) within 60 days of the close of the Plan year in which the participant attains age 55 or (2) the participant terminates service with the Company. Participants may also elect to make withdrawals at age 59 1/2 without tax penalty. Plan benefits are distributed in the form of either a series of payments or a lump-sum payment as elected by the participant.

Forfeited accounts

Forfeited accounts during years ended December 31, 2024 and 2023 amounted \$1,514 and \$-, respectively. Forfeited accounts will be used to reduce Matching Contributions and/or Profit Sharing Contributions, be reallocated as additional Profit Sharing distributions or applied to reduce the Plan's administrative expenses.

Plan expenses and administration

Expenses attributable to investments earmarked to a participant's account and fees associated with specific participant transactions, including loan application fees, are charged to that account to the extent specified by the Plan Administrator. The Company is responsible for the general administration of the Plan and for carrying out the provisions thereof. Certain administrative functions are performed by officers or employees of the Company. No such officers or employees receive compensation from the Plan.

Change in Plan Custodian and Recordkeeper

Effective on July 17, 2024, Voya Retirement and Annuity Company ("Voya") was replaced by Empower Retirement, LLC ("Empower") as the custodian and recordkeeper for the Plan. As part of the transition, all Plan assets held in custody with Voya were transferred to Empower in accordance with the Plan's governing documents and applicable regulatory requirements. There was no impact to participants' account balances or the overall financial position of the Plan as a result of this change.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure contingent assets and liabilities. Actual results could differ from those estimates.

Investments valuation and income recognition

The Plan's investments are reported at fair value with the exception of fully benefit-responsive investment contracts. Fair value is the price that would be received to sell an asset or paid to transfer liability in an orderly transaction between market participants at the measurement date.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED

Investments valuation and income recognition - continued

Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts. The contract value is the relevant measurement since it represents the amount that the participant would receive if they were to initiate permitted withdrawal transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Benefit payments

Benefits are recorded upon distributions.

3. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent (100%) vested in their accounts and benefits will be payable strictly under the terms of the Plan.

4. TAX STATUS

Effective on January 1, 2012, the Plan is amended to comply with the provisions of the Puerto Rico Internal Revenue Code of 2011, Sections 1081.01 (a) and (d), as amended ("PR-Code") and the Internal Revenue Circular Letter No. 11-10 of December 16, 2011. Such amendments will not affect in any way the ruling issued on behalf of the aforesaid plan on March 20, 2006, in where the Department determined and informed that the Plan is exempt from local income taxes under Puerto Rico Internal Revenue Code of 1994. The Plan is being operated in compliance with the applicable requirements of ERISA and the PR-Code.

5. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements*, provides a framework for measuring fair value. This framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB Accounting Standards Codification Topic of *Fair Value Measurements* are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2 Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and
- Level 3 Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

Following is a description of the valuation methodologies used for assets measured at fair value:

Money market: Is valued based on the amortized cost valuation method which approximates fair value.

Mutual funds: Valued at the net asset (NAV) of shares held by the plan at the year end.

Fixed Annuities: The reported values for fixed annuity options are reported daily based on the valuation method disclosed in the annuity contract, as calculated by the annuity provider.

8. RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

9. INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN

The Plan administrator has elected to have the audit of Hospital Buen Samaritano Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under this election, the Plan administrator instructed the Plan's independent auditor not to perform any auditing procedures with respect to the information certified by Empower Retirement, LLC, except for comparing such information to that included in the Plan's financial statements and supplemental Schedule H, line 4i – Schedule of Assets (Held at End of Year). The certified information includes investments and their corresponding fair values, investment income including net appreciation (depreciation) in fair value of investments, number of shares, and investment transactions.

10. PROHIBITED TRANSACTIONS

During the years ended December 31, 2024 and 2023, certain participants' contributions in the amount of \$13,407 and \$39,775, respectively, were not remitted to the Plan's custodian within the period prescribed by the Department of Labor Regulations. Delays in remitting contributions to the custodian were due to unintentional administrative errors.

11. RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

The financial statements of the *Hospital Buen Samaritano Retirement Plan* are prepared in accordance with accounting principles generally accepted in the United States of America (GAAP), which differ in certain respects from the form and content required by the Department of Labor (DOL) for Form 5500 reporting purposes.

12. SUBSEQUENT EVENTS

The Plan administrator evaluated subsequent events through October 9, 2025, which is the date the financial statements were available to be issued. No events have occurred subsequent to the Statements of Net Assets Available for Benefits date and to the date financial statements were available to be issued, that would require additional adjustment to, or disclosure in, the financial statements.
