Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Qualico Steel Company, Inc. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Note 1 - Plan Description

The following description of the Qualico Steel Company, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Qualico Steel Company, Inc. (the Sponsor) is the Plan Sponsor. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering all full-time employees of the Sponsor and its affiliate, Webb Aviation, who have one year of service and are age 18 or older. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

Employer contributions - For the years ending December 31, 2024 and 2023, the Plan was stated to be a Safe Harbor Plan. The Sponsor makes a matching contribution equal to 100% of the participant's elective deferrals less than or equal to 3% of the participant's compensation and 50% of the participants elective deferrals that exceed 3% but that are less than are equal to 5% of the participant's compensation. In addition, a profit sharing contribution is available to those who were employed on the last day of the year. The profit sharing contribution was \$500,000 for the years ending December 31, 2024 and 2023.

Participant contributions - Participants are automatically enrolled at an automatic elective deferral percentage of 3%. Participants who have attained the age of 50 before the end of the Plan year are eligible for catch-up contributions. Participants may also make Roth contributions to the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant accounts - Each participant's account is credited with the participant's contributions and an allocation of (a) the Sponsor's contributions, (b) Plan earnings (losses), and (c) forfeitures of terminated participant's nonvested accounts and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the remainder of their account is based on years of continuous service. Participants are 100% vested after six years of credited service.

Notes receivable from participants - A participant may borrow from their accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, with a minimum loan amount of \$1,000. The interest rate is based on 1% plus the prime interest rate and is fixed over the life of the note. The interest rate on outstanding loans ranged from 4.25% to 9.50% at December 31, 2024 and 2023. A participant may have two loans outstanding at any given time. Outstanding loans are collateralized by the participant's account.

Notes receivable from participants are issued directly from a participant's account. Repayments on the notes are made through payroll deduction. Generally, participants must repay loans within five years, unless the loan is used to purchase a primary residence. At December 31, 2024 and 2023, there were \$848,991 and \$639,695 in outstanding notes receivable from participants, respectively.

Payment of benefits - Upon discontinuance of service due to termination of employment, normal retirement (age 65), required minimum distributions, rollover contributions, or qualified reservist distribution. Cashout level for terminated participants is \$5,000. Terminated participants with account balances of \$1,000 or less will be involuntary cashed out. Balances between \$1,000 and \$5,000 are rolled over into an IRA established retirement account established on behalf of the employee. The normal form of payment of benefits is a lump sum; however, non-recurring partial payments are allowed. The Plan does not allow for hardship distributions.

Forfeited accounts - Forfeitures are to be applied to pay Plan administrative expenses. Any remaining forfeitures are to be allocated to participants in a manner in accordance with the adoption agreement. At December 31, 2024, and 2023 there were \$21,289 and \$21,432 in forfeited nonvested accounts respectively. For the year ended December 31, 2024 and 2023, \$21,862 and \$0, respectively, were used to pay Plan administrative expenses.

Note 2 - Summary of Significant Accounting Policies

Basis of accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates that affect the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment valuation and income recognition - The Plan's Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the loan is reclassified as a benefit payment to the participant when a distributable event, as defined in the Plan document, occurs.

Payment of benefits - Benefits are recorded when paid.

Administrative expenses - Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Fees for the administration of notes receivable from participants are included in administrative fees and charged directly the participants account. Investment related expenses are included in the net appreciation (depreciation) of fair value on investments.

Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2: Inputs other than quoted prices included with Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Money market funds and mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 5 - Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

Note 6 - Tax Status

The Plan adopted a nonstandardized form of a pre-approved plan sponsored by Ascensus. The pre-approved plan has received an opinion letter from the IRS dated June 30, 2020, as to the pre-approved plan's qualified status. The pre-approved plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8 - Related Party Transactions

Administrative fees paid by the Plan to the Trustee, amounted to \$35,566 and \$8,920 for the years ended December 31, 2024 and 2023. Fees paid by the Plan for investment services are included in net appreciation (depreciation) in fair value of investments. These transactions qualify as party-in-interest. The Plan Sponsor pays directly any other fees related to the Plan's operations.

Note 9 - Subsequent Events

The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued. All subsequent events requiring recognition as of December 31, 2024, have been incorporated in these financial statements.
