***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Alabama Grocers Association 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (an ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

***Opinion***

***Basis for Opinion***

## Notes to Financial Statements

December 31, 2024

### **1. Description of the Plan**

The following description of Alabama Grocers Association 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

#### **General**

The Plan is a multiple employer plan sponsored by Alabama Grocers Association (the Sponsor) as a defined contribution plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Employees eligible to participate in the Plan (collectively, the Employers) are those employees of Gregerson's Foods, Inc., Hometown Grocery - Athens, GEL Enterprises, LLC, Gateway Foods, Inc., Eagle Foods, Inc., B&W Foods, Inc., Baker Foods, Inc., Big Bear of Luverne, Inc., Meat Depot Roebuck, Meat Depot Sylacauga, Meat Depot Northport, Fresh Value Athens who have completed one year of service, are at least 21 years of age and are not leased employees, union employees, non-resident aliens, or independent contractors, as well as employees of A&R Super Markets, Inc., Food Outlet, Calera Food Outlet, Savmor Associated Foods, and Tarrant Food Outlet who have completed 90 days of service, are at least 21 years of age and are not leased employees, union employees, non-resident aliens, or independent contractors. In 2024, Fresh Value West Point, LLC, Fresh Value Somerville, LLC and Fresh Value, Inc. (with 10 stores as part of a controlled group of employers as defined in the joinder agreement) were added as participating employers. Assets related to Fresh Value, Inc. were transferred from Fourth Avenue Supermarket, Inc. 401(k) Plan to this Plan on October 8, 2024. Employees of these locations were immediately eligible to participate in this Plan.

#### **Contributions**

Contributions to the Plan include (i) salary reduction contributions authorized by participants, (ii) safe harbor matching contributions made by the Employers, (iii) discretionary nonelective contributions made by the Employers, and (iv) rollovers from new participants in another qualified plan. Participants should refer to the Plan document for a complete description of the Employers' contributions to the Plan. Participants may direct the investment of their contributions and any Employers' contributions into various investment options offered by the Plan.

## Alabama Grocers Association 401(k) Plan

### Notes to Financial Statements (continued)

#### **1. Description of the Plan (continued)**

##### **Contributions (continued)**

Each year, participants may contribute up to 100 percent of eligible annual compensation (as defined in the Plan document) as pretax and/or Roth contributions not to exceed federal limits. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

##### **Participant Accounts**

Each participant's account is credited with the participant's contribution, the Employers' safe harbor matching contribution, Plan earnings or losses from that account's activities, and an allocation of the Employers' discretionary nonelective contributions. Allocations are based on participant compensation, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### **Benefit Payments**

On termination of service due to separation, death, disability, or retirement at attainment of age 59 ½, a participant may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, installment payments over a specified time period for required minimum distributions only, or partial withdrawals or annuity (certain participating employers only as defined in the joinder agreements). Hardship and in-service withdrawals may be available as defined in the Plan document.

##### **Participant Loans**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates. Principal and interest are paid ratably through payroll deductions. Participant loans are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

### Notes to Financial Statements (continued)

#### **1. Description of the Plan (continued)**

##### **Forfeitures**

Forfeitures of terminated nonvested participant accounts may be used to pay administrative expenses of the Plan or used to reduce future Employers' contributions.

##### **Administrative Expenses**

Certain administrative expenses of the Plan, including accounting fees, have been paid by the Sponsor. Participant initiated distribution and loan fees are charged directly to the participant's account. All other administrative expenses, including recordkeeping, investment advisory fees and investment transaction fees (including investment-related expenses which are included in net appreciation in fair value of investments) are paid by the Plan.

##### **Vesting**

Participants are immediately vested in their voluntary contributions and safe harbor matching contributions plus actual earnings thereon. Vesting in all other Employers' contribution portions of their accounts plus earnings thereon is based on years of continuous service. A participant is 100 percent vested after six years of credited service.

##### **Plan Termination**

Although it has not expressed any intent to do so, the Employers have the right under the Plan to discontinue contributions and participation in the Plan at any time and the Sponsor may terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100 percent vested in discretionary nonelective Employers' contributions.

#### **2. Summary of Significant Accounting Policies**

##### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management of the Sponsor to make estimates that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **2. Summary of Significant Accounting Policies (continued)**

##### **Investment Valuation and Income Recognition**

Investments are reported at fair value, except for the fully benefit-responsive investment contract which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. Management of the Sponsor determines the Plan's valuation policies utilizing information provided by the investment advisor and custodian. See Notes 4 and 5 for discussion of fair and contract value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan provides for investments in various investment securities that in general are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

##### **Basis of Presentation**

The financial statements of the Plan have been prepared on the accrual basis of accounting.

#### **3. Investment Information**

All information related to investments and participant loans disclosed in the accompanying financial statements and supplemental schedules, including investments held and participant loans receivable at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest for the year ended December 31, 2024, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by Transamerica Financial Life Insurance Company, Inc., the custodian.

### Notes to Financial Statements (continued)

#### 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2      Inputs to the valuation methodology include:  
Quoted prices for similar assets or liabilities in active markets;  
Quoted prices for identical or similar assets or liabilities in inactive markets;  
Inputs other than quoted prices that are observable for the asset or liability;  
Inputs that are derived principally from or corroborated by observable market data by correlation or other means.  
If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: fair value is based on prices quoted and published by the investment advisor of the accounts. Quoted prices are determined daily based on the market value of the underlying mutual funds and other securities in the accounts which are deemed to be actively traded. Net change in fair value of the accounts includes interest, dividends and realized and unrealized gains and losses on investments in the accounts.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 5. Fully Benefit-Responsive Investment Contract

The Plan invests in the Transamerica Stable Value Core Option. This guaranteed investment contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer and has no minimum or maximum interest rate. The crediting rate is reviewed on a semi-annual basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

#### **5. Fully Benefit-Responsive Investment Contract (continued)**

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Examples of such events include the Plan's failure to qualify under Section 401(a) of the Internal Revenue Code (IRC) or the failure of the trust to be tax-exempt under Section 501(a) of the IRC; premature termination of the contract; Plan termination or merger; changes to the Plan's prohibition on competing investment options; or bankruptcy of the Sponsor or other Sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include an uncured violation of the Plan's investment guidelines; a breach of material obligation under the contract; a material misrepresentation; or a material amendment to the agreements without the consent of the issuer.

#### **6. Tax Status**

The Sponsor adopted a non-standardized pre-approved profit-sharing plan with a cash or deferral arrangement, which received a favorable opinion letter from the Internal Revenue Service on June 1, 2021, which stated that the Plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Sponsor believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax.

#### **7. Subsequent Events**

Management of the Sponsor evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through October 13, 2025 which is the date the financial statements were available to be issued.
