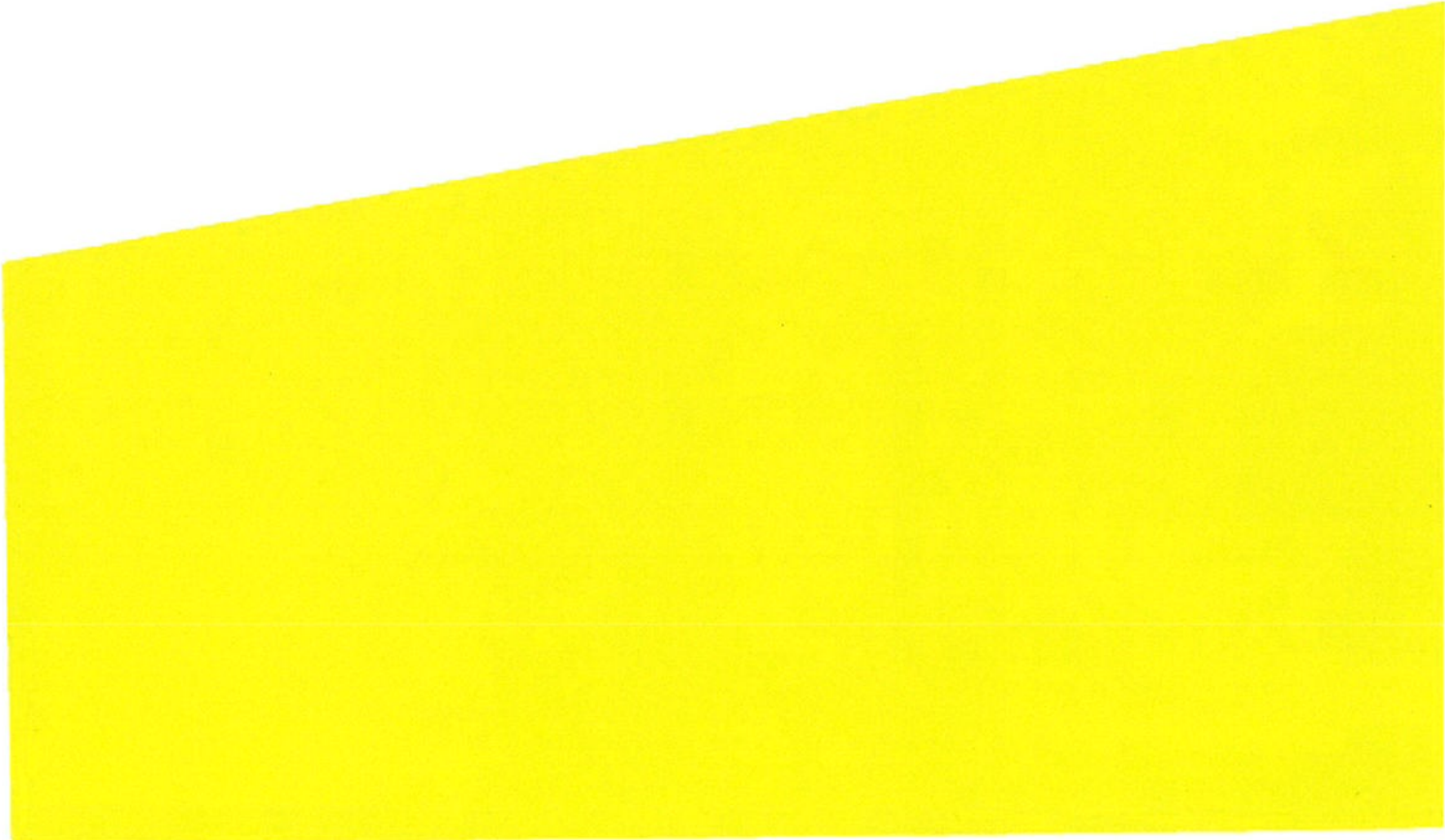

1. Description of the Plan

The following description of the City Hill Company (Guam), Ltd. 401(k) Profit Sharing Plan (the Plan) provides general information about the Plan's provisions. City Hill Company (Guam), Ltd. (the Company) is the plan sponsor. Participants should refer to the plan description for a more complete description of the Plan's provisions, copies of which may be obtained from the plan sponsor.

General

The Plan, which was initially effective July 1, 1990, is a voluntary defined contribution plan covering all employees of the Company who have completed three months of service and have attained age 18. The Plan does not cover employees included in a collective bargaining unit, temporary employees, and nonresident alien employees who receive no earned income from the Company that constitutes income from sources within the United States. ASC Trust, LLC (ASC) is the trustee and recordkeeper for the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Contributions

Each year, participants may elect to contribute a percentage of their pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions. The Company may contribute discretionary matching contributions equal to a percentage of the participant's contributions as determined by the board of directors on an annual basis. The board of directors also has the option to contribute additional amounts. No such amounts were contributed for 2024 and 2023. All contributions are subject to certain limitations of the Internal Revenue Code (the Code).

Participants may direct the investment of their contributions among one or more of the several options offered under the Plan and may elect to change the amount of their contributions or to transfer all or part of their individual plan account balances among such options, subject in each case to applicable conditions and limitations established under the Plan. The Company's contributions are invested in the same manner as that of the participant's elective contributions.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's matching contributions and allocations of plan earnings and is charged with an allocation of administrative expenses. Plan earnings are allocated based on the participant's share of net earnings or losses of their respective elected investments options. Allocations of administrative expenses are based on the participant's account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. Description of the Plan, continued

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Forfeitures

Upon termination of employment, participants forfeit their nonvested balances. If a participant is rehired within a five-year period, the forfeited contributions are reinstated. Forfeited balances of terminated participant's nonvested accounts are used to pay administrative expenses of the Plan or supplement future Company discretionary matching and profit-sharing contributions. As of December 31, 2024 and 2023, unallocated forfeitures totaled to \$1,209 and \$62, respectively, and forfeitures used to reduce Company contributions for 2024 were \$62.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Contributions

Participant contributions and the matching employer contributions are recorded in the year in which the participant contributions are withheld from compensation.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced, and a benefit payment is recorded.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates that affect the

4. Fair Value Measurements, continued

Following is a description of the valuation techniques and inputs used for each general type of assets measured at fair value by the Plan:

Mutual funds and Money Market funds: These investments held by the Plan at year end are valued at quoted prices in an active market and are classified within level 1 of the valuation hierarchy.

Common/Collective Trust Funds: The common/collective trust fund investments are valued at their fair value that is readily determinable, published and is the basis for current transactions. These funds are classified within level 1 of the valuation hierarchy.
