### Report on the Audit of the Financial Statements

#### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the accompanying financial statements of IWCO Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of IWCO Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

***Basis for Opinion***

**NOTE 1 DESCRIPTION OF PLAN**

The following description of the IWCO Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan sponsored by Instant Web, LLC (formerly Instant Web Companies, Inc.) (dba: IWCO Direct) (the Company). Employees become eligible to make elective deferral contributions to the Plan upon attaining age 18 and completion of one month of service. Employees enter the Plan on the first day of the month following the attainment of the eligibility requirements. The Plan excludes employees covered by a collective-bargaining agreement, leased employees, interns, and nonresident aliens. The Plan is subject to ERISA, as amended.

**Contributions**

The Plan includes a 401(k) cash or deferred arrangement. Under this arrangement and subject to Plan provisions, employee-participants may elect to contribute up to a certain percentage of their eligible compensation to the Plan. New participants are automatically enrolled at 3% of eligible compensation unless otherwise elected by the participant. Automatically enrolled participants will have their deferral rate increased by 1% each year up to a maximum rate of 6%.

The Employer made a matching contribution of 50% of the first 6% for the years ended December 31, 2024 and 2023. Company matching contributions for the years ended December 31, 2024 and 2023 were \$1,901,098 and \$1,948,178, respectively.

Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans or conduit IRAs. Participants direct the investment of contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a collective trust fund as investment options for participants. Contributions are subject to certain limitations.

**Participant Accounts and Benefit Payments**

Each participant's account is credited with the participant's contribution and allocation of (1) the Company's contribution and (2) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. On termination of service, including death, disability, financial hardship, or retirement (59½), a participant may elect to receive a lump-sum amount equal to the value of his or her vested account.

**Participant Accounts and Benefit Payments (Continued)**

If the participant's vested account balance is less than \$1,000, the vested account balance may be distributed without the participants consent. Prior to 2024, participants with an account balance greater than \$1,000 but less than \$5,000 will receive a lump-sum distribution that is automatically rolled into an IRA for the benefit of the former participant. Effective in 2024, participants with an account balance greater than \$1,000 but less than \$7,000 will receive a lump-sum distribution that is automatically rolled into an IRA for the benefit of the former participant.

**Vesting**

Participants are immediately vested in their own contributions, rollovers, any Company matching contributions, and any discretionary nonelective contributions, plus actual earnings thereon.

**Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Note receivable transactions are treated as a transfer to (from) the investment fund from (to) the note receivable. Note terms range from 1 to 5 years or up to 10 years for the purchase of a primary residence. The notes are secured by the balance in the participant's account and bear interest at a rate of prime plus 1%. Principal and interest is paid ratably through monthly payroll deductions.

**Forfeited Accounts**

Forfeited nonvested accounts are first used to reduce administrative expenses and then are used to reduce future Employer contributions. Forfeitures used to reduce the Employer match for the years ended December 31, 2024 and 2023 were \$-0- and \$-0-, respectively. Forfeitures used to pay fees for the years ended December 31, 2024 and 2023 were \$19 and \$120 respectively. Forfeited nonvested accounts totaled \$2,341 and \$901 as of December 31, 2024 and 2023, respectively.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities, and changes therein; disclosure of contingent assets and liabilities at the date of the financial statements, and changes therein. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are valued at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Dividends are recorded on the ex-dividend date.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan document.

**Administrative Expenses**

The Company pays certain administrative expenses on behalf of the Plan.

**Benefit Payments**

Benefit payments are recorded when paid.

**Subsequent Events**

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through July 31, 2025, the date the financial statements were available to be issued.

**NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION**

Fidelity Management Trust Company, the trustee of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of notes receivable from participants and all investment information reflected in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statements of changes in net assets available for benefits for the years then ended, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 4 FAIR VALUE OF INVESTMENTS**

The Plan categorizes its assets and liabilities measured at fair value into a three-level hierarchy based on the priority of the inputs to the valuation technique used to determine fair value. The fair value hierarchy gives the highest priority to quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). If the inputs used in the determination of the fair value measurement fall with different levels of the hierarchy, the categorization is based on the lowest level input that is significant to the fair value measurement. Assets and liabilities valued at fair value are categorized based on the inputs to the valuation techniques as follows:

*Level 1* – Investment in stocks and bonds are valued based on closing price in an active market in which the stock or bond is traded.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

*Mutual Funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective Trust Fund* – Valued at the NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

**NOTE 5 PARTY-IN-INTEREST**

Transactions related to funds managed by Fidelity Management Trust Company, the trustee, qualify as exempt party-in-interest transactions. Fees in the amount of \$114,325 and \$134,429 were paid to Fidelity Management Trust Company for the years ended December 31, 2024 and 2023, respectively.

**NOTE 6 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the Company will direct the trustee with respect to the distribution of accounts. Liquidation of assets and payment of benefits will be made provided that the Plan is in compliance with the applicable Plan termination requirements of ERISA and the Internal Revenue Code (IRC).

**NOTE 7 PLAN TAX STATUS**

The Plan administrator adopted Fidelity Basic Plan Document No. 17. The Internal Revenue Service (IRS) has issued an opinion letter dated June 30, 2020, stating the language and elections included in this document is acceptable. The Plan administrator has not filed for a determination letter with the IRS. The Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 RISKS AND UNCERTAINTIES**

The Plan provides for investment in a variety of investment funds. In general, investments are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### Report on the Audit of the Financial Statements

#### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the accompanying financial statements of IWCO Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of IWCO Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

**NOTE 1 DESCRIPTION OF PLAN**

The following description of the IWCO Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan sponsored by Instant Web, LLC (formerly Instant Web Companies, Inc.) (dba: IWCO Direct) (the Company). Employees become eligible to make elective deferral contributions to the Plan upon attaining age 18 and completion of one month of service. Employees enter the Plan on the first day of the month following the attainment of the eligibility requirements. The Plan excludes employees covered by a collective-bargaining agreement, leased employees, interns, and nonresident aliens. The Plan is subject to ERISA, as amended.

**Contributions**

The Plan includes a 401(k) cash or deferred arrangement. Under this arrangement and subject to Plan provisions, employee-participants may elect to contribute up to a certain percentage of their eligible compensation to the Plan. New participants are automatically enrolled at 3% of eligible compensation unless otherwise elected by the participant. Automatically enrolled participants will have their deferral rate increased by 1% each year up to a maximum rate of 6%.

The Employer made a matching contribution of 50% of the first 6% for the years ended December 31, 2024 and 2023. Company matching contributions for the years ended December 31, 2024 and 2023 were \$1,901,098 and \$1,948,178, respectively.

Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans or conduit IRAs. Participants direct the investment of contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a collective trust fund as investment options for participants. Contributions are subject to certain limitations.

**Participant Accounts and Benefit Payments**

Each participant's account is credited with the participant's contribution and allocation of (1) the Company's contribution and (2) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. On termination of service, including death, disability, financial hardship, or retirement (59½), a participant may elect to receive a lump-sum amount equal to the value of his or her vested account.

**Participant Accounts and Benefit Payments (Continued)**

If the participant's vested account balance is less than \$1,000, the vested account balance may be distributed without the participants consent. Prior to 2024, participants with an account balance greater than \$1,000 but less than \$5,000 will receive a lump-sum distribution that is automatically rolled into an IRA for the benefit of the former participant. Effective in 2024, participants with an account balance greater than \$1,000 but less than \$7,000 will receive a lump-sum distribution that is automatically rolled into an IRA for the benefit of the former participant.

**Vesting**

Participants are immediately vested in their own contributions, rollovers, any Company matching contributions, and any discretionary nonelective contributions, plus actual earnings thereon.

**Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Note receivable transactions are treated as a transfer to (from) the investment fund from (to) the note receivable. Note terms range from 1 to 5 years or up to 10 years for the purchase of a primary residence. The notes are secured by the balance in the participant's account and bear interest at a rate of prime plus 1%. Principal and interest is paid ratably through monthly payroll deductions.

**Forfeited Accounts**

Forfeited nonvested accounts are first used to reduce administrative expenses and then are used to reduce future Employer contributions. Forfeitures used to reduce the Employer match for the years ended December 31, 2024 and 2023 were \$-0- and \$-0-, respectively. Forfeitures used to pay fees for the years ended December 31, 2024 and 2023 were \$19 and \$120 respectively. Forfeited nonvested accounts totaled \$2,341 and \$901 as of December 31, 2024 and 2023, respectively.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities, and changes therein; disclosure of contingent assets and liabilities at the date of the financial statements, and changes therein. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are valued at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Dividends are recorded on the ex-dividend date.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan document.

**Administrative Expenses**

The Company pays certain administrative expenses on behalf of the Plan.

**Benefit Payments**

Benefit payments are recorded when paid.

**Subsequent Events**

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through July 31, 2025, the date the financial statements were available to be issued.

**NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION**

Fidelity Management Trust Company, the trustee of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of notes receivable from participants and all investment information reflected in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statements of changes in net assets available for benefits for the years then ended, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 4 FAIR VALUE OF INVESTMENTS**

The Plan categorizes its assets and liabilities measured at fair value into a three-level hierarchy based on the priority of the inputs to the valuation technique used to determine fair value. The fair value hierarchy gives the highest priority to quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). If the inputs used in the determination of the fair value measurement fall with different levels of the hierarchy, the categorization is based on the lowest level input that is significant to the fair value measurement. Assets and liabilities valued at fair value are categorized based on the inputs to the valuation techniques as follows:

*Level 1* – Investment in stocks and bonds are valued based on closing price in an active market in which the stock or bond is traded.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

*Mutual Funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective Trust Fund* – Valued at the NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Liquidation of assets and payment of benefits will be made provided that the Plan is in compliance with the applicable Plan termination requirements of ERISA and the Internal Revenue Code (IRC).

**NOTE 7 PLAN TAX STATUS**

The Plan administrator adopted Fidelity Basic Plan Document No. 17. The Internal Revenue Service (IRS) has issued an opinion letter dated June 30, 2020, stating the language and elections included in this document is acceptable. The Plan administrator has not filed for a determination letter with the IRS. The Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 RISKS AND UNCERTAINTIES**

The Plan provides for investment in a variety of investment funds. In general, investments are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
