### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Spire Health and Wellness Benefit Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of benefit obligations and net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in benefit obligations and net assets available for benefits for the years then ended, and the related notes to the financial statements.

### **Notes to Financial Statements**

#### **1. DESCRIPTION OF THE PLAN**

Spire Missouri established a Wrap Plan Document entitled the Spire Health and Wellness Benefit Plan (“the Plan”) covering eligible employees and retirees. The Wrap Plan Document includes the following health and welfare benefit programs:

Severance Program

The Plan was amended and restated on January 1, 2023. The primary change was the transition of two sub-populations of retirees and their dependents, one from Spire Alabama and one from Spire Missouri, who had their benefits transitioned to Health Retirement Accounts. The populations of affected retirees were those retirees who had grandfathered benefits beyond age 65. There was a total of 1,479 participants who were eligible for this benefit change. Of this population, 708 participants enrolled. Additionally, there were other program enhancements to the health benefits for active employees for those who chose to participate. The Plan was previously amended and restated on October 1, 2017, at which time the assets and obligations of the Spire Alabama Retiree Benefit Plan (formerly the Alabama Gas Corporation Retiree Welfare Plan) were merged into the Plan. Also included in the amendment and restatement was a change of Plan sponsor to Spire Services Inc. (“Company”), and the renaming of the Plan to the Spire Health and Wellness Benefit Plan. On September 30, 2019, The Spire Gulf Inc. Retirees’ Group Insurance Plan was incorporated into the Plan and its assets and obligations were merged into the Plan. Spire Inc. (“Spire”), Spire Missouri Inc. (“Spire Missouri”), Spire Alabama Inc. (“Spire Alabama”) and Spire Gulf Inc. (“Spire Gulf”), are referred to as “Employer” or collectively, “Spire and its affiliates”.

On December 16, 2024, the plan was amended to expand the definition of “Welfare Benefit Program” to codify new benefit offerings to active employees. This amendment was effective January 1, 2025, and primarily impacted pay-as-you go benefits for active employees.

Spire Missouri has established three related trusts, the Employee Benefit Trust for Retirees of Spire Missouri Inc. Not Covered by a Collective Bargaining Agreement (formerly the Laclede Gas Company Benefit Plan Trust / Voluntary Employees’ Beneficiary Association (“VEBA”) for Certain Non-Union Employees), Employee Benefit Trust for Retirees of Spire Missouri Inc. Covered by a Collective Bargaining Agreement (formerly the Laclede Gas Company Benefit Plan Trust / VEBA for Contract (Union) Employees), (collectively referred to as the “Missouri

East Trusts”), and a trust for Spire Missouri West (formerly Missouri Gas Energy), that consists of two sub-accounts: the Employee Benefit Trust for Retirees of Spire Missouri West Division of Spire Missouri Inc. Not Covered by a Collective Bargaining Agreement (formerly the Employee Benefit Trust for Retirees of Missouri Gas Energy Division of Laclede Gas Company not Covered by a Collective Bargaining Agreement), and the Employee Benefit Trust for Retirees of Spire Missouri West Division of Spire Missouri Inc. Covered by a Collective Bargaining Agreement (formerly the Employee Benefit Trust for Retirees of Missouri Gas Energy Division of Laclede Gas Company Covered by a Collective Bargaining Agreement) (collectively referred to as the “Missouri West Trust”).

Spire Alabama has established the Retired Hourly Employee Benefit Plans Trust (“Hourly Trust Fund”) to segregate the contributions and the investment activity relating to hourly retirees that participate in Employer-sponsored defined benefit health and welfare plans. Spire Alabama has also established the Retired Salaried Employee Benefit Plans Trust (“Salaried Trust Fund”) to segregate the contributions and the investment activity relating to salaried retirees that participate in Employer-sponsored defined benefit health and welfare plans. Spire Alabama established the Retired Salaried Group Life Insurance Plan Trust (“Group Life Trust Fund”) to segregate the contributions and the investment activity relating to salaried retirees that participated in the Employer-sponsored group life insurance plan. These trusts are collectively referred to as the “Alabama Trusts”.

Spire Gulf has established the Spire EnergySouth Inc. Benefit Trust for Retirees Covered by a Collective Bargaining Agreement (formerly the Mobile Gas Service Corporation Union Benefit Trust) (“Gulf Hourly Trust Fund”) to segregate the contributions and the investment activity relating to hourly retirees that participate in Employer-sponsored defined benefit health and welfare plans. Spire Gulf has also established the Spire EnergySouth Inc. Benefit Trust for Retirees Not Covered by a Collective Bargaining Agreement (formerly the Mobile Gas Service Corporation Non-Union Benefit Trust) (“Gulf Salaried Trust Fund”) to segregate the contributions and the investment activity relating to salaried retirees that participate in Employer-sponsored defined benefit health and welfare plans. These trusts are collectively referred to as the “Spire Gulf Trusts”.

The Missouri East Trusts, the Missouri West Trust, the Alabama Trusts, and the Spire Gulf Trusts are collectively referred to as the “Trusts”.

The following description pertains to the Plan as in effect during the years ended December 31, 2024 and December 31, 2023 and is provided for informational purposes only. If any discrepancy between this summary and the Plan document arises, the terms of the Plan document will govern.

**General** – Spire Services Inc. is the Plan Administrator. The Plan Administrator has the power and duty to interpret the Plan to determine persons entitled to benefits, the amount of benefits payable and whether claims are covered by the Plan or are excluded from coverage.

Various health and welfare benefits are provided by Spire and its affiliates for eligible employees and their eligible dependents. Medical and life benefits are provided by Spire Missouri, Spire Alabama and Spire Gulf for eligible retirees and/or their eligible dependents. All payments for the Plan require approval of the Plan Administrator.

Medical benefits are offered through a Preferred Provider Organization (“PPO”) Plan, which provides benefits on a PPO in-network and out-of-network basis.

The trustee for the Missouri East Trusts, the Missouri West Trust, and the Spire Gulf Trusts is U.S. Bank, N. A. (“Missouri /Gulf Trustee”). The trustee for the Alabama Trusts is Russell Trust Company (“Alabama Trustee”). The Missouri /Gulf Trustee and the Alabama Trustee are collectively referred to as “Trustees”.

For Spire and its affiliates, vision and dental benefits are offered to eligible active union and non-union employees and their dependents. The Employee Assistance Plan, Healthcare Reimbursements and Voluntary Accidental Death and Dismemberment are offered to eligible active union and non-union employees. Termination and

dismissal pay are offered to eligible active union employees. Voluntary Group Accident Insurance and Business Travel Accident are offered to eligible active non-union employees. Special Life Insurance is offered to certain eligible active and retiree non-union employees.

**Coverage for Eligible Employees and/or their Eligible Dependents: Spire and Affiliates** – In accordance with the terms of the Plan, benefit payments and administrative expenses for Spire and its affiliates eligible employees and their eligible dependents are paid by Spire and its affiliates on a pay-as-you-go basis; eligible active employees and their eligible dependents do not make contributions to the Plan, except for benefits provided as required under the Consolidated Omnibus Budget Reconciliation Act (“COBRA” benefits) and the Pretax Premium Plan. The Salary Continuance and Voluntary Group Accident programs are fully contributory plans for active non-union employees. Funding is not required when the pay-as-you-go method is used for a welfare plan. Benefit payments, administrative expenses, and premiums for fully insured programs for eligible employees and their eligible dependents are paid by Spire Missouri out of corporate general assets, not from Plan assets.

Medical benefits are self-insured up to a specified dollar amount, after which they become fully-insured by a third-party to limit Spire and its affiliates’ liability. The Medical Benefits are administered by Anthem Blue Cross Blue Shield and Blue Cross Blue Shield of Alabama. Healthcare Reimbursements are administered by Wex Health. The Prescription Drug benefit is self-insured and administered by Express Scripts, Inc. Dental coverage is self-insured, under an administrative service agreement between the Company and Delta Dental of Missouri. Vision coverage is self-insured, under an administrative service agreement between the Company and Vision Service Plan (“VSP”). The Employee Assistance Program is administered by Guidance Resources Worldwide. Other programs are on a fully-insured basis and are administered by the insurer.

Vision and dental benefits are offered to eligible active union and non-union employees and their dependents. Healthcare Reimbursements and Voluntary Accidental Death and Dismemberment are offered to eligible active union and non-union employees. Termination and dismissal pay are offered to eligible active union employees. Voluntary Term Life Benefit, Long-Term Disability Insurance, Voluntary Group Accidental Death and Dismemberment Insurance and Business Travel Accident are offered to eligible active non-union employees. Special Life Insurance is offered to certain eligible active and retiree non-union employees.

**Coverage for Eligible Retirees and/or their Dependents: Spire Missouri, Spire Alabama and Spire Gulf** – Employer contributions are made to the Trusts in such amounts and at such times as necessary to fund them. The Employers’ funding policy is to contribute amounts to the Trusts equal to the periodic benefit cost calculated pursuant to ASC Topic 715. Therefore, the Plan records an employer contribution receivable equal to the estimated liability for incurred but unreported claims. Trust assets must be used exclusively for paying benefits to eligible retirees and/or their dependents and for paying any administrative expenses incurred by the retiree medical plan related to the Trusts. The assets of the Trusts shall never inure to the benefit of the Employer.

## **2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting** – The Plan follows the provisions of the FASB Accounting Standards Codification (ASC) Topic 965, Plan Accounting – Health and Welfare Benefit Plans. Obligations for claims that have been reported but not paid and claims that have been incurred but not reported are accrued in the financial statements.

**Fair Value of Plan Assets** – Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. GAAP establishes a hierarchy of inputs used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities.
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.
- Level 3** Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

A description of the valuation methodologies used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy is included in Note 3.

**Postretirement Benefits** – The postretirement benefit obligation (Note 4) represents the actuarial present value of those estimated future benefits that are attributed to employee service rendered to December 31, 2024 and 2023. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired employees and their beneficiaries and dependents and (2) active employees and their beneficiaries and dependents after retirement from service with the Company. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the present value of the portion of the expected postretirement benefit obligation that is attributed to that employee's service rendered to the valuation date. The postretirement benefit obligation represents the amount that is to be funded by contributions from the Company and from existing Plan assets.

The actuarial present value of the expected postretirement benefit obligation is determined by the Plan's independent actuary and is the amount that results from applying actuarial assumptions to historical claims cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment, and to reflect the portion of those costs expected to be borne by Medicare, the retired participants, and other providers.

**Investment Valuation and Income Recognition** – Investments in funds are stated at the fair value of the direct investments held by the Plan and are determined by quoted market prices. Purchases and sales of securities are recorded at the trade date. Interest and dividend income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold and / or held during the year.

**Use of Estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, benefit obligations and changes therein, claims incurred but not reported, disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions and deductions during the reporting period. The liability reported for incurred but unreported claims is an estimate based on historical claims experience. Actual results could differ from these estimates.

**Risks and Uncertainties** – The Trusts invest in mutual funds. The mutual funds may invest in various securities including U.S. government securities, corporate debt instruments, and corporate stocks. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of benefit obligations and net assets available for benefits.

There has been significant volatility in the investment markets both nationally and globally since the Plan's year end. While the Plan has no immediate intention to liquidate any significant portion of its portfolio, the Plan may

be required to liquidate a portion of these investments in order to pay plan expenses or benefits to participants. Conversely, any planned contribution amounts may have to be adjusted to ensure continuous payment of all benefit types.

**Administrative Expenses** – The cost of the Plan administration is paid by Spire Services Inc., the Plan sponsor. The Plan does pay all Trustee and investment adviser fees, in accordance with Plan provisions.

**Review of Subsequent Events** – Subsequent events have been evaluated through October 9, 2025, which is the date the financial statements were available to be issued.

### 3. FAIR VALUE OF INVESTMENTS (UNAUDITED)

The table below represents the fair value measurements of assets recognized in the accompanying Statements of Benefit Obligations and Net Assets Available for Benefits measured at fair value on a recurring basis and the level within the fair value hierarchy in which the fair value measurements fall at December 31, 2024 and 2023.

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no assets or liabilities measured at fair value on a non-recurring basis.

### 4. POSTRETIREMENT BENEFIT OBLIGATION

The postretirement benefit obligations at December 31, 2024 and 2023 related to the following categories of participants (including their beneficiaries and dependents) are as follows:

At December 31, 2024, the assumed health care cost trend rate used in measuring the accumulated postretirement benefit obligation for the next year was 6.50% and gradually decreases each successive year until it reaches 5.00% in 2031 and future years. Such rate was 6.50% for December 31, 2023, gradually decreasing each successive year until it reaches 5.00% in 2030 and future years. A one percentage-point increase or (decrease) in the assumed health care cost trend for each future year would have increased or (decreased) the postretirement benefit obligation by \$5,340,000 or (\$4,743,000).

- Mortality rates for active and retired lives – For 2024 and 2023, separate rates for non-annuitants and annuitants (based on Pri-2012 “Employees” and “Non-disabled Annuitants” tables, respectively, without collar or amount adjustment), projected generationally using a modified version of scale MP-2021 and MP-2018, respectively.
- Mortality rates for disabled lives – For 2024 and 2023, the Disabled Retiree PRI-2012 mortality table projected generationally using a modified version of scale MP-2021 and MP-2018, respectively.
- Retirement – Rates vary beginning at age 55 through age 65.

The foregoing actuarial assumptions were based on the presumption that the Plan will continue. If the Plan were to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of postretirement benefit obligations.

## **5. TAX STATUS**

### Spire Missouri Wrap Document

The Internal Revenue Service has determined that the Trusts of the Plan are exempt from Federal income tax under Internal Revenue Code Section 501(c)(9), with the exception of the unrelated business income tax remitted by the Employee Benefit Trust for Retirees of Spire Missouri Inc. Not Covered by a Collective Bargaining Agreement and the Employee Benefit Trust for Retirees of Spire Missouri West Division of Spire Missouri Inc. Not Covered by a Collective Bargaining Agreement on the income from investments used to fund medical benefits. Accordingly, the Trusts’ net investment income is exempt from income taxes.

The Missouri East Trusts have obtained exemption letters dated December 4, 1995 and December 29, 1995, from the Internal Revenue Service. The Missouri West Trust received an exemption letter from the Internal Revenue Service dated April 12, 1991.

The Wrap Plan Document was adopted effective October 1, 1999 and was amended and restated effective January 1, 2023, with no significant changes. The Plan sponsor believes that the Trusts and Plan continue to qualify and operate in accordance with the applicable requirements of the Internal Revenue Code.

### Spire Alabama Retiree Plan

The Salaried Trust Fund and the Group Life Trust Fund have received exemption letters from the Internal Revenue Service dated November 6, 2014, stating that the trusts are tax-exempt under the provisions of Section

501(c)(9) of the Internal Revenue Code (“IRC”), with the exception of the unrelated business income tax remitted by the Salaried Trust Fund and the Group Life Trust Fund on the income from investments used to fund benefits. The Hourly Trust Fund has received an exemption letter from the Internal Revenue Service dated September 28, 1994, stating that the trust is tax-exempt under the provisions of Section 501(c)(9) of the IRC.

#### Spire Gulf Inc. Retirees’ Group Insurance Plan

The Gulf Salaried Trust Fund has received an exemption letter from the Internal Revenue Service dated August 10, 1992, stating that the trusts are tax-exempt under the provisions of Section 501(c)(9) of the Internal Revenue Code (“IRC”), with the exception of the unrelated business income tax remitted by the Gulf Salaried Trust Fund on the income from investments used to fund benefits. The Gulf Hourly Trust Fund has received an exemption letter from the Internal Revenue Service dated August 10, 1992, stating that the trust is tax-exempt under the provisions of Section 501(c)(9) of the IRC.

## **6. TERMINATION OF THE PLAN**

In the event of termination of the Plan, any remaining assets of the Trusts shall be applied: to provide benefits to those who are then receiving or entitled to receive benefits, to provide benefits to those who are eligible for benefits on termination of the Plan, and to satisfy all liabilities of the Plan.

## **7. UNAUDITED INFORMATION PREPARED BY TRUSTEES**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, U.S. Bank, N.A and Russell Investments Trust Company, qualified institutions, have certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedules is complete and accurate:

- Investments as shown in the statements of benefit obligations and net assets available for benefits as of December 31, 2024 and 2023.
- Investment income as shown in the statements of changes in benefit obligations and net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investment information included in the accompanying schedule of assets (held at end of year) as of December 31, 2024.

The Plan’s independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

**8. RECONCILIATION OF STATEMENTS OF BENEFIT OBLIGATIONS AND NET ASSETS AVAILABLE FOR BENEFITS TO FORM 5500**
