## **NOTES TO FINANCIAL STATEMENTS**

**DECEMBER 31, 2024**

### **Note 1: Description of Plan**

The following description of the Information Providers, Inc. ("Company") 401(k) Retirement Plan ("Plan"), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all employees of the Company, excluding leased employees. The President and Vice President are excluded from all discretionary non-elective contributions. Eligible employees must complete six months of credited service and be age twenty-one or older. Plan entry dates are the first day of each quarter. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

Each year, participants may contribute up to 100% of pre-tax annual compensation, as defined in the Plan, and post-tax Roth 401(k) contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 4% of eligible compensation. Contributions are automatically invested in a designated balanced fund until changed by the participant. Matching contributions and additional discretionary non-elective amounts may be contributed at the option of the Company's Board of Directors. During the year ended December 31, 2024, the Company made matching contributions of \$113,070 to the Plan. There were no discretionary contributions for the year ended December 31, 2024. Contributions are subject to certain statutory limitations.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions and, (b) Plan earnings (losses), and charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is fully vested after six years of credited service for employer non-elective contributions and after three years of credited service for employer matching contributions. A participant is also fully vested upon reaching normal retirement age, upon death, or upon becoming totally and permanently disabled.

#### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The participants may have one outstanding note receivable. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 5.25%-10.50%, which are commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest is paid through payments made directly to the Plan by participants.

### **Note 1: Description of Plan (Continued)**

#### **Payment of Benefits**

On termination of service due to death, disability or retirement, a participant or designated beneficiary may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in the participant's account or take partial withdrawals. For termination of service due to other reasons, a participant will receive the value of the vested interest in the participant's account as a lump-sum distribution. For the period January 1, 2024 to September 30, 2024 if a participant terminates with a vested balance of less than \$5,000, the amount of their vested balance is required to be removed from the Plan. For the period October 1, 2024 to December 31, 2024 this amount increased to \$7,000.

#### **Forfeited Accounts**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$6,354 and \$2,002, respectively. These accounts will be used to reduce future employer contributions and plan expenses. No forfeitures were used to reduce employer contributions or plan expenses in 2024.

### **Note 2: Summary of Significant Accounting Policies**

#### **Statement Presentation**

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("GAAP").

#### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting. Investments held by a defined contribution plan are required to be reported at fair value.

#### **Use of Estimates**

The preparation of financial statements in accordance with GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value and all are participant directed. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the plan year.

### **Note 2: Summary of Significant Accounting Policies (Continued)**

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant note receivable to be in default, the participant note receivable balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are included in net appreciation of fair value of investments. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

#### **Subsequent Events**

The plan sponsor has evaluated subsequent events through October 9, 2025, the date on which the financial statements were available to be issued.

### **Note 3: Fair Value Measurements**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs would only be used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used when Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 1 or 2 inputs for the periods presented and there were no changes in the methods used to measure fair value at December 31, 2024 and 2023.

### **Level 3 Fair Value Measurements**

The insurance company general account is not actively traded and significant other observable inputs are not available. The fair value is measured by discounting the related cash flows and is therefore approximated at contract value. The Plan owns a promise to pay interest at crediting interest rates which are announced in advance and guaranteed for a specific period of time and is backed by the general assets of Minnesota Life Insurance Company (2.32% and 2.11% for the years ended December 31, 2024 and 2023, respectively).

For those assets with fair value measured using Level 3 inputs, the Plan Administrator determines the fair value measurement policies and procedures in consultation with the Company's corporate support manager and the Plan trustee. Those policies and procedures are reassessed at least annually to determine if the current valuation techniques are still appropriate. At that time, the unobservable inputs used in the fair value measurements are evaluated and adjusted, as necessary, based on current market conditions and other third-party information.

Gains and losses included in changes in net assets available for benefits for the years ended December 31, 2024 and 2023 are reported in net appreciation in fair value of investments for pooled separate accounts and interest-other for the insurance company general account.

The Plan's policy is to recognize transfers into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the year ended December 31, 2024, there were no transfers of investments into or out of Level 3.

**Note 4: Priorities Upon Termination of the Plan**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, the participants will become fully vested in their employer contributions.

**Note 5: Trustee and Administration of the Plan**

The Plan is administered by Information Providers, Inc., the Plan sponsor. The Company uses a third party administrator to aid in the acquisition, disposition, and accounting for trust assets. Frederick Peters, an officer of the Company, is the appointed trustee.

**Note 6: Tax Status**

The Plan is qualified under Section 401 of the Internal Revenue Code (IRC) and is exempt from federal and state income taxes. The non-standardized pre-approved plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the underlying non-standardized pre-approved plan was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the opinion letter. However, the Plan Administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC.

GAAP requires the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.
