We have performed audits of the financial statements of Fetzers' Inc. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

## **Note 1. Description of the Plan**

The following description of Fetzers' Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan document and *Summary Plan Description* for a more complete description of the Plan's provisions, which are available from the plan administrator.

### **General**

The Plan was established on December 30, 1953 and is a defined contribution plan sponsored by Fetzers' Inc. (the Company) for the benefit of its eligible employees who have either completed 250 hours of service during three consecutive months from the date of employment or completed one year of service and have attained the age of 18. Eligible employees may enter the Plan on the first day of coinciding or following pay period. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Great-West Trust Company, LLC is the custodian of the Plan.

The Plan is governed by the Trustees, which is appointed by the Board of Directors of the Company.

### **Contributions**

Participants authorize the Company to deduct a percent of their annual compensation for deposit into the Plan. However, the law limits the amount that can be contributed in any tax year (\$23,000 in 2024). Pursuant to the *Economic Growth Tax Relief Reconciliation Act* (EGTRRA) amendments, participants who have attained age 50 during the plan year may make additional elective contributions (\$7,500 in 2024). The Plan allows participants to designate contributions as Roth 401(k) contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company may make contributions. Company contributions are discretionary as determined by the Trustees of the Plan. For 2024 and 2023, the Company matched 100% of the first 3% and 50% of the next 2% of participant contributions made and satisfied the safe harbor rules during those years.

### **Participant Investment Account Options**

Investment account options available include various mutual funds and a collective investment trust. Each participant has the option of directing his or her contributions into any of the funds offered by the Plan and may change the allocation daily.

### **Participant Accounts**

Each participant's account is credited with the participant's contribution, the Company's contribution and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants are immediately vested in their voluntary contributions, plus earnings thereon, as well as the Company's matching contribution.

***Payment of Benefits***

In the case of termination of employment, a participant may elect to receive a lump-sum amount if the balance exceeds \$5,000. A participant will receive the vested benefit in a lump-sum amount if the balance is less than \$5,000. In the case of termination of service due to death, disability or retirement of service, a participant may elect to receive an amount equal to the value of the participant's vested interest in either a lump-sum amount, or in payments in monthly, quarterly, or annual installments. This payment period is not to exceed the life expectancy of the participant or joint life and last survivor expectancy of the participant or the individual the participant designates as a beneficiary. An in-service withdrawal is permitted upon attainment of age 59 ½ and hardship withdrawals are permitted under certain circumstances, as defined by the Plan.

***Forfeited Accounts***

Forfeited accounts include the nonvested portion of the Company's contributions, including any realized earnings thereon, previously allocated to former participants in the Plan. Forfeitures may be first used to pay any administrative expenses. The remaining forfeitures may then be used to reduce employer contributions. The Plan did not have any forfeited nonvested accounts for the years ended December 31, 2024 and 2023.

***Notes Receivable from Participants***

The plan document includes provisions authorizing loans from the Plan to active eligible participants. Loans are made to any eligible participant. The minimum amount of a loan shall be \$1,000. The maximum amount of a participant's loans is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. A participant may have no more than two outstanding loans at any time. All loans are covered by demand notes and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings unless the participant is paying the loans in full. Interest on the loans is equal to 1% above the prime rate. Loan refinancing is not permitted.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes in net assets available for benefits and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Valuation of Investments and Income Recognition***

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds and the money market fund are valued at the net asset value (NAV) of shares held by the Plan at year-end.

The Plan's interest in the stable value fund (SVF), a collective investment trust (CIT), is based on information reported by the investment advisor using the audited financial statements of the SVF.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded when received. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Contributions***

Contributions from plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

***Plan Tax Status***

The Plan operates under a standardized adoption agreement in connection with a volume submitter profit sharing plan sponsored by Pen-Cal Administrators, Inc. This volume submitter plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and that the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

**Note 3. Certification of Plan Custodian**

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Great-West Trust Company, LLC, a qualified institution and custodian of the Plan, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments at fair value as shown in the statements of net assets available for benefits and related disclosures as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information (excluding participant loans) included in the accompanying schedule of assets (held at year-end) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

#### **Note 4. Related-Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Certain plan investments are shares of mutual funds managed by Great-West Trust Company, LLC. Great-West Trust Company, LLC is a custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment.

The Plan incurs expenses for certain accounting and auditing services. For the years ended December 31, 2024 and 2023, these expenses were \$124,041 and \$105,000, respectively.

#### **Note 5. Disclosures About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets

In accordance with Subtopic 820-10, the Plan's investment in the stable value fund (SVF), a collective investment trust (CIT) was measured at net asset value per share (or its equivalent) totaling \$779,273 and \$877,709 at December 31, 2024 and 2023, respectively, and have not been classified in the fair value hierarchy. This category of investments seeks to provide income while protecting investors' wealth by maintaining a stable fund net asset value.

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the year ended December 31, 2024. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

***Investments***

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy, and include mutual funds and a CIT. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. The Plan does not hold any Level 2 or Level 3 securities.

**Note 6. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 7. Plan Termination**

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

**Note 8. Subsequent Events**

Subsequent events have been evaluated through September 16, 2025, which is the date the financial statements were available to be issued.
