## INDEPENDENT AUDITORS' REPORT

To the Participants and Trustees  
Spartan Logistics 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Spartan Logistics 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

## 1. DESCRIPTION OF PLAN:

The following description of the Spartan Logistics 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

### General

The Plan is a defined contribution plan covering full-time employees, subject to certain exclusions, as defined by the Plan, of Spartan Warehouse & Distribution Company, Inc. and any related companies that have adopted the Plan (collectively, the Employer) who have completed specified service requirements, as defined, and are age eighteen or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was restated effective January 1, 2022.

The Plan was amended effective January 1, 2023 to allow Benchmark Restaurant Group to participate in the Plan and amended effective March 1, 2023 to allow Harmon Management Services Company to participate in the Plan. Effective August 1, 2023, the Plan was amended to change the eligibility requirements to age eighteen and two months of service.

### Contributions

Each year, participants may contribute a portion of their pretax annual compensation, as defined by the Plan, subject to certain limitations established by law. Participants are also permitted to make Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute rollover contributions representing distributions from other qualified defined benefit or defined contribution plans.

The Employer contributes a safe harbor matching contribution of 100% of the participant's elective contributions up to 4% of the participant's eligible compensation. In addition, the Employer may, at its discretion, make a profit sharing contribution. No profit sharing contributions were made by the Employer for the years ended December 31, 2024 or 2023.

### Participant accounts

Each participant's account is credited with the participant's contribution and allocations of the Employer's contributions and Plan investment earnings. Participant accounts are charged with an allocation of administrative expenses and Plan investment losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their contributions into various investment options offered by the Plan.

### Vesting

Participants are vested immediately in their contributions plus actual earnings thereon and any safe harbor contributions made by the Employer. A participant becomes 100% vested in the profit sharing contribution after three years of credited service.

### Payment of benefits

In accordance with the Plan, a participant may receive the vested value of his or her account upon normal retirement at age 65, early retirement at age 60, attainment of age 59½, total disability or termination.

Upon the death of a participant, the beneficiary shall be entitled to the full value of the account.

Distributions shall be made in lump sum or substantially equal installments.

Before a participant attains the normal retirement age or age 59½, he or she may elect to withdraw any or all of his or her pretax contributions only in the event of a financial hardship, as defined in the Plan. The plan administrator must approve all hardship withdrawals and such distributions shall be limited solely to the participant's contributions.

**Participant notes receivable**

Participants may borrow from their accounts a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. Notes to participants are secured by the respective participant's vested account balance and are subject to interest charges. Interest rates applicable to new notes are determined by the plan administrator at a reasonable fixed rate with reference to the economic conditions and interest rates being charged by financial institutions for loans which would be made under similar circumstances. Notes are repaid ratably through periodic payroll deductions over a term not exceeding five years, or ten years for the purchase of a primary residence.

**Forfeited accounts**

There were no forfeited nonvested accounts for the years ended December 31, 2024 and 2023.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:**

**Basis of accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment valuation and income recognition**

The Plan's investments are reported at fair value (except for fully benefit-responsive contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustees determine the Plan's valuation policies utilizing information provided by the investment advisor and custodian.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of benefits**

Benefits are recorded when paid.

**Participant notes receivable**

Participant notes receivable are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant notes are reclassified as distributions based upon the terms of the plan document. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

### **Administrative expenses**

Certain Plan expenses are paid by the Employer and are excluded from these financial statements. If the Employer does not pay Plan-related expenses, such fees or expenses will generally be allocated to the accounts of participants either proportionally based on the value of account balances or as an equal dollar amount based on the number of participants in the Plan. The participant is responsible for any investment-related fees incurred as a result of their investment decisions. Additionally, a participant may be charged fees directly associated with the administration of the participant's account.

### **Subsequent events**

The Plan evaluates events and transactions occurring subsequent to the date of the financial statements for matters requiring recognition or disclosure in the financial statements. The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

### **3. CERTIFIED INVESTMENT INFORMATION:**

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Standard Insurance Company (Standard), a qualified institution, has certified to the completeness and accuracy of all investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023 and the supplemental schedule of assets (held at end of year) as of December 31, 2024 and the related investment activity and interest income on notes receivable from participants reflected in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.

### **4. INSURANCE CONTRACT:**

The Plan has a fully benefit-responsive insurance contract with Standard. Standard maintains the contributions in a general account. The account is credited with contributions and earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed insurance contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The contract meets the fully benefit-responsive contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Standard, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events may limit the ability of the Plan to transact at contract value with the issuer. The Plan administrator believed that any events that would limit the Plan's ability to transact at contract value with participants were not probable of occurring.

## 5. FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation method used for assets measured at fair value. There have been no changes in the method used at December 31, 2024 or 2023.

- *Pooled separate accounts:* The pooled separate accounts are valued at net asset value (NAV), which is based on the market value of its underlying investments. The NAV is used as a practical expedient to estimate fair value. The practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. The investment objectives of the accounts include the preservation of capital, to attain certain growth or income, or to balance performance levels based on different tolerance levels of risk.

**Investments Measured Using the Net Asset Value per Share Practical Expedient**

The following tables summarize investments for which fair value is measured using the NAV per share practical expedient as of December 31, 2024 and 2023, respectively. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

**6. PARTY-IN-INTEREST TRANSACTIONS:**

Certain Plan investments are managed by Standard, the recordkeeper as defined by the Plan. In addition, certain fees are charged by Standard for investment management services. Therefore, these transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules.

**7. PLAN TERMINATION:**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

**8. TAX STATUS:**

The Employer elected to adopt a non-standardized defined contribution pre-approved plan which received a favorable opinion letter from the Internal Revenue Service dated June 30, 2020, that stated that the non-standardized defined contribution pre-approved plan was designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter; however, management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provisions for income taxes have been included in these financial statements.

**9. RISKS AND UNCERTAINTIES:**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**10. PLAN AMENDMENT CARES ACT:**

On March 27, 2020, the U.S. Congress passed the Coronavirus Aid, Relief, and Economic Security (CARES) Act. The CARES Act provides temporary relief for retirement plan sponsors and their participants with respect to distributions and participant loans. The provisions of the CARES Act may be effective and operationalized immediately, prior to amending the plan document.

The plan administrator has adopted the distribution and loan relief provisions included in the CARES Act which permits qualified individuals to request a pre-approved distribution up to \$100,000 through December 30, 2020, through participant self-certification of eligibility, and permits qualified individuals to defer repayments of an outstanding loan for one year. The CARES Act also permits the Employer to increase the maximum loan amount available to qualified individuals up to \$100,000 per participant.

The Employer intends to formally amend the Plan before the end of the applicable remedial amendment period to reflect such provisions.
