NOTE 1. DESCRIPTION OF THE PLAN

The following description of the Zoe Holding Company, Inc 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established for participation on January 1, 2013 and restated in 2021 and has been amended from time to time since that date. It is a defined contribution plan covering all eligible employees of Zoe Holding Company, Inc (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Eligibility

Under the provisions of the Plan, each employee shall be eligible to participate in the Plan upon completing one month of service and attaining the age of 21.

Contributions

Each year, participants may elect to contribute to the Plan through tax-deferred and Roth salary deferrals up to 50% of their annual compensation, as defined by the Plan, not to exceed a statutory maximum determined by the Internal Revenue Service ("IRS"). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans ("rollovers"). Participants direct the investments of all contributions into various investment options offered by the Plan.

Company Matching Contributions

Each year, the Company may make a matching contribution at its discretion. For the year ended December 31, 2024, the Company elected to make a matching contribution equal to 50% of participant contributions up to \$500, amounting to \$23,422.

Additionally, the Company may make qualified matching contributions and/or qualified non-elective contributions. For the year ended December 31, 2024, the Company did not make qualified matching or qualified non-elective contributions.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contributions portion of their accounts is based on years of service. A participant vests 30% after year one, 60% after year two, and 100% after year three.

Hardship Withdrawal

In certain situations, as defined in the Plan agreement and with approval of the Plan Administrator, participants may make hardship withdrawals.

Participant Accounts

All investment options are participant directed. Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and Plan earnings, and reduced for any Plan losses and administrative expenses. The benefit to which a participant is entitled is the benefit from the participant's vested account.

Notes Receivable from Participants

Notes receivable from participants are not permitted by the Plan.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant will receive a lump sum amount equal to the value of the participant's vested interest in their account in accordance with the provisions of the Plan. In the event that a participant dies before retirement, their beneficiary will receive the value of the participant's vested interest in a lump sum distribution in accordance with the provisions of the Plan. For termination of service for other reasons, a participant may receive the value of the vested interest in their account as a lump sum distribution.

Forfeitures

Forfeitures of Company contributions may be used to restore forfeitures, reduce Company contributions or reduce administrative expenses. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$905 and \$428, respectively. In 2024, employer contributions and administrative expenses were reduced by \$13,142 and \$12,801 from forfeited non-vested accounts, respectively.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year and reinvested interest and dividends.

Excess Contributions Payable

The Plan had contributions in excess of amounts allowed by the IRS totaling \$12,973 and \$32,069 for the years ended December 31, 2024 and 2023, respectively. Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding increase to corrective distributions deductions. The Plan distributed the 2024 excess contributions to the applicable participants in March of 2025.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan, unless otherwise paid by the Company. Fees related to the administration of participants' activities are charged directly to the participants' accounts and are included in administrative expenses. Investment related expenses are included in the net appreciation of fair value of investments.

Concentration of Credit Risk and Financial Instruments

Financial instruments that potentially subject the Plan to concentrations of credit risk consist of securities held by a broker.

NOTE 3. FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted

prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 and Level 3 inputs for the periods presented.

Level 1 Fair Value Measurements

The fair value of registered investment companies is based on quoted net asset values of the shares as reported by the funds. The registered investment companies held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The registered investment companies held by the Plan are considered to be actively traded.

The fair value of common/collective trusts is valued at the net asset value ("NAV") of units of a collective investment trust. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. Participant transactions may occur daily.

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Financial Group has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate with respect to investments:

- Investments, at fair value
- Interest and dividend income
- Net earnings and appreciation in fair value of investments
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

NOTE 5. TAX STATUS OF THE PLAN

The IRS has determined and informed the Company in a letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and Sponsor's management believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore believe the Plan is qualified and is tax-exempt.

The Plan follows the provisions of ASC 740, *Income Taxes* of the FASB Accounting Standards Codification. The Plan believes it has no uncertain tax positions that qualify for either recognition or disclosure. As of December 31, 2024, due to statutes of limitations, the Plan is no longer subject to examination of its Form 5500 by the IRS for years prior to 2021.

NOTE 6. TERMINATION OF THE PLAN

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 7. RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, including interest rate, market and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

NOTE 8. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan's investments consist of registered investment companies and common/collective trusts managed by Principal Life Insurance Company, a member company of Principal Financial Group. Principal Financial Group is the Custodian and Principal Life Insurance Company is the Recordkeeper, as defined by the Plan and, therefore these transactions qualify as party-in-interest. Fees paid by the Plan to Principal Life Insurance Company during the year ended December 31, 2024 totaled \$52,124. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 9. SEPARATED PARTICIPANTS

At December 31, 2024 and 2023, there were no amounts allocated to accounts of persons who had elected to withdraw from the Plan but have not yet been paid.
