Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Description of Plan

The following description of the Wall Family Enterprise Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is intended to meet the requirements of Section 401(k) of the Internal Revenue Code (IRC) and qualify as a defined-contribution plan. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and is sponsored by Wall Family Enterprise, Inc., Demco, Inc., Gaylord Bros., Inc. and Hatch, Inc. (the Company). Eligible participants of the Plan include all employees of the Company who have completed a minimum of one hour of service, excluding collective bargaining employees. The Plan's Investment and Administrative Committee is responsible for oversight of the Plan and determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

Contributions

Participants may contribute to the Plan on a pre-tax and/or after-tax basis from their gross wages an amount not to exceed the annual elective deferral limit specified by the Internal Revenue Service (IRS), up to \$23,000 for 2024. Participants who have reached age 50 before the end of the plan year are also eligible to make catch-up contributions up to \$7,500 in 2024. The total company and participant contributions cannot exceed the lesser of 100% of eligible compensation as defined in the plan document or \$76,500 for 2024. The Plan also permits participants to make rollover contributions from other qualified retirement plans.

All newly eligible employees are automatically enrolled in the Plan if a salary deferral agreement is not executed upon attaining eligibility. Automatically enrolled participants have their pre-tax deferral set at 6% of eligible compensation and their contributions invested in designated balanced investment fund until changed by the participant. Employees enrolled via automatic deferral shall have their automatic deferral increased by 1% per year up to a maximum of 15% of eligible compensation at the beginning of each subsequent plan year. Participants may subsequently change these deferral and investment elections at any time.

The Company makes safe harbor matching contributions equal to 100% of each participant's elective deferrals up to 3% of the participant's eligible compensation, and 50% of the next 3% of the participant's eligible compensation. Additional discretionary matching contributions may be made at the option of the Company's management team. A participant must be employed on the last day of the plan year and work at least 30 days during the plan year in order to receive an additional discretionary matching contribution, which are allocated based on the participants' eligible compensation. For 2024, the Company did not make any discretionary additional matching contributions.

Each participant's account is credited with the participant's contributions, company contributions, reallocation of forfeitures and allocations of investment earnings and losses, rollover contributions and charged with participant withdrawals and allocations of administrative expenses. Investment earnings, losses and administrative expenses are allocated based on the value of each participant's account balance. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contributions are based on years of continuous service. Safe harbor contributions are 100% vested after two years of credited service, while for additional matching contributions, a participant is 20% vested after one year of credited service and continues to vest in increments of 20% until 100% vested after five years of credited service. Other employer contributions contain certain vesting provisions as set forth in the plan document.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is set at the Prime rate, as defined. Principal and interest are paid ratably through monthly payroll deductions. Terms range from one to five years or greater for the purchase of a primary residence.

Payment of Benefits

Benefits may be paid to the participant or beneficiary upon death, disability, retirement or termination of employment, as defined in the plan agreement. The Plan provides for normal retirement at age 65 and early retirement on or after attaining age 60 and completion of five years of service. A participant, upon election of a benefit payment, may receive an amount equal to the vested interest in his or her account in either a lump sum amount or in annual installments. Participants experiencing financial hardship may withdraw a portion of this account balance as defined by the Plan. Participants who have reached the age of 59 1/2 may take in-service withdrawals of all or any part of their vested account at any time.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$128,786 and \$43,090, respectively. These accounts will be allocated to participant accounts of participants employed on the last day of the plan year. During 2024, no amounts were applied to plan activities from forfeited nonvested accounts.

Termination of Plan

Although they have not indicated any intention to do so, the Company has the right under the Plan to discontinue their contributions at any time and to withdraw from the Plan or to terminate the Plan subject to provisions of ERISA. In the event of the termination of this plan, the interest of each participant shall become fully vested and the assets of the trust shall be liquidated and the accrued benefits shall be paid to the participants after provision is made for the expense of liquidation.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment and Administrative Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company, as applicable. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. Related fees are recorded as administrative expenses and are expensed when they are incurred. Interest income is recorded on the accrual basis.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Payment of Benefits

Benefits are recorded when paid.

Recent Regulatory Updates

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the year ended December 31, 2024, and continues to evaluate the impact of the adoption and implementation of this legislation on the Plan. The application of SECURE 2.0 Act did not have a material effect on the Plan's financial statements.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust funds: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

4. Concentrations

At times the Plan may hold certain investments that represent 10% or more of the Plan's net assets available for benefits. As of December 31, 2024 and 2023, the Plan had investments totaling \$16,725,581 and \$14,460,133 respectively, that were concentrated in two funds.

5. Information Certified by Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules (DOL) and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Empower Trust Company, LLC, the Trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024. Such information was obtained by management and agreed to or derived from information certified as complete and accurate by a qualified institution.

6. Related-Party and Party in Interest Transactions

The Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

7. Tax Status

The Plan obtained its latest opinion letter on November 14, 2022, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the opinion letter. The plan administrator believes that the Plan, as amended, is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan was qualified and the related trust was tax-exempt at the financial statement date.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

9. Delinquent Participant Contributions

For the year ended December 31, 2023, the Company did not remit certain participant contributions to the Plan on a timely basis as defined by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Untimely remittances identified on the Schedule of Delinquent Participant Contributions, which totaled \$21,833, in 2023 have been corrected during 2024. Additionally, the Plan has compensated participants for lost earnings resulting from the delay in contributions.

10. Subsequent Events

The Plan has evaluated subsequent events through October 10, 2025, the date that the financial statements were approved and available to be issued.

During 2025 the Plan approved changes to the fund line-up replacing certain existing funds with new funds with similar risk characteristics.
