1. DESCRIPTION OF PLAN:

The following description of the 403(b) Thrift Plan of Cadence International (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

GENERAL

The Plan is a defined contribution plan covering all eligible employees of Cadence International (Cadence). Other than employees who work less than twenty hours per week, all employees are eligible to participate in the Plan (as defined). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The 403(b) oversight committee of Cadence International is responsible for plan oversight.

CONTRIBUTIONS

Eligible employees are automatically enrolled in the Plan upon hire at 1 percent of compensation. Participants may contribute up to a maximum of 100 percent of annual compensation, as defined in the Plan and subject to the annual limits of the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to \$7,500. Participants direct the investment of their contributions into various investment options offered by the Plan.

PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's contribution and allocations of the Plan earnings and charged with an allocation of Plan expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

VESTING

Participants are vested immediately in their contributions and actual earnings thereon.

PLAN LOANS

Plan loans are issued as separate contracts by Mutual of America (MoA) as contemplated under IRC section 72(p)(5) and do not represent Plan assets. Such loans are subject to certain limitations. Applicants receiving such loans are required to pledge as collateral general interest account value of 100% of the loan amount for the period of time it is outstanding and are limited to the lesser of \$50,000 or 50%, of their vested account balance. Loan balances outstanding from MoA to the Plan participants were \$0 and \$8,445, as of December 31, 2024 and 2023, respectively. As such, general interest accounts as of December 31, 2024 and 2023, include collateral for related loans, which are included in cash and cash equivalents in the accompanying statements of net assets available for benefits. They bear interest at 4%. Principal and interest are paid monthly or quarterly as the agreement specifies.

1. DESCRIPTION OF PLAN, continued:

PAYMENT OF BENEFITS

Upon termination of service due to death, disability, retirement, or obtaining age 59 1/2, participants may request lump-sum cash distributions from their retirement account. Upon proof, to the satisfaction of the Plan administrator, of an immediate and heavy financial need, amounts contributed may be withdrawn for hardship purposes.

ADMINISTRATIVE EXPENSES

General administrative expenses are paid by the Plan. Indirect fees are netted against investment income.

2. SIGNIFICANT ACCOUNTING POLICIES:

BASIS OF ACCOUNTING

The financial statements of the Plan are prepared on the accrual basis of accounting.

ESTIMATES

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

INVESTMENT VALUATION AND INCOME RECOGNITION

Investments in pooled separate accounts are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Investments in pooled separate accounts are represented by a "unit of account" and per unit values whose value is the result of the accumulated values of the underlying investments. The underlying investments are mutual funds. The pooled separate accounts' net asset value (NAV) is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding.

INVESTMENT VALUATION AND INCOME RECOGNITION, continued

The following table summarizes information related to the pooled separate accounts measured at fair value based on NAV per share (or equivalent practical expedient) as of December 31, 2024 and 2023, respectively. The pooled separate accounts are maintained by the insurance company and hold investments in accordance with a stated set of objectives.

Because the pooled separate accounts are measured using NAV per share, a fair value leveling table is not disclosed.

The Plan also holds funds for investment in an interest-bearing cash account. Interest-bearing cash of \$279,114 and \$324,511 as of December 31, 2024 and 2023, respectively, is reported at cost value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

PAYMENT OF BENEFITS

Benefits are recorded when paid.

RECLASSIFICATION OF PRIOR YEAR AMOUNTS

Certain amounts in the prior year have been reclassified to conform to current year presentation.

3. INFORMATION CERTIFIED BY A QUALIFIED INSTITUTION:

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Mutual of America Life Insurance Company, a qualified institution, has certified the completeness and accuracy of all investments reflected on the accompanying statements of net assets for benefits, the related investment activity reflected in the statement of changes in net assets available for benefits, and the supplemental Schedule H, line 4i-Schedule of Assets (Held at End of Year).

4. PLAN TERMINATION:

Although it has not expressed any intent to do so, Cadence has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

5. TAX STATUS:

The Plan has adopted a prototype plan document sponsored by MoA Life Insurance Company. The prototype plan document has obtained an opinion letter from the Internal Revenue Service (IRS) dated March 31, 2017, which states that the prototype document satisfies the applicable provisions of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is operating in compliance with the applicable requirements of the Internal Revenue Code.

6. PARTIES-IN-INTEREST:

Certain investments of the Plan are separate accounts managed by MoA. MoA performs recordkeeping services for the Plan; therefore, these transactions qualify as party-in-interest transactions. Direct fees paid by the Plan for recordkeeping services amounted to \$642 for the year ended December 31, 2024.

7. RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. SUBSEQUENT EVENTS:

Subsequent events have been evaluated through June 19, 2025, which represents the date the financial statements were available to be issued. Subsequent events after that date have not been evaluated.
