Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Etnyre International Profit Sharing and Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Etnyre International Profit Sharing and Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Etnyre International Profit Sharing and Retirement Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. NOTE 1 DESCRIPTION OF PLAN

The following description of the Etnyre International Profit Sharing and Retirement Savings Plan (the Plan) provides only general information. Participants and others should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan originally effective February 3, 1947, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan has been amended throughout the years to comply with tax legislation and was most recently amended November 13, 2024. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). For the purpose of this Plan a trust known as the Etnyre International Profit Sharing and Retirement Savings Plan has been created to receive all contributions and to pay all benefits under the Plan.

Participation

Effective January 1, 2022, participation and entry in the Plan is extended immediately to any individual in the service and employ of Etnyre International, LTD, EDECO Southwest Service Company LLC (d/b/a Bear Cat Manufacturing and Rayner Equipment Systems), and EDECO, LLC (dba: SMF). Effective May 6, 2024, participation and entry in the Plan is extended immediately to any individual in the service and employ of EDECO East, LLC (dba: Hendrick Manufacturing and Hendrick Screen) (the Company), other than collectively bargained employees, nonresident aliens, and leased employees.

Contributions

Participants' Contribution

The Plan permits voluntary contributions by participants up to the maximum amount as defined by certain Internal Revenue Code (IRC) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation with an annual increase of 1% each year up to a maximum of 10%.

Contributions (Continued)

Matching Contribution

The Company may, at its discretion, elect to make a qualified matching contribution to the Plan. For the year ended December 31, 2024, the Company matching contribution for Etnyre International, Ltd. employees was equal to 25% of the participant's deferral, up to a maximum deferral percentage of 6%, for the Bear Cat Manufacturing employees was equal to 50% of the participant's deferral, up to a maximum deferral percentage of 5%, for the SMF, Inc. employees was equal to 50% of the participant's deferral, up to a maximum deferral percentage of 6%, and for Hendrick Manufacturing employees was equal to 50% up to the first 6% of the participants deferral. Matching contributions are invested in the same options as participant contributions, at the participant's discretion. During the 2024 Plan year, the Company made matching contributions of \$1,165,201.

Discretionary Contribution

The Company also funds the Plan by a discretionary profit sharing contribution as declared by the Board of Directors. Participants must work 1,000 hours during the year and be employed on the last day of the Plan year or have retired at normal retirement age during the Plan year to be eligible for an allocation of the profit sharing contribution. Discretionary contributions are invested in the same options as participant contributions at the participant's discretion. The Company allows a monthly contribution for the employees of Hendricks. EDECO East, LLC d/b/a Hendrick Manufacturing and Hendrick Screen participants must be employed on the last day of the month to receive the monthly Employer contribution during the Plan Year, and they must work at least 86.67 hours during the month. During the 2024 Plan year, the Company made discretionary contributions of \$2,423,437.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's matching contribution, the Company's profit sharing contribution allocation, an allocation of Plan earnings and expenses, and reduced for certain fees paid by the Plan. Allocations of earnings and expenses are based on participant account balances, while profit sharing allocations are based on period of service and compensation received from the Company by the participant for the Plan year. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their elective contributions and Company matching contributions, plus actual earnings thereon. Participants' interests in their share of the Company profit sharing contributions vest in accordance with the following schedule based on years of service (a 12 consecutive month period of at least 1,000 hours of service):

Vesting (Continued)

If an active participant dies prior to attaining normal retirement age, the participant's vesting percentage shall be 100%. Full vesting also occurs upon attainment of age 60 plus 5 years of service or termination of employment due to disability.

All participants from the SMF Inc Retirement Plan and Trust, Bear Cat Mfg., Inc. Profit Sharing Saving Plan, and Hendrick Manufacturing Co. Profit Sharing & Savings Plan were credited with their existing vesting service upon the merger with the Etnyre International Profit Sharing and Retirement Savings Plan.

Forfeited Accounts

At December 31, 2024 and 2023, the balance of forfeited nonvested accounts totaled \$283,394 and \$124,403, respectively. Forfeitures from less than 100% vested accounts could be used to offset Company contributions, pay for Plan administrative expenses, or reallocated to participant accounts as an additional profit sharing contribution in accordance with the Plan document terms and based on period of service and compensation received from the Company by the participant for the Plan year. During December 31, 2024, there were -\$0- of forfeitures used to offset Company contributions, respectively. There were \$31,690 of forfeitures used to offset Plan administrative expenses for the year ended December 31, 2024.

Benefit Payments

Benefits are payable to the participant upon:

- (a) death or retirement from the service of Company on or after normal retirement date (age 60 plus 5 years of service) or on account of disability; or
- (b) resignation or dismissal from the service of Company prior to normal retirement date.

If the benefits are payable in the event of (a) above, the amount of the benefits would be equal to the then balance in the participant's accounts. However, if (b) is applicable, the benefits payable would be the total of the participant's own contributions, and the Company matching and discretionary contributions, up to the amount of vested interest in the discretionary contributions. Benefits may be paid in either a lump-sum payment or substantially equal installments over a period of time not exceeding the participant's life expectancy or the joint life expectancy of the participant and the beneficiary. Payments may be made in cash or rollover to another qualified retirement plan. Each participant or former participant may, in writing, designate a beneficiary or beneficiaries to whom distributions of the participant's interest in the Trust shall be made in the event of the participant's death.

Upon reaching 59½ years of age, participants may elect to make a withdrawal of the entire balance of their account. Upon any distribution, the normal form of payment to a single participant is a lump sum and to a married participant is a joint and survivor annuity. Participants may elect installment payments over a period not to exceed the life expectancy of the participant and their designated beneficiary or a single sum. Married participants need spousal consent for the election of any option. Benefits of \$1,000 or less will always be paid in a single sum. The Plan also allows hardship distributions subject to Plan provisions.

Notes Receivable from Participants

A participant may borrow the lesser of \$50,000 reduced by the excess (if any) of the highest outstanding balance of notes receivable from the Plan to the participant during the one-year period ending on the day before the date on which such notes receivable was made, or 50% of his or her vested account balance. The notes receivable are secured by the balance in the participant's account. Notes receivable are repayable through payroll deductions over periods ranging up to 60 months or longer if for the purchase of a primary residence. The interest rate is determined by the Plan administrator based on prevailing market conditions and is fixed over the life of the note. At December 31, 2024 and 2023, interest rates on participant loans ranged from 1.0% to 9.50% and 3.25% to 9.50%, respectively.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the trustees. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent notes receivable are recorded as distributions on the basis of the terms of the Plan document.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

The Plan's expenses are paid either by the Plan or the Company, as provided by the Plan document. Expenses paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits.

Subsequent Events

The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION

Vanguard Fiduciary Trust Company, the qualified institution of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

NOTE 4 FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

NOTE 4 FAIR VALUE OF INVESTMENTS (CONTINUED)

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Fund: Valued daily at the NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily.

NOTE 5 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 6 PLAN TERMINATION

Although the Company has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time, and to terminate the Plan subject to the provisions of the Employee Retirement Income Security Act of 1974. In the event of termination, all participants would become fully vested.

NOTE 7 PLAN TAX STATUS

The Plan is placing reliance on an opinion letter dated June 30, 2020 from the Internal Revenue Service (IRS) indicating that the Plan is designed in accordance with the applicable sections of the IRC. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 PARTY-IN-INTEREST TRANSACTIONS

Mutual funds and a collective fund held by the Plan are managed by Vanguard Fiduciary Trust Company, the qualified institution of the Plan, and therefore, the investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Certain administrative functions are performed by officers or employees of the Company for which no compensation is received.

NOTE 9 TRANSFERS IN FROM PLANS

In May of 2024, the Hendricks Manufacturing Retirement Plan and Trust Plan was terminated and participants were given the option to rollover their funds into the Etnyre International Profit Sharing and Retirement Savings Plan. For individuals that elected to rollover their account balances, their loans were transferred into the notes receivable from participants balance of the Plan. During 2024, \$268,103 of loans were transferred into the Plan.
