INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Participants of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of Cleveland-Cliffs Steel LLC Hourly 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 Cleveland-Cliffs Steel LLC Hourly 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other matter – supplemental schedule required by ERISA

The supplemental Schedule of Assets Held for Investment Purposes at End of Year as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in

accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the prior year audit did not extend to any statements or information related to assets held for investment of the plan that were certified by a qualified institution. Their report dated August 29, 2024, indicated that (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2023 supplemental schedule, other than the information in the 2023 supplemental schedule that agreed to or is derived from the certified investment information, was presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA; and the information in the 2023 supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determines meets the requirements of ERISA Section 103(a)(3)(C).

NOTES TO FINANCIAL STATEMENTS

Cleveland-Cliffs Steel LLC Hourly 401(k) Plan

NOTE 1 - DESCRIPTION OF PLAN

The following description of The Cleveland-Cliffs Steel LLC Hourly 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

GENERAL

The Plan is a defined contribution plan that provides benefits to eligible employees of Cleveland-Cliffs Steel LLC and its affiliates ("the Company") who are members of the United Steelworkers Union or the Bricklayers and Allied Craftsmen Union of Indiana and Kentucky (the Union).

The assets of the Plan, excluding notes receivable from participants, are held in the Cleveland-Cliffs Inc. Defined Contribution Plan Master Trust ("Master Trust"). Fidelity Management Trust Company ("Fidelity") is the trustee and record keeper for the Plan. The Plan is administered by a committee appointed by the board of directors of the parent company, Cleveland-Cliffs Inc. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

CONTRIBUTIONS

Employees electing to participate in the Plan may contribute up to 50% of their annual compensation, as defined by the Plan, plus all or any portion of a bonus under the Company's profit-sharing plan or any other bonus plan or arrangement, subject to Internal Revenue Code (IRC) limitations. Newly hired employees are automatically enrolled in the Plan as soon as administratively practicable at a deferral rate of 5% unless the employee affirmatively elects not to participate in the Plan or a different level of contribution. In accordance with the agreement dated September 1, 2022 between the Company and the Union, the Company is to make monthly contributions to covered employees based on employee contributory hours, which amounted to approximately \$1 million for the year ended December 31, 2024. Additionally, on behalf of eligible employees hired or rehired after the 2015 labor ratification date of June 23, 2016, the Company makes a contribution of \$0.75 per hour worked thereafter upon completion of their probationary period in lieu of providing retiree health and life insurance benefits, which amounted to approximately \$8 million for the year ended December 31, 2024. Participant and employer contributions are fully vested at all times. Employer contributions may be directed to any of the eligible investment options offered by the Plan.

INVESTMENT OPTIONS

Participants direct the investment of their contributions and account balances into various investment options offered by the Plan. Investment options include a self-directed brokerage option, which allows participants to invest in options not offered directly through the Plan. On August 17, 2023, UBS Workplace Wealth Solutions replaced Fiduciant Advisors LLC as the Plan's investment advisor. As a result, some of the investment options offered by the Plan were removed or replaced in April 2024.

PARTICIPANTS' ACCOUNTS

Individual participant accounts are maintained and are credited with participant and employer contributions and allocations of investment earnings or losses from each investment fund in which such contributions are invested. Allocations of each fund's earnings or losses are based on the ratio of each participant's account balance in such fund to the total of all participants' balances in that fund. The cost of certain administrative services provided by the trustee are paid from participants' accounts or assets within the appropriate investment option, as applicable.

Participants, upon termination, can elect to transfer their contributions and related earnings to another qualified plan. The Plan provides that new participants may transfer their contributions and related earnings to the Plan from their previous employers' qualified plans.

VESTING

Participants are fully vested at all times in their respective contribution and match accounts.

NOTES RECEIVABLE FROM PARTICIPANTS

Participants may borrow up to 50% of their account balances up to a maximum of \$50,000, less any outstanding loan balance(s) within the last 12 months (subject to certain limitations set forth in the Plan), for terms not exceeding five years, subject to acceleration under certain circumstances, unless the loan qualifies as a home loan, for which a repayment term up to 15 years is permitted.

Participants may have up to two outstanding loans at any given time. The loans are secured by the balance in the participant's account and bear interest at rates commercially reasonable that are published on the first day of the month preceding the month the loan was granted. The loans are secured by the balances in the participant accounts.

PAYMENT OF BENEFITS

Upon retirement, termination of employment, death or disability, benefits are payable in a lump sum, partial cash distribution, installments or can be rolled over to an individual retirement account (IRA) or another eligible retirement plan based on the participant's election (or beneficiary). Hardship withdrawals are permitted in accordance with Internal Revenue Service ("IRS") guidelines. Participants are entitled to receive payments without terminating employment upon attainment of age 59½.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

BASIS OF ACCOUNTING

The accompanying financial statements have been prepared in accordance with the accounting principles generally accepted in the United States of America ("U.S. GAAP"), using the accrual method of accounting.

USE OF ESTIMATES

The preparation of financial statements in conformity with U.S. GAAP requires the use of estimates and assumptions that affect the reported amounts in the financial statements and disclosures. Actual results could differ from those estimates.

RISKS AND UNCERTAINTIES

The Plan utilizes various investment instruments through its participation in the Master Trust. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

VALUATION OF INVESTMENTS AND INCOME RECOGNITION

Investments in the Master Trust are stated at fair value, except for the synthetic investment contracts ("SIC"), which are stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for further discussion of fair value measurements.

Certain plans within the Master Trust have entered into benefit responsive investment contracts with various insurance companies. Under Accounting Standards Update ("ASU") 2015-12, SICs meet the fully benefit responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of their plan.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

BENEFIT PAYMENTS

Benefit payments to participants are recorded upon distribution.

ADMINISTRATIVE FEES

Certain trustee, record-keeping and administrative fees are paid by the Plan. All other management fees and costs of administering the Plan are paid by the Company. Other management fees may be paid by the forfeiture account in accordance with the Plan's arrangement with Fidelity.

PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of a plan termination, participants will be entitled to the benefit that can be provided by the participant's account.

SUBSEQUENT EVENTS

The Plan evaluates events occurring subsequent to the date of the financial statements in determining the accounting

for and disclosure of transactions and events that affect the financial statements.

Subsequent events have been evaluated through October 1, 2025, which is the date the financial statements were available to be issued.

NOTE 3 - TAX STATUS

On November 17, 2016, the IRS stated that the Plan is qualified under Section 401(a) of the Internal Revenue Code and, therefore, the related trust is exempt from taxation. The Plan has been amended; however, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken any uncertain tax positions that more likely than not would not be sustained upon examination by applicable taxing authorities. The Plan Administrator has analyzed tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability or that would require disclosure in the financial statements. The Plan is subject to routine audits by tax jurisdictions. However, currently no audits for any tax periods are in progress.

NOTE 4 - INVESTMENT IN MASTER TRUST

Use of the Master Trust permits the commingling of assets for these plans. Although the assets are comingled in the Master Trust, the trustee maintains supporting records for the purpose of allocating the net gain or loss of the investment account to the participating plans.

Effective January 1, 2023, the Trust Agreement Between Cleveland-Cliffs Inc. and Associated Employers and Fidelity Management Trust Company was amended to rename the Cliffs and Associated Employers Defined Contribution Plan Collective Trust to the Cleveland-Cliffs Inc. Defined Contribution Plan Master Trust.

The Master Trust includes the assets of the following plans:

- Cleveland-Cliffs Steel LLC Savings and Investment Plan (effective January 1, 2023)
- Cleveland-Cliffs Steel Corporation Thrift Plan A (effective January 1, 2023)
- Cleveland-Cliffs Steel Corporation Thrift Plan B (effective January 1, 2023)
- Cleveland-Cliffs Steel Corporation Thrift Plan C (effective January 1, 2023)
- Cleveland-Cliffs Tubular Components LLC Columbus, Indiana Plant 401(k) Plan (effective January 1, 2023)
- Cleveland-Cliffs Tubular Components LLC Walbridge 401(k) Retirement Plan (effective January 1, 2023)
- Fleetwood Metal Industries Corporation Retirement Savings Plan (effective January 1, 2023)
- Cannon BG 401(k) Plan (effective January 1, 2023)

NOTE 5 - FAIR VALUE OF FINANCIAL ASSETS

ASC 820, *Fair Value Measurements and Disclosures*, establishes a three-level valuation hierarchy for classification of fair value measurements. The valuation hierarchy is based upon the transparency of inputs to the valuation of an asset or liability as of the measurement date. Inputs refer broadly to the assumptions that market participants would use in pricing an asset or liability. Inputs may be observable or unobservable. Observable inputs are inputs that reflect the assumptions market participants would use in pricing the asset or liability developed based on market data obtained from independent sources. Unobservable inputs are inputs that reflect our own views about the assumptions market participants would use in pricing the asset or liability developed based on the best information available in the circumstances. The three-tier hierarchy of inputs is summarized below:

- Level 1 — Valuation is based upon quoted prices (unadjusted) for identical assets or liabilities in active markets.
- Level 2 — Valuation is based upon quoted prices for similar assets and liabilities in active markets, or other inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument.
- Level 3 — Valuation is based upon other unobservable inputs that are significant to the fair value measurement.

The classification of assets and liabilities within the valuation hierarchy is based upon the lowest level of input that is significant to the fair value measurement in its entirety.

The following is a description of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

Self-Directed Accounts - Primarily consists of common stocks, mutual funds and cash that are valued on the basis of readily determinable market prices and are classified as Level 1 investments. In addition, the self-directed brokerage accounts hold Level 2 investments, primarily consisting of bonds, which do not have regular market pricing, but whose fair value is determined based on third party pricing models maximizing the use of observable inputs for similar securities.

Collective Trust Funds - Valued at the NAV of units held. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the funds less their liabilities. This practical expedient is not used when it is determined to be probable that a fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of a collective trust, the investment advisor generally reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. There are no unfunded commitments of the collective trust funds.

Mutual Funds & Common Stock - Valued at the closing price reported on the active market on which the individual securities or mutual funds are traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 6 - INFORMATION CERTIFIED BY THE TRUSTEE

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, the trustee of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Plan interest in Cleveland-Cliffs Inc. Defined Contribution Plan Master Trust and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net investment income from interest in Cleveland-Cliffs Inc. Defined Contribution Plan Master Trust and interest from participant notes receivable, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Master trust investment information included in Note 4.
- Schedule H, schedule of assets (held at end of year) as of December 31, 2024.

NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by Fidelity Management and Research Company, which is affiliated with Fidelity as defined by the Plan and, therefore, these transactions qualify as party-in-interest. Usual and customary fees were paid by the mutual funds for the investment management services. In addition, the Plan has arrangements with various service providers and these arrangements qualify as party-in-interest.

NOTE 8 - INVESTMENT CONTRACTS

All plans within the Master Trust hold separately managed fully benefit-responsive stable value investments that hold an assortment of SICs.

A SIC is a wrap contract paired with an underlying investment or investments, usually a portfolio, of high-quality, intermediate-term fixed income securities. Certain funds held by the Master Trust purchase wrapper contracts from financial services institutions. As described in Note 2, because the SICs are fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets attributable to the SICs. Contract value, as reported by the trustees, represents contributions made under the contracts, plus earnings, less participant withdrawals and administrative expenses. SICs provide for a variable crediting rate, which typically resets at least quarterly based on the current yield of the underlying investments. The crediting rate is primarily based on the current yield to maturity of the covered investment, plus or minus the differences between the contract value and the market value of the underlying assets supporting the contracts amortized over the duration of each contract. The interest rate cannot be less than zero.

Certain events limit the ability of plans within the Master Trust to transact at contract value with the issuers. Such events include, but may not be limited to, the following: (1) amendments to plan documents (including complete or partial plan termination or merger with another plan); (2) changes to a plan's prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of a plan sponsor or other plan sponsor events (e.g., divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from a plan; or (4) the failure of the Master Trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrators of the plans within the Master Trust do not believe that the occurrence of any such value event, which would limit any plan's ability to transact at contract value with participants, is probable.
