## Independent Auditor's Report

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Vesta Food Service 401(k) Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Vesta Food Service 401(k) Plan and Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

### **Basis for Opinion**

#### **Note 1: Description of the Plan**

The following description of the Vesta Food Service 401(k) Plan and Trust (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan and was established January 1, 1998. LA Specialty Produce Co. DBA Vesta Food Service (the Company) is the plan sponsor (the plan sponsor). The Plan was established by the plan sponsor to provide retirement income for its employees and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### Contributions

The Plan is a contributory plan whereby participants may defer part of their earnings on a pre-tax or after-tax basis, up to 100% of their salary, not to exceed \$23,000 and \$22,500 for calendar years 2024 and 2023, respectively. All employees who are eligible to make elective deferrals under the Plan and who have attained the age of 50 before the close of the plan year are eligible to make additional catch-up contributions up to \$7,500 for calendar years 2024 and 2023. Participants may also contribute eligible amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Plan is a safe-harbor matching contribution plan. To be eligible for the safe-harbor matching contributions, employees must be eligible to participate in the Plan and have contributed to the Plan during the plan year.

The Company matches 100% of the participant's contribution on the first 3% of eligible earnings and 50% on the next 2% of eligible earnings. Matching contributions are allocated to investments per the participant's direction. The employer-safe harbor matching contributions for the year ended December 31, 2024, are \$851,771.

The plan sponsor may also make a discretionary profit-sharing contribution to the Plan. There are no discretionary profit-sharing contributions made for the year ended December 31, 2024. The participants must be employed on the last day of the plan year and have completed a year of service to receive a share of profit-sharing contributions.

##### *Participant Accounts*

Separate accounts are maintained for each participant. Each participant account is credited with the participant's contribution, allocations of the Company's contribution, plan earnings, and charged with an allocation of administrative expenses. Participants direct the investment of their contributions into various investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### *Vesting*

Participants are immediately vested in their contributions, safe-harbor matching contributions, and transfer of rollover contributions plus earnings thereon. Vesting in the Company's profit-sharing contribution portion of their accounts is based on years of continuous service. A participant is 100% vested in their employer contributions after six years of credited service.

The vesting schedule for employer profit-sharing contributions is as follows:

Less than 2 years	0%
At least 2 years, but less than 3	20%
At least 3 years, but less than 4	40%
At least 4 years, but less than 5	60%

##### *Payment of Benefits*

On termination of service due to death, disability, retirement or other reasons, a participant or beneficiary may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a single-sum cash payment or have it rolled over into an individual retirement account (IRA) or another qualified plan that accepts transfers.

##### *Forfeited Accounts*

Forfeitures are created when participants terminate employment before becoming vested to their full benefits under the Plan. These forfeited amounts will be used to reduce the employer contributions or to offset plan expenses. The Plan did not have any forfeitures available as of December 31, 2024 and 2023. The Plan did not have any forfeitures for the year ended December 31, 2024.

##### ***Hardship Withdrawals***

The Plan allows for hardship distributions in accordance with IRS regulations. A participant may withdraw any part of their vested account in the event of undue financial hardship.

##### ***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from 1 year to a maximum of 5 years (a maximum of 10 years if used to purchase participant's principal residence). The loans are secured by the balance in the participant's account and bear interest at the prime interest rate in effect at the time of loan issuance. Interest rates on participant loans range from 3.25% to 8.5% as of December 31, 2024 and 2023. Principal and interest are paid ratably through payroll deductions.

#### **Note 2: Summary of Significant Accounting Policies**

##### ***Basis of Accounting***

The financial statements of the Plan are prepared using the accrual method of accounting.

##### ***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results may differ from these estimates.

##### *Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussions of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid, interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024, and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan is treated as distributed based upon the terms of the plan document.

##### *Payment of Benefits*

Benefits are recorded when paid.

##### *Expenses*

Certain expenses of maintaining the Plan are paid by the plan sponsor and are excluded from these financial statements. Fees related to benefit payments and participant loan issuance are charged directly to the individual participant's account and are included in the administrative expenses. Investment related expenses are applied ratably to participants' accounts and are included in net appreciation of fair value of investments.

#### **Note 3: Investments (Unaudited)**

The December 31, 2024 and 2023 statements of net assets available for benefits, the investment activities included in the statement of changes in net assets available for benefits for the year ended December 31, 2024, the accompanying notes, and supplemental schedules to the financial statements, were prepared in part or entirely from information certified by the custodian, Reliance Trust Company, in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The information certified includes total investments of \$27,844,154 and \$23,614,535 as of December 31, 2024 and 2023, respectively.

The Plan's investments (including investments bought, sold, and held during the year) appreciated in value by \$1,631,531 during the year ended December 31, 2024. Interest income from the Plan's investments for the year ended December 31, 2024 is \$82,212. Dividend income from the Plan's investments for the year ended December 31, 2024 is \$1,696,900.

#### **Note 4: Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodology used as of December 31, 2024 and 2023.

*Registered investment companies (mutual funds):* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Security and Exchange Commission (SEC). These funds are required to publish their daily Net Asset Value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of Net Realizable Value (NRV) or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **Note 5: Group Annuity Contract with Insurance Company**

The Plan holds a traditional fully benefit responsive guaranteed investment contract with the Standard Insurance Company (SIC) with a contract value of \$2,475,407 and \$2,611,126 as of December 31, 2024 and 2023, respectively. SIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1% per annum. The crediting rate is reviewed on a quarterly basis for resetting.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by SIC, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) termination of the contract, (2) spin-offs, (3) divestures, (4) layoffs, (5) corporate relocation, (6) partial or total plan termination, (7) retirement incentive programs, and (8) the liberalization of plan withdrawal or transfer rules.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan with written notice 30 days in advance and settle at an amount different from contract value. Examples of such events include (1) plan sponsor's failure to abide to state or federal law, (2) failure to render performance necessary to comply with the terms of the contract, (3) failure to maintain assets of at least \$25,000, (4) plan disqualification, and (5) failure to adopt the Plan in a reasonable period of time.

#### **Note 6: Plan Termination**

Although they have not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their employer contributions. If the Plan terminates, benefits provided under this Plan are neither insured nor guaranteed by the Company, by the Pension Benefit Guaranty Corporation, a federal governmental agency, nor under any state or federal law.

#### **Note 7: Tax Status**

The prototype plan obtained a determination letter on June 30, 2020, in which the Internal Revenue Service stated that the prototype plan is qualified under section 401(a) of the Internal Revenue Code (the Code). Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirement of the Code and therefore believes that the Plan is qualified, and the related trust was tax exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by tax jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.

#### **Note 8: Risk and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **Note 9: Related Party and Party in Interest Transactions**

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan. The Plan issues notes to participants which are secured by the vested balances in the participants' accounts, therefore these transactions qualify as party in interest transactions; a statutory exception exemption exists.

Certain administrative fees related to the administration of the Plan were paid by the Plan to Standard Retirement Services, the Plan's third-party administrator and Pensionmark Financial Group, LLC, the Plan's investment advisor. These transactions qualify as party in interest transactions, for which a statutory exception exemption exist.

For the year ended December 31, 2024, the Plan paid \$108,413 in fees for services provided by party in interest service providers, of which \$54,064 was paid to the Plan's third-party administrator and \$54,349 was paid to the Plan's investment advisors.

The Plan invests in a group annuity contract that is issued by the Standard Insurance Company, a known party in interest. See Note 5 on the group annuity contract.

#### **Note 10: Corrective Distributions Payable**

During the years ended December 31, 2023 and 2022, the Plan failed its annual compliance testing and as a result incurred excess employer safe harbor matching contributions. These funds were withdrawn from affected participant accounts and were held by the Plan to reduce subsequent employer contributions. During the year ended December 31, 2024, excess employer safe harbor match contributions identified during compliance testing amounting to \$18 were withdrawn from affected participant accounts and were held by the Plan to reduce subsequent employer contributions. As of December 31, 2024 and 2023, \$34,062 and \$34,044, respectively, remain to be used by the Plan to reduce subsequent employer contributions and are recorded as corrective distributions payable in the accompanying statements of net assets available for benefits.
