Benefit accruals ceased in 2002 and employees who commenced employment after 2002 are not eligible.

**Normal Retirement Date:** The Normal Retirement Date is the first day of the month coincident with or immediately following the later of the Participant's 65<sup>th</sup> birthday or the 5<sup>th</sup> anniversary of Plan participation.

**Early Retirement Date:** The Early Retirement Date is the first day of any month coincident with or immediately following the later of the Participant's 55<sup>th</sup> birthday and 10 Years of Service.

**Normal Retirement Benefit:** A Participant who retires on his Normal Retirement Date will be entitled to a monthly retirement income commencing on his Normal Retirement Date and payable for his lifetime with 50% to his spouse upon his death. If the participant is not married, the benefit is payable for 10 years certain and then for his lifetime thereafter. The amount of such retirement income will be equal to the Participant's accrued benefit as of December 31, 2002.

**Early Retirement Benefit:** The accrued benefit reduced by 1/15<sup>th</sup> for each of the first 5 years the payment of benefits commences prior to Normal Retirement Date and 1/30<sup>th</sup> for each of the next 5 years.

**Death Benefit:** In the event of a Participant's death, his beneficiary will be entitled to receive the greater of the actuarial equivalent of the Participant's Accrued Benefit at date of death or the qualified pre-retirement survivor's annuity benefit.

**Disability Benefit:** In the event of a Participant's disablement prior to his eligibility for Normal Retirement Benefits, he will be entitled to the actuarial equivalent of his Accrued Benefit at date of disability.
