Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Gallup Retirement and Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

The information included in the supplementary information, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplementary information that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplementary information, we evaluated whether the supplementary information, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Plan Description

The following description of the Gallup Retirement and Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established to provide retirement benefits for the employees of Gallup, Inc. (the Company).

Professional employees and interviewers are eligible for participation on the first day of the month following their date of hire, provided they have reached their 18th birthday. Both professional employees and interviewers are eligible to receive discretionary matching contributions and discretionary profit-sharing contributions if they are employed on the last day of the Plan year and complete at least 1,000 hours with the Company during the year. For the years ended December 31, 2024 and 2023, the discretionary matching contributions, net of forfeitures, were \$3,283,648 and \$3,176,463, respectively. The Gallup 401(k) Advisory Committee is responsible for oversight of the Plan, which includes determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

Funds

The Plan includes two funds: the Participant-Directed 401(k) Salary Reduction Fund and the Employer-Directed Fund. Under the terms of the 401(k) Plan, employees may contribute from 1% to 100% of their eligible compensation as either pre-tax or Roth after-tax salary deferral contributions, provided they do not exceed certain Internal Revenue Service (IRS) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants also may rollover amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants may direct their contributions to one or more mutual funds and collective trusts, or liquidate a portion of their investments and utilize such proceeds to purchase the Company's common stock. Participants also may select investment options outside of the Plan through the Plan's self-directed brokerage account.

All eligible employees are automatically enrolled in the Plan at a deferral rate of 6% of eligible compensation. At any time, a participant can elect not to contribute or may increase or decrease their deferral rate. If the participant does not choose a different contribution rate (including zero), the deferral rate is automatically increased on each anniversary of the participant's entry date by 2% up to a maximum deferral rate of 14%.

For the years ended December 31, 2024 and 2023, the board of directors of the Company authorized a discretionary matching contribution of up to 50% of the employee contribution up to a maximum of \$5,000. The Company may make discretionary profit-sharing contributions in addition to the matching contribution at the discretion of the board of directors, although no such contributions were made in 2024 and 2023.

Participants may direct their contributions to one or more mutual funds and collective trusts, or liquidate a portion of their investments and utilize such proceeds to purchase the Company's common stock. Effective March 2023, participants may utilize their Company discretionary contributions to purchase the Company's common stock. Participants also may select investment options outside of the Plan through the Plan's self-directed brokerage account.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's discretionary matching contributions and discretionary profit-sharing contributions and (b) Plan earnings, and is charged with an allocation of administrative expenses. The Company's discretionary matching contributions are allocated among participants based upon each participant's elected salary deferral. The Company's discretionary profit-sharing contributions are allocated among participants based upon eligible compensation of participants. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Investments are maintained in individual member accounts managed by Vanguard Fiduciary Trust Company (Vanguard).

Vesting

Participants are vested immediately in their contributions, plus actual earnings thereon. Participants are vested immediately in the Company's discretionary matching contributions and discretionary profit-sharing contributions.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are made on a non-discriminatory basis and are secured by the participant's account. Interest rates are established at current market rates at the time of issuance and range from 4.25% to 9.50% as of December 31, 2024 and 2023. Principal and interest rates are paid ratably through monthly payroll deductions.

Payment of Benefits

Upon termination of service due to retirement, disability, or death, the participant or beneficiary may elect to receive either a lump-sum distribution or installment payments equal to the value of the participant's vested interest in the participant's account. For termination of service for other reasons, a participant may receive the value of the vested interest in the participant's account as a lump-sum distribution. Plan participants are eligible for normal retirement at age 65 but may elect to retire at a later date. Upon attainment of 65 years of age, death, or determination of disability, a participant becomes 100% vested regardless of the number of credited years of service completed. The Plan requires that distribution payments between \$1,000 and \$7,000 (\$5,000 prior to January 1, 2024) be directly rolled over to an individual retirement account and distributions under \$1,000 will be paid out directly to the participant.

Forfeitures

Non-vested Company contributions of terminated participants become forfeitures of the Plan. Forfeitures are valued as of the day the participant is terminated from the Plan. Forfeitures remain in the Plan and will be used to pay administrative expenses or to reduce the Company's discretionary matching contributions and discretionary profit-sharing contributions. During 2024 and 2023, approximately \$188,000 and \$149,000, respectively, of forfeited amounts were used to reduce employer contributions receivable. As of December 31, 2024 and 2023, forfeited non-vested accounts were approximately \$54,000 and \$51,000, respectively.

2. Summary of Significant Accounting Policies

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting and in conformity with accounting principles generally accepted in the United States of America.

Presentation of Participant-Directed Funds

The Plan's presentation of participant-directed investments is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, *Plan Accounting-Defined Contribution Pension Plans*.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the investment advisors, custodian, trustee and insurance company. See Note 4 for further discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document.

Payment of Benefits

Benefit payments are recorded when paid.

Payment of Administrative Expenses

Certain administrative expenses have been paid by the Company. The Plan's financial statements reflect only those administrative expenses that have been paid from assets of the Plan.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through October 8, 2025, noting no items requiring disclosure.

3. Information Certified by Vanguard

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Vanguard, except for comparing such information certified by the custodian and the trustee to information included in the Plan's financial statements and supplementary information.

4. Fair Value Measurements

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual Funds: The funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at the price. The funds held by the Plan are deemed to be actively traded.

Self-Directed Brokerage Accounts: The self-directed brokerage accounts include investments in money market funds, mutual funds, and common stocks. The money market funds, mutual funds, and common stocks are valued at the closing price reported on the active market on which the individual securities are traded.

Common Collective Trusts: Valued at NAV as provided by the trustee. FASB ASC 820, *Fair Value Measurement*, allows NAV to serve as a practical expedient to estimate the fair value as long as certain requirements are met. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the trusts will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trusts, the investment advisor reserves the right to temporarily delay withdrawal from the trusts in order to ensure that securities liquidations will be carried out in an orderly business manner. There are no unfunded commitments as of December 31, 2024 and 2023.

Gallup, Inc. Common Stock: Valued at estimated fair value based upon an independent appraisal. As a private company, the Company's shares are not freely traded. The share price is valued annually with the price determined by an independent third-party appraisal and transactions are completed at the determined share price. This appraisal was based upon a combination of market and income valuation techniques. The appraiser took into account historical and projected cash flow and net income, revenues, market comparables and estimated fair value of the Company's assets and liabilities.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Tax Status

The Plan is qualified as a profit sharing plan under Section 401(a) of the Internal Revenue Code and is exempt from federal income taxation under Section 501(a) of the Internal Revenue Code.

The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.
