NOTE A - DESCRIPTION OF THE PLAN

The following description of the Follett Retirement Savings Plan ("Plan") provides only general information. Participants or other interested parties should refer to the plan document for a more complete description of the Plan's provisions.

1. General

The Plan is a defined contribution and profit sharing 401(k) plan covering eligible employees of Follett Higher Education Group, LLC (formerly Follett Corporation), and its subsidiaries as participating employers (collectively, "Company" or "Plan Administrator"). The Plan was established on April 1, 1985 for the purpose of permitting eligible employees to defer a portion of their compensation and to provide retirement benefits for eligible employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

2. Eligibility

The Plan is available to all full-time, part-time, and temporary employees of the Company. New associates are eligible to make employee contributions to the Plan and receive safe harbor matching and discretionary matching contributions beginning the first day of the month following their date of hire.

All full-time, part-time, and temporary employees are eligible for discretionary profit sharing contributions if they have met the following eligibility requirements: (i) employed as an employee on December 31 of the Plan year for which the contribution is being made, (ii) accumulated at least 1,000 hours of service during that Plan year, (iii) not be eligible for, or a participant in, a management bonus incentive plan, retail bonus incentive plan, or sales commission or sales bonus incentive on the last day of the Plan year, and (iv) not be a highly compensated employee.

3. Contributions

The Plan is funded by voluntary contributions of participants, required safe harbor matching contributions, discretionary matching contributions and discretionary profit sharing contributions of the Company. Participants may contribute to the Plan, through regular payroll deductions, and participants who have attained age 50 before the end of the calendar year are eligible to make catch-up contributions. Participants may also roll over amounts representing distributions from other qualified employee benefit plans.

3. Contributions (Continued)

Participants may contribute a percentage of eligible earnings to the Plan, subject to limitations imposed by the Internal Revenue Code. Each pay period, safe harbor matching contributions are made by the Company up to 100% of the first 4% of each participant's eligible earnings contributed to the Plan. Company safe harbor matching contributions totaled \$3,848,418 and \$3,988,236 for the years ended December 31, 2024 and 2023, respectively. Discretionary profit sharing contributions made by the Company are determined on an annual basis and are subject to certain limitations imposed by the Internal Revenue Code. There were no discretionary profit sharing contributions for the year ended December 31, 2024. The Company provided \$822,043 of discretionary profit sharing contributions for the Plan year ended December 31, 2023. The Company made no discretionary matching contributions for the Plan years ended December 31, 2024 and 2023.

4. Investment Options

Participants direct their salary deferral contributions and the Company's contributions into a variety of selected investment options, including a participant-directed brokerage account, as made available and determined by the Administrative Committee. Participants may change their investment options any time.

5. Participant Accounts

Each participant's account is credited with the participant's contribution, an allocation of the Company's contributions, and an allocation of plan earnings. The Company's discretionary and safe harbor matching contributions are allocated based on a percentage of the participant's contribution. In the case when discretionary profit sharing contributions are made, all eligible participant accounts are credited contributions as a flat dollar amount. Plan earnings are allocated to participants' accounts in direct proportion to their respective account balances, based on the performance of participants' investment selections. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

6. Vesting

Participants are immediately 100% vested in participant and rollover contributions as well as employer discretionary matching and safe harbor matching contributions plus earnings thereon, if any.

6. Vesting (Continued)

Participants are 100% vested in the Company's discretionary profit sharing contributions after three years of vested service in which the participant worked at least 1,000 hours. In the event of death, disability, or retirement at designated ages, participants become fully vested.

7. Payment of Benefits

Upon termination of service, a participant or their beneficiary is entitled to receive an amount equal to the entire value or a partial value of the participant's vested account balance in the form of a lump-sum or installment distribution. Alternatively, the funds, if greater than \$5,000, may be left in the Plan until the participant reaches age 70 ½. In the event of a participant's death, the beneficiary must take a distribution no later than the fifth anniversary of the participant's death.

In addition to a loan, eligible participants can withdraw funds (funds are comprised of rollover dollars, participant contributions to the Plan, Company discretionary matching contributions, safe harbor matching contributions, and discretionary profit sharing contributions) from their account using one of the following three options:

- (i) In-service withdrawal - allows participants over 59 ½ to withdraw all vested funds. Withdrawals for participants under 59 ½ are limited to rollover dollars contributed to the Plan.
- (ii) Special in-service withdrawal - allows a participant to withdraw up to 60% of the vested profit sharing contribution to purchase a primary residence.
- (iii) Hardship withdrawal - only allowed for the following seven purposes: 1) to purchase a primary residence, 2) to prevent eviction or foreclosure on a primary residence, 3) to pay for post-secondary education expenses, 4) to pay for unreimbursed medical expenses, 5) to pay for funeral or burial expenses of a parent, spouse, child or other dependent, 6) to pay for repair of catastrophic property damage to the participant's principal residence, or 7) to pay for expenses and losses (including loss of income) incurred because of a natural disaster declared by the Federal Emergency Management Agency ("FEMA") if the participant's principal place of employment at the time was located in an area designated by FEMA for individual assistance. The hardship withdrawal provisions of the Plan allow a participant to receive a hardship distribution based on the financial hardship of the participant's beneficiary even if the beneficiary is not the participant's spouse or dependent.

8. Notes Receivable from Participants

Notes receivable from participants are measured at unpaid principal balance plus any accrued but unpaid interest. Participants may borrow up to the lesser of \$50,000 or 50% of their vested account balances, with a minimum loan amount of \$1,000. The loans are collateralized by the borrowers' respective vested account balances and bear interest at rates ranging from 3.25% to 9.50%. Principal and interest are paid through payroll deductions over a period not to exceed five years, unless for the purchase of a primary residence.

9. Administrative Expenses

Certain expenses incurred maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments.

10. Forfeitures

At December 31, 2024 and 2023, unallocated plan assets resulting from forfeited nonvested accounts were insignificant. These accounts will be used to reduce future Company contributions or pay the Plan's administrative expenses. Forfeitures of \$5,251 and \$126,839 were used to reduce Company contributions related to the Plan years ended December 31, 2024 and 2023, respectively.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting. The Plan recognizes employee contributions and the related employer matching contributions in the period the employee contribution is withheld.

2. Fair Value Measurements

Current accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted market prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include the following:

- \* Quoted prices for similar assets or liabilities in active markets;
- \* Quoted prices for identical or similar assets or liabilities in inactive markets;
- \* Inputs other than quoted prices that are observable for the asset or liability; and
- \* Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for the Plan's investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded (Level 1).

*Participant-directed brokerage account assets:* Accounts primarily consist of mutual funds, common stocks, and exchange-traded funds that are valued on the basis of readily determinable market prices.

*Common collective trusts:* Valued based on the NAV of units of the common/collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimating fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the common collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

*Stable value collective trust fund:* A stable value fund that is composed primarily of fully benefit-responsive investment contracts that is valued at the NAV of units of the bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

3. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the custodian. See Note B-2 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income on notes receivable from participants is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

4. Use of Estimates

In preparing the Plan's financial statements, management is required to make estimates and assumptions that affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

5. Payment of Benefits

Benefits are recorded when paid.

NOTE C - INFORMATION CERTIFIED BY T. ROWE PRICE TRUST COMPANY

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by T. Rowe Price Trust Company, a qualified institution (the trustee of the Plan).

NOTE D - TAX STATUS

The Plan adopted a nonstandardized pre-approved plan sponsored by the trustee. The pre-approved plan has received an opinion letter from the Internal Revenue Service as to the pre-approved plan's qualified status. The pre-approved plan opinion letter has been relied upon by this Plan. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE E - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants become fully vested in their respective account balances.

NOTE F - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE G - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Plan investments are managed and recordkeeping services are provided by the trustee; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each investment.

The Plan issues loans to participants, which are secured by the vested balance in the participant's accounts, and certain administrative fees related to the administration of the Plan were paid by the Plan or by the Company. These transactions qualify as party-in-interest. Employees of the Company provide administrative services to the Plan for which no fees are charged.

NOTE H - PLAN AMENDMENTS AND RESTATEMENT AND SUBSEQUENT EVENTS

Effective November 6, 2024, the Plan was amended to remove Advances Graphic Products, Inc. as a participating Employer in the Plan.

Effective December 21, 2024, the Plan was amended to remove Willo Labs, Inc. as a participating Employer in the Plan.

Significant provisions of the amended and restated plan document are consistent with those of the current plan document. Interested parties should refer to the plan document for a more complete description of the Plan's provisions.

NOTE I - SUBSEQUENT EVENTS

Plan management has evaluated subsequent events through October 8, 2025, the date that these financial statements were available to be issued. Plan management has determined that no events or transactions have occurred subsequent to the statement of net assets available for benefits date that require disclosure in the financial statements.
