Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of RestorixHealth 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Emphasis of Matter

As discussed in Note 1 to the financial statements, RestorixHealth, the Plan sponsor, downsized its operations during the 2024 Plan year, which resulted in a partial plan termination during 2024. Our disclaimer of opinion has not been modified with respect to this matter.

Other Matter—Supplemental Schedules Required by ERISA

The supplemental schedule of delinquent participant contributions for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements, or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

Notes to Financial Statements

Note 1. Description of Plan

The following description of the RestorixHealth 401(k) Plan (the Plan) provides only general information. Participants should refer to the prototype Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan established January 1, 2002, for the benefit of covering all eligible employees, as defined, of Hyperbaric Medical Associates, P.C., New York Hyperbaric and Wound Care Centers, L.L.C. (the Plan Sponsor), a wholly owned subsidiary of The Center for Wound Healing, Inc., who meet certain age requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). John Hancock Retirement Plan Services LLC (the Recordkeeper) is the Plan's record keeper and John Hancock Trust Company LLC (the Custodian) if the Plan's custodian.

Eligibility: All employees of the Plan Sponsor who have met the minimum eligibility requirement of attaining the age of 21 are eligible to participate in the Plan. Employees covered by collective bargaining agreements, nonresident aliens, residents of Puerto Rico, leased employees and certain part-time employees, as defined, are not eligible to participate in the Plan.

Contributions: If a newly eligible participant does not make an election on a written salary reduction agreement within 45 days from the hire date, such participant will be automatically enrolled in the Plan at a 4% elective deferral rate. Automatically enrolled participants' deferral rate will increase by 1% each plan year until reaching 6%. Each participant may elect to contribute up to 100% of his or her annual compensation to the Plan, not to exceed the annual dollar limit provided under the Internal Revenue Code (IRC).

The Plan Sponsor may elect to make a matching contribution equal to a discretionary percentage of participants' elective deferrals, to be determined by the employer. The Plan Sponsor elected to make matching contributions effective January 1, 2022, at the rate of \$0.50 for every \$1 contributed up to 6% of compensation.

The Plan Sponsor may also make discretionary profit sharing contributions to the Plan to be credited to the participants' accounts based on a percentage of their pay. During the year ended December 31, 2024, the Plan Sponsor did not make any discretionary profit sharing contributions into the Plan.

Payment of benefits: Distributions are made to participants upon termination of service or, if the participant chooses, upon reaching age 59½. Withdrawals from the Plan may also be made upon circumstances of financial hardship in accordance with provisions specified in the Plan. Benefits provided by the Plan are not insured by the Pension Benefit Guaranty Corporation because the insurance provisions are not applicable to defined contribution plans.

Participant accounts: Each participant's account is credited with the participant's contributions and an allocation of the Plan's earnings or losses. Plan earnings are allocated based on account balances. Each participant's account is updated on a daily basis to reflect any investment gains or losses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Participants' investment options: Participants must direct their salary deferral contributions to selected investments as made available by the Plan Sponsor. Participants may change their investment options at any time throughout the year.

Note 1. Description of Plan (Continued)

Vesting: Participants are vested immediately in their contributions plus actual earnings thereon. The vesting in employer discretionary contributions, if any, is based on years of service as follows:

3 years but less than 4	60%

Notwithstanding the foregoing, the vesting schedule for former participants in the Gordian Medical Inc. 401(k) Profit Sharing Plan (see Note 1) with respect to the accounts subject to vesting accrued in such plan shall be as follows:

Forfeitures: Forfeitures relate to nonvested employer discretionary contributions to which the participant is not entitled. At December 31, 2024 and 2023, the forfeited nonvested account balances totaled approximately \$306,000 and \$58,000, respectively. During the year ended December 31, 2024, approximately \$31,000 of forfeited nonvested account balances were used to pay Plan administrative expenses and approximately \$1,000 of forfeited nonvested account balances were used to reduce employer contributions.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. There is a limit of two outstanding loans at any given time. Loan terms range from one to five years; however, terms may exceed five years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator. At December 31, 2024 and 2023, notes receivable from participants bear interest at rates ranging from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

Administrative expenses: All expenses related to administering the Plan may be paid from the Plan unless paid by the Plan Sponsor. Such expenses may include, but are not limited to, fees for accountants, counsel and other costs of administering the Plan. The Plan Sponsor may reimburse the Plan for any administrative expenses incurred.

Note 1. Description of Plan (Continued)

Partial Plan termination: In 2024, the Plan Sponsor downsized its operations, which resulted in a partial Plan termination. This affected 245 Plan participants, and these participants held \$5,514,000 of assets in the Plan at December 31, 2024. Of the affected participants, 123 participants took distributions from the Plan of approximately \$3,626,000 in the current year. All participants affected by the partial Plan termination became fully vested in their accounts.

Note 2. Summary of Significant Accounting Policies

The following are the significant accounting policies followed by the Plan:

Basis of accounting: The Plan's financial statements have been prepared on the accrual basis of accounting.

Valuation of investments and income recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Contributions: Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which participant compensation is earned.

Payment of benefits: Benefits are recorded when paid.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are treated as distributions based on the terms of the Plan documents.

Subsequent events: The Plan Administrator has evaluated subsequent events for potential recognition and or disclosure through October 3, 2025, the date the financial statements were available to be issued.

Note 3. Information Certified by the Custodian

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Mutual funds are valued at quoted market prices. These securities are categorized in Level 1 as they are actively traded.

Collective investment trust: Investments in the John Hancock Stable Value Fund are stated at the estimated fair value based on the fair value of the underlying assets at net asset value (NAV) of the fund as based on information reported in the fund's audited financial statements at year-end.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes that its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine the fair value of certain instruments could result in a different fair value measurement at the reporting date.

(b) The John Hancock Stable Value Fund is a collective trust that seeks to preserve principal and provide contract value liquidity on a daily basis for plan-permitted, participant-directed withdrawals while maintaining a competitive rate of interest. The collective trust invests primarily in diversified fixed income investments and in stabilizing agreements.

Note 5. Tax Status

The Plan has adopted a preapproved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since adopting the preapproved plan document; however, The Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC.

Financial Accounting Standards Board guidance requires the evaluation of tax positions taken or expected to be taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan terminates, participants will become 100% vested in their accounts.

Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8. Exempt Party-In-Interest Transactions

The Plan's collective investment trust is managed by an affiliate of the Custodian and, therefore, qualifies as a permitted party in interest, as defined by ERISA. Most administrative expenses are paid by the Plan Sponsor.

Note 9. Prohibited Transactions

During 2023 and 2022, the Plan Sponsor inadvertently failed to deposit \$49,854 and \$321,033, respectively, of participant contributions and loan repayments within the required time frame as stated by DOL's regulations. The Plan Sponsor has deposited lost earnings to correct \$25,966 of the 2022 failure in 2023 and \$295,067 of the 2022 failure in 2024 from the Plan Sponsor's assets. The Plan Sponsor has deposited lost earnings to correct the 2023 failure in 2024 from the Plan Sponsor's assets.
