## Independent Auditors' Report

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Employees' Incentive Savings Plan of Emigrant Bank (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control-related matters that we identified during the audit.

## 1. Description of Plan

The following brief description of the Employees' Incentive Savings Plan of Emigrant Bank, as amended, (the Plan) is provided for general information purposes only. Participants should refer to the plan document for more complete information.

### General

The Plan is a multiple employer defined contribution plan sponsored by Emigrant Bank, formerly known as Emigrant Savings Bank and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan offers an opportunity for employees to establish a personal savings and investment plan with tax advantages. All salaried employees of the wholly owned banks of Emigrant Bancorp, Inc. (collectively the participating employers in the Plan are referred to as the Bank) are eligible to participate in the Plan. Employee contributions and Bank matching contributions are invested in mutual funds and U.S. treasury cash reserves for the benefit of the participants. The primary intention of the Plan is to provide additional income to employees at retirement or termination of employment with the Bank.

The Plan's Committee of Fiduciaries is responsible for the oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Board of Directors.

### Participating Employers

The Plan provides for participation by companies outside the controlled group of Emigrant Bank. Each participating employer is required to use the same trustee as provided by the Plan. The assets of the Plan are available to pay benefits to all participants under the Plan without regard to the employer or participating employer who contributed such assets. The transfer of any participant among any participating employers does not affect the rights of the participant under the Plan. All contributions made by participating employers are determined separately by each participating employer and are allocated only among the eligible participants of the participating employer making the contribution.

### Employee Eligibility and Contributions

Each salaried and commissioned employee of the Bank may elect to participate in the Plan beginning the first of the month following 30 days of employment. If an employee is compensated on a basis other than salary and/or commissions (e.g., on a daily, fee, hourly or retainer basis), the employee will meet the service requirement for all types of contributions after a one-year period of service (i.e., generally, as of the first anniversary of the date of hire).

Effective January 1, 2008, the Plan was converted to a 401(k) Safe Harbor Plan. The new plan includes the following enhanced features: (a) participants may contribute up to 100% of their pre-tax compensation not to exceed limits set by the Internal Revenue Code (IRC), (b) the Bank will match (safe harbor matching) 100% of the first 4% of the participant's basic compensation, (c) past matching contributions were vested 100% effective on January 1, 2008 and (d) future matching contributions will be vested immediately.

Participants may also rollover amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Bank is required to make safe harbor matching contributions using the formula designated in the plan document. These safe harbor matching contributions are required to be made to employees who have deferred into the Plan and have met the eligibility requirements to receive the contribution. Safe harbor matching contributions are funded to the Plan each pay period, however, the safe harbor matching contributions are determined based on the entire plan year as designated in the plan document. After year end, the Plan's recordkeeper prepares a match verification report, which compares the calculated annual safe harbor matching contributions for each participant to the actual safe harbor match contributions reported. The intent of this report is to identify any participants who are owed a true-up contribution or received excess safe harbor matching contributions.

### **Employee Vesting**

Contributions made by participants, the Bank and amounts credited to participants' safe harbor matching contributions account, if any, are 100% vested.

### **Withdrawals**

Upon termination of employment, participants may withdraw the vested portion of the value of their account. Participants are permitted to rollover account balances above \$1,000 into an Individual Retirement Account. If a terminated participant's vested balance is less than or equal to \$7,000, the amount may be automatically distributed in the form of lump sum cash payment.

Employees may make withdrawals of after-tax contributions once every calendar quarter. Such withdrawals may be subject to penalties. No withdrawals are permitted to employees on their before-tax contributions before age 59½, except certain legally defined hardship withdrawals.

### **Notes Receivable From Participants**

Participants may borrow against up to 50% of the value of their vested account balance, not less than \$1,000 and not to exceed \$50,000. Loans are secured by the participant's vested interest in the Plan and bear interest at rates set forth by the Bank that range from 2.38% to 9.50% at December 31, 2024. Participants are permitted to have up to two loans outstanding under the Plan at any time. The loan is generally to be repaid for any period up to five years. However, if the loan is used for the purpose of acquiring a dwelling to be used as a primary residence, the loan is then to be repaid for any period up to twenty years.

### **Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of (a) the Bank's contribution and (b) the Plan's earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## **2. Summary of Significant Accounting Policies**

### **Basis of Presentation**

The financial statements have been prepared on the accrual basis of accounting.

### **Use of Estimates**

The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### **Investment Management**

Newport Trust Company (a subsidiary of Ascensus) is the trustee of the Plan and Charles Schwab Bank is the sub-custodian of the plan. Newport Trust Company manages the Plan assets on behalf of the Plan. The Plan investments and changes therein have been reported to the Committee of Fiduciaries by the Newport Trust Company.

## Investment Valuation and Related Investment Income

The investments in which the Plan participates are reported at fair value based on their reported net asset value (NAV) as determined by the trustee. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Committee of Fiduciaries determines that Plan's valuation policies utilizing information provided by the trustee. See Note 7 for a discussion of fair value measurements.

Interest income is recorded on the accrual basis, and dividend income is recorded on the ex-dividend date. Purchases and sales of investments are recorded on a trade date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

## Payment of Benefits

Benefits to participants or their beneficiaries are recorded when paid.

## Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

## Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Bank. Expenses that are paid by the Bank are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of mutual funds.

## Recent Regulatory Update

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the year ended December 31, 2024, and continues to evaluate the impact of the adoption and implementation of this legislation on the Plan. The application of SECURE 2.0 Act did not have a material effect on the Plan's financial statements.

## 3. Plan Termination

Although the Bank has not expressed any intent to do so, the Bank has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

## 4. Information Certified by the Trustee

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Newport Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of all investments, including notes receivable from participants, reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reported in the Statements of Changes in Net Assets Available for Benefits for the years ended December 31, 2024 and 2023. Such information was obtained by management and agreed to or derived from information certified as complete and accurate by a qualified institution.

## 5. Tax Status

The Bank received a determination letter dated May 4, 2004 from the Internal Revenue Service (IRS) that stated the Plan and related trust, as then designed, were in compliance with applicable requirements of the IRC. On October 26, 2012 and September 30, 2013, the Plan received a determination letter from the IRS, which approved several additional amendments. Although the Plan has been amended since receiving these letters, in the opinion of the Committee of Fiduciaries, the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC, and therefore, is exempt from taxes.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## 6. Related-Party and Party in Interest Transactions

The Plan invests in shares of mutual funds and U.S. Treasury Cash Reserves managed by an affiliate of Newport Trust Company. Newport Trust Company acts as trustee for only those investments as defined by the Plan. Additionally, the Plan issues loans to participants, which are secured by the participants' account balances. These transactions qualify as party in interest transactions, which are exempt from prohibited transaction rules. Certain administrative functions of the Plan are performed by officers or employees of the Bank. No such officer or employee receives compensation from the Plan.

## 7. Fair Value Measurements

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction (not a forced or distress transaction) between market participants at the measurement date. Fair value is a market based measurement incorporating assumptions that independent, knowledgeable market participants would use, including assumptions about risk; and considers attributes specific to the asset or liability. The measurement of fair value assumes the transaction occurs in the principal (or most advantageous) market for the asset or liability.

The degree of judgment utilized in measuring the fair value of financial instruments is generally inversely related to the level of pricing observability. Financial instruments with readily available quotes in active markets or for which fair value can be measured based on other observable market inputs generally have more pricing observability and less judgment is required in measuring fair value. Conversely, financial instruments that are not quoted or infrequently traded have less observability and are measured at fair value using valuation processes that are based on unobservable inputs and thus require more judgment. When measuring the fair value of financial instruments, management seeks to maximize the use of observable market inputs and minimize the use of unobservable inputs. Illiquid credit markets have resulted in inactive (or less active) markets for certain financial instruments; as a result the level of observable inputs for certain instruments may have decreased, necessitating an increased use of unobservable inputs.

Investment securities recorded at fair value in the Plan's Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023 are categorized based upon the level of judgment associated with the inputs used to measure fair value. A description of the disclosure hierarchy established and the types of financial instruments recorded at fair value that the Committee of Fiduciaries believes would generally qualify for each category is as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date. Financial instruments in this level would generally include mutual funds and U.S. Treasury funds that are readily redeemable at their published NAV.

Level 2 - Inputs to the valuation methodology, other than quoted prices or published NAVs included in Level 1, are either directly or indirectly observable for the asset or liability for substantially the full term of the instrument. Such inputs may include quoted prices for similar instruments in an active market; quoted prices for the identical or similar instrument in an inactive (or less active) market; other observable inputs such as yield curves, prepayment speeds or credit spreads; or other inputs that are derived from or corroborated by observable market data.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A description of the methods, factors and significant assumptions utilized in estimating the fair values for significant categories of financial instruments follows. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual funds are valued at the published NAV of units held by the Plan on the measurement date. In the unlikely event a NAV was not published on the measurement date, reference would be made to an indicative bid or the published NAV most proximate to the measurement date. Participants can redeem their funds based on the policies set forth in the funds' prospectus.

U.S. Treasury Cash Reserves are carried at cost which approximates fair value.

### 8. Risk and Uncertainties

The Plan invests in a variety of funds. The funds include mutual funds and U.S. Treasury Cash Reserves. Investment securities, in general, are exposed to various risks, such as interest rate, credit, liquidity and overall market volatility risk. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

The Plan's exposure to risk is limited by the diversification of investments across the numerous participant directed funds. Additionally, the investments within each participant directed fund are further diversified into varied financial instruments.

As of December 31, 2024 and 2023, the Plan had investments of \$48,123,508 and \$41,726,354, respectively, that were concentrated in two funds.

### **9. Administration of Plan Assets**

The Plan's assets are administered under a contract with Newport Trust Company, the trustee of the Plan. The trustee invests funds received from contributions, investment sales, interest and dividend income and makes distribution payments to participants.

### **10. Subsequent Events**

The Plan has evaluated whether any subsequent events that require recognition or disclosure in the accompanying financial statements and notes thereto have taken place through October 13, 2025, the date these financial statements were available to be issued.
