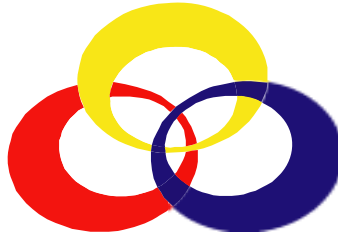

The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedules Required by ERISA

The supplemental schedule of assets held at end of year and schedule of reportable transactions for the year ended December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1 Description of Plan

The following description of the Willow Health Care, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a single-employer, voluntary, defined contribution plan sponsored by Willow Health Care, Inc. covering all employees who have attained the age of 18. The Plan excludes employees who are not eligible based on a written agreement, employees who work only if needed, and residents of Puerto Rico. Benefits cannot be based on a collective bargaining agreement. The Plan was originally established effective as of October 1, 1997. The Plan was most recently restated effective January 1, 2022 to bring the plan into compliance with legislative and regulatory changes. The Plan was amended effective January 1, 2022 to implement hardship distribution provisions of the Bipartisan Budget Act of 2018. A second amendment to remove the automatic contribution arrangement became effective 3-1-2022. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Reliance Trust Company is a trustee of the Plan.

Contributions

Each year, participants may contribute up to 100% of annual compensation as a pretax deferral or Roth deferral, as defined in the Plan. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. Effective March 1, 2022, the Plan no longer includes an auto-enrollment provision. Plan entry dates are the first day of the month following meeting eligibility requirements. Participants determine if they choose to enroll in the plan on their first day of employment or if they want to opt out of the Plan. Participants may change their deferral amounts or allocations at any time or elect to decline participation by contacting Human Resources.

Employer non-safe harbor matching contributions as well as profit sharing contributions are discretionary. Non-safe harbor matching contributions cannot exceed 10% of compensation. In order to receive the profit-sharing contributions, employees are required to work at least 1000 hours of service per year and must be employed as of the last day of the plan year. For the years ended December 31, 2024 and 2023, the employer elected not to make a non-safe harbor matching contribution or a profit-sharing contribution.

Participants direct the investment of all contributions in various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations. Retirement Trust Company holds all the Plan's investments.

Participant Accounts

Each participant's account is credited with the participant's contribution, employer non-safe harbor matching contributions, discretionary matching profit-sharing contribution as well as allocations of Plan earnings or losses. Participant accounts are charged with an allocation of certain administrative

expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus earnings. Vesting in the employer non-safe harbor matching contributions and discretionary profit-sharing contributions portion of their accounts plus actual earnings thereon, is based on years of credited service and is determined as follows. A year of service is defined as 1000 hours of service.

Notes Receivable from Participants

The Plan does not allow participants to borrow from their vested account balance.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant will immediately vest at 100%. Terminated participant may elect to receive the value of the vested interest in his or her account in the form of a lump sum distribution or a partial withdrawal. The Plan allows for in-service distributions if a participant reaches age 59 ½; however, normal retirement age is 65. Hardship distributions are subject to Plan provisions.

Plan Administration

Plan assets are managed by Reliance Trust Company, the custodian, who is a party-in-interest.

Forfeited Accounts

Generally, when a participant terminates participation in the Plan, the non-vested portion of the participant's account, as defined by the Plan, represents a forfeiture. Forfeitures are utilized to reduce the Plan's administrative expenses and then to reduce employer contributions. Forfeitures of profit-sharing contributions are reallocated as an additional profit-sharing contribution. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0 and \$0, respectively. Forfeitures used to reduce plan expenses were \$0 and \$0 during the years ended December 31, 2024 and 2023, respectively.

Note 2 Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with the accrual basis of accounting requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Board determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 4 for discussion of fair value measurements.

Fully benefit-responsive investment contracts are reported at contract value. Contract value represents contributions made under the contract, plus interest at the contract rate, less participant withdrawals and administrative expenses.

Purchases and sales of securities are recorded on a trade-date basis. Dividends and interest income are recorded on the cash basis. The net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Cash

Cash, including cash denominated in foreign currencies, represents cash on hand and demand deposits held at major financial institutions and is subject to credit risk to the extent those balances exceed applicable Federal Deposit Insurance Corporation (FDIC) or Securities Investor Protection Corporation (SIPC) limitations.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company, if any, are excluded from these financial statements. Fiduciary and distribution fees are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments. As of December 31, 2024 and 2023, administrative expenses were \$44,958 and \$47,809 respectively.

Subsequent Events

The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued. No subsequent events have been identified.

Note 3 Certification of Investment Information

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The Annual Trust Statement was provided and certified by the custodian, Reliance Trust Company as of and for the years ended December 31, 2024 and 2023 as complete and accurate.

Note 4 Fair Value of Investments

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under *FASB ASC 820* are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant of the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology the Plan used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 5 Guaranteed Investment Contract

In August of 2010, the Plan entered into a fully benefit-responsive guaranteed investment contract with Standard Insurance Company (Standard). Standard maintains the contributions in its general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. As of December 31, 2024 and 2023, the value of the guaranteed investment contract was \$230,600 and \$204,562, respectively.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented at contract value on the face of the statement of net assets available for benefits. Contract value, as reported to the Plan by Standard, represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than zero percent. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include:

1. Amendments to the Plan documents (including complete or partial Plan termination or merger with another plan),
2. Changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions,
3. Bankruptcy of the Plan Sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan,
4. The failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA,
5. Premature termination of the contract.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines,
2. A breach of material obligation under the contract,
3. A material misrepresentation,
4. A material amendment to the agreement without the consent of the issuer.

Note 6 Risks and Uncertainties

The Plan provides various investment options to its participants. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

The Plan's exposure to a concentration of risk is limited by the diversification of investments across all participant-directed fund elections. Additionally, the investments within each participant-directed fund election are further diversified into varied financial instruments.

Note 7 Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their employer matching

contributions. Any unallocated assets (non-vested forfeiture accounts) of the Plan shall be allocated to participant accounts and distributed in such a manner as the Plan Sponsor may determine.

Note 8 Plan Tax Status

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9 Party-in-Interest Transactions

The plan investments are managed by Reliance Trust Company. Reliance Trust Company is the trustee and custodian for the Plan and, therefore, these transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. Fees paid by the Plan for the investment management services were included as a reduction of the return earned on each fund. During 2024 and 2023, administrative expenses paid by the Plan were \$44,958 and \$47,809 respectively.

Additionally, the Plan Sponsor, Willow Health Care, Inc., is a party-in-interest to the Plan; however, there were only transactions related to the funding of contributions to the Plan.

Note 10 Change in Basis of Accounting

Effective January 1, 2024, the Plan voluntarily changed its basis of accounting from the modified cash basis to the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (GAAP). Under the modified cash basis of accounting, contributions were recorded when received and expenses when paid. Under GAAP, contributions are recognized when due, investment income is recognized when earned, and expenses are recognized when the related liability is incurred.

Management elected to adopt GAAP to provide financial statements that are more consistent with those of other employee benefit plans and to enhance the usefulness of the financial statements to plan participants and other users. The change in basis of accounting has been applied prospectively. Accordingly, the 2023 financial statements, which were prepared on the modified cash basis of accounting, have not been restated.
