## Independent Auditor's Report

To the Plan Administrator and Participants of  
Fisher & Paykel Appliances USA Holdings Inc. Retirement Savings Plan:

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of Fisher & Paykel Appliances USA Holdings Inc. Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Fisher & Paykel Appliances USA Holdings Inc. Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **1. Plan Description**

The following description of the Fisher & Paykel Appliances USA Holdings Inc. Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

a. General

The Plan is a defined contribution savings and profit sharing plan established on August 1, 1997 and restated November 1, 2022 by Fisher & Paykel Appliances USA Holdings Inc. (the "Company") under the provisions of Section 401(a) of the Internal Revenue Code ("IRC"), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

b. Eligibility

Employees of the Company are eligible to participate in the Plan upon employment and reaching the age of 21. Participants enter the Plan on the first day of the month following the date on which the eligibility requirements are met.

c. Participant Contributions

Participants may elect to defer up to 90% of their eligible compensation, limited by the requirements of the IRC. The Plan includes an automatic enrollment feature whereby new participants are automatically enrolled in the Plan with a 6% deferral rate, unless the participant affirmatively elects otherwise. Upon reaching the age of 50, eligible employees may make additional catch-up contributions as allowed by the IRC. Additionally, participants may roll over amounts representing distributions from other qualified defined benefit or defined contribution plans into the Plan.

d. Employer Contributions

The Company, at its discretion, may make matching contributions to the Plan. During 2024 and 2023, the Company matched 50% of the participants' first 6% of elective salary deferrals. Additionally, the Company may make discretionary non-elective profit sharing contributions for those eligible employees with 1,000 hours of service and are employed on the last day of the Plan year. There were no discretionary non-elective profit sharing contributions made for the years ended December 31, 2024 and 2023.

e. Participant Accounts

Participants are able to direct their account balances into a variety of investments offered by the Plan. Individual accounts are maintained for each of the Plan's participants to reflect the participant's contributions, the Company's contributions, and an allocation of the Plan's earnings and expenses. The benefit to which a participant is currently entitled to is the benefit that can be provided from the participant's vested account.

f. Vesting

Participants are 100% vested in their elective salary deferrals, catch-up contributions, rollover contributions, and any earnings (losses) thereon. Participants become vested in their discretionary

employer matching and profit sharing contributions upon entering the Plan.

g. Notes Receivable From Participants

Participants may borrow the lesser of \$50,000 or 50% of their vested account balance, subject to a \$500 minimum and certain other restrictions. Participant loans are secured by the vested account balance of the participant. Loans are repayable through payroll deductions over periods ranging up to five years, unless the loan is used to acquire a principal residence, in which case the loan term may be extended. New notes bear interest at the prime rate plus 1% per annum and is fixed at the inception of the note. Interest rates on outstanding loans at December 31, 2024 range from 4.25% to 9.50%, and the loans mature through 2029.

h. Payment of Benefits

Upon reaching retirement age, termination of service, disability or death, a participant or their beneficiary may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, installment payments, partial sums, or annuity payments. However, account balances less than \$5,000 may be distributed in a single lump-sum cash payment to the participant or beneficiary.

i. Hardship Withdrawals

Upon certain conditions, participants, while still employed by the Company, are permitted to withdraw in a single sum, subject to a \$500 minimum, a portion of their vested account as a result of an immediate and heavy financial need. These conditions include unreimbursed medical expenses, the purchase of the participant's principal residence, the payment of postsecondary education tuition, the payment of burial or funeral costs of immediate family members, the payment of natural disaster clean-up on the participant's principal residence or to prevent eviction or foreclosure from the participant's principal residence. A participant's right to make deferrals to the Plan will be suspended for six months after the receipt of a hardship withdrawal.

j. Forfeitures

Forfeitures may be used to reduce future Company contributions or to pay administrative expenses of the Plan. At December 31, 2024 and 2023, there were \$6,000 and \$2,000 forfeitures available to reduce future employer contributions or to pay future administrative expenses, respectively. During the years ended December 31, 2024 and 2023, no forfeitures were utilized to offset employer matching contributions or administrative expenses.

## 2. **Summary of Significant Accounting Policies**

a. Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

b. Use of Estimates

The preparation of the financial statements in conformity with generally accepted accounting principles ("GAAP") requires management of the Plan to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

c. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement

date. See Note 4 for discussion of fair value measurements.

Net appreciation in fair value of investments consists of the net change in unrealized gains or losses during the year and the realized gain or loss on investments sold during the year. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis, and dividends are recorded on the ex-dividend date.

d. Contribution receivable

Contribution receivables are contributions earned during the year but not received until the subsequent period due to the timing of the deposit and can be from either the Company or the participants. Contribution receivables are recorded at cost and due to its nature, the Plan does not establish an allowance for credit losses for contribution receivables.

e. Notes receivable

Notes receivable from participants are recorded at their unpaid principal balance plus any accrued but unpaid interest. The Plan does not establish an allowance for credit losses on note receivables since the receivables are fully secured by the participants' contributions to the Plan. Delinquent notes receivable from participants may be treated as a distribution based on the terms of the Plan document.

f. Payment of Benefits

Benefits are recorded when paid.

g. Administrative Expenses

Substantially all administrative expenses are paid by the Company. Investment related expenses not paid by the Company are deducted from investment earnings before allocation to participant accounts and are not separately quantified. Loan administrative fees are charged to the borrower. Direct expenses paid by the Plan were approximately \$76,000 and \$57,000 for the years ended December 31, 2024 and 2023.

### **3. Investments**

Plan investment assets are held by Fidelity Management Trust Company. Participants can direct their accounts among various mutual funds, a money market fund and a common collective trust.

The Federated Hermes Capital Preservation Fund R6 ("Stable Value Fund") objective is to seek the preservation of capital and to provide a competitive level of income over time that is consistent with the preservation of capital by investing primarily in assets diversified in fixed-income securities or bond funds and may include derivative instruments such as futures contracts, swap agreements, and wrap contracts. Wrap contracts are designed to allow a stable value portfolio to maintain a constant NAV and to protect a portfolio in extreme circumstances. The beneficial interest of each participant is represented by units. Units are issued and redeemed at the Stable Value Fund's constant NAV of \$1.00 per unit. Distribution to the Stable Value Fund unit holders is declared daily from the net investment income and automatically reinvested in the fund on a monthly basis, when paid.

Certain events limit the ability of the Plan's investment in the Stable Value Fund to transact at contract value with the issuer. Such events initiated by the Plan sponsor include facility closings, layoffs, Plan termination, bankruptcy or reorganization, merger, early retirement incentive programs, tax disqualification of a trust or other events. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

#### 4. Fair Value Measurements

Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements and Disclosures*, establishes a framework for fair value measurements, which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for the Plan’s investment assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds and Money market fund:* Valued at the daily closing price as reported by the fund. Mutual funds held by the plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds and money market fund held by the plan are deemed to be actively traded.

*Common collective trusts:* The Plan’s interest in the common collective trusts is based on the NAV as the practical expedient of the common collective trusts’ underlying investments as based on information reported by the investment advisor using the audited financial statements or daily reported NAV of the common collective trusts at year-end. Participant transactions can occur daily.

## 5. Risks and Uncertainties

The Plan assets are invested in a variety of investments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, foreign currency and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits, and therefore participant account balances.

## **6. Information Certified by the Trustee**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The following information included in the financial statements and supplemental schedules was provided and certified by Fidelity Management Trust Company, the trustee of the Plan, as complete and accurate:

- Investments, at fair value
- Notes receivable from participants
- Investment income
- Interest earned on notes receivable from participants
- Schedule of assets (held at end of year)
- Schedule of delinquent participant contributions

## **7. Related-Party Transactions**

Certain Plan investments are managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee as defined by the Plan. Certain investment fees are paid by the trustee and is reflected in the investment income or loss for the year. The Plan also issues loans to participants that are secured by the vested balance in the participants' accounts. As such, these transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

The Plan sponsor, Fisher & Paykel Appliances USA Holdings Inc., is a party-in-interest to the Plan; however, there were no transactions with the Plan sponsor other than the funding of contributions to the Plan and payment of certain administrative expenses of the Plan.

## **8. Income Tax Status**

The Plan adopted the non-standardized preapproved profit sharing plan which received a favorable opinion letter dated June 30, 2020 in which the Internal Revenue Service ("IRS") stated that the plan document was in compliance with the applicable requirements of the IRC. The Plan has been amended since the date of the opinion letter. However, management believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, management believes that the Plan is qualified and the related trust is tax exempt.

Assuming it meets certain initial and ongoing requirements, the Plan is generally exempt from federal and state income taxes. However, GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **9. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants will become fully vested in their accounts.

## 10. Non-exempt Transactions

Certain participant contributions that occurred in 2023 were identified that were not remitted to the Plan by the Company within the time period required by the Department of Labor. These late remittances constitute prohibited transactions as defined by ERISA. Management has included these amounts on the schedule of delinquent participant contributions. In 2024, the contributions were remitted to the Plan, and the Plan is in the process of calculating and remitting lost earnings.
