### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Clegg's Termite and Pest Control, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and December 31, 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

## Notes to the Financial Statements

### 1. Description of the Plan

The following description of the Clegg's Termite and Pest Control, LLC 401(k) Plan (the Plan) provides general information. Participants should refer to the Plan adoption agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was originally established on February 28, 1972, and was restated effective January 1, 2021. The Plan covers all eligible employees of Clegg's Termite and Pest Control, LLC (the Plan Sponsor and Administrator).

#### Eligibility

Employees are eligible to participate in the Plan if they have attained one year (1,000 hours) of credited service and are 21 years of age. Enrollment dates are January 1 and July 1 of each Plan year. Once eligible, participants can begin deferring compensation into the Plan. Employees are eligible for both the employer match and any discretionary contribution after one year of service. They must be employed at the end of the Plan year to be eligible for the discretionary contribution. If an employee is a nonresident alien, or a union employee they are not eligible to participate in the Plan.

#### Contributions

Each year, participants are permitted to make voluntary tax-deferred contributions, subject to certain Internal Revenue Code (IRC) limitations. Participants who have attained age 50 by the end of the Plan year are eligible to make catch-up contributions up to certain amounts in excess of all applicable limits. A participant may contribute any rollover contributions to which they are entitled from another qualified trust. Such rollover contributions are deposited in the participant's account. The Plan Sponsor has elected to contribute a discretionary matching contribution up to the first 5% of participant contributions. They may also elect to make an employer profit sharing contribution; no such contribution was made in the year ended December 31, 2024.

#### Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's separate account is credited with the participant's contributions and allocations of the Plan Sponsor's contributions, Plan earnings and charged with an allocation of administrative fees. Allocations are based on participant earnings or account balances, as defined in the Plan adoption agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## CLEGG'S TERMITE AND PEST CONTROL, LLC 401(K) PLAN

Notes to the Financial Statements, continued

### 1. Description of the Plan, continued

#### Vesting

Participants are immediately vested in their elective contributions, including rollovers, plus actual earnings thereon. Vesting in the employer matching and profit-sharing contribution portion of their accounts plus actual earnings thereon is based on years of credited service.

The following table summarizes the Plan Sponsor's vesting policy:

#### Investment Options

Participants can direct the investment of their contributions as well as employer matching contributions made on their behalf into various investment options offered by the Plan, including a formal investment program offered by the Plan and a self-directed investment program.

#### Notes Receivable from Participants

Participants who incur a financial hardship or have a specified financial need may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms may not exceed five years, unless the proceeds are used to acquire a home that will be the primary residence of the participant. The loans are secured by the vested balance in the participant's account and bear interest at rates ranging from 4.25% to 9.50%, which were commensurate with prevailing rates on the date of the loan application or last date published prior to the loan application. Principal and interest are paid ratably through payroll deductions. Should a participant terminate employment, the outstanding principal balance of the loan plus accrued interest shall become due immediately.

#### Payment of Benefits

The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The Plan permits withdrawals in the event of disability, death, retirement, termination of employment, or proven financial hardship. The Plan provides for normal retirement at age 65 and permits early retirement after a participant has rendered twenty years of credited service and attained age 62. If a participant terminates before rendering twenty years of credited service, the participant is entitled to the vested portion of their benefits as a lump-sum distribution upon retirement or termination.

### Notes to the Financial Statements, continued

#### 1. Description of the Plan, continued

##### Payment of Benefits, continued

The Plan states that a participant's account balance becomes fully vested upon the total disability or death of the participant. The entire amount in the account shall be paid, in the manner described above, to the participant upon total disability, or to the person or persons specified in the participant's beneficiary designation upon the participant's death.

##### Forfeited Accounts

Forfeitures of employer matching contributions are used to offset future employer matching contributions or administrative expenses of the Plan. Forfeitures available to offset these costs were \$0 and \$516 as of December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, \$8,796 of forfeitures were utilized to pay record keeping fees.

##### Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks such as interest rate risk, market and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

##### Administrative Expenses

The Plan is responsible for its administrative expenses unless paid by the Plan Sponsor.

#### 2. Summary of Significant Accounting Policies

The financial statements have been prepared in conformity with accounting principles generally accepted in the United States of America (GAAP) which require management to make estimates and assumptions that affect the reported amounts and disclosures in the financial statements. Actual results could differ from those estimates. The following is a summary of the significant accounting policies consistently applied by the Plan in the preparation of its financial statements:

##### Income Recognition

Purchases and sales of securities are reflected on a trade-date basis. Interest income on investments as well as from notes receivable from participants is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Capital gain distributions are included in dividend income. Net appreciation or depreciation includes the Plan's gains or losses on investments bought and sold as well as held during the year.

### 2. Summary of Significant Accounting Policies, continued

#### Investment Valuation

All underlying investments of the Plan are reported at fair value. The collective investment trust funds invest in mutual funds with quoted market prices. Shares of mutual funds (registered investment companies), as well as money market funds through self-directed investment accounts, are valued at the quoted market price per share held by the Plan at year-end. Corporate bonds are valued at amortized cost, which approximates fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

#### Contributions

Contributions from Plan participants and the matching contributions from the Plan Sponsor are recorded in the year in which the employee contributions are withheld from compensation.

#### Notes Receivable from Participants

Notes receivable (participant loans) are measured at their unpaid principal balance, plus accrued but unpaid interest at the end of the period. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses had been recorded, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participant's account balance. If a participant does not make loan payments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan adoption agreement.

#### Payment of Benefits

Benefit payments to participants are recorded upon distribution.

#### Subsequent Events

The Plan's management has evaluated subsequent events for accounting and disclosure requirements through October 9, 2025, the date the financial statements were available to be issued.

### 3. Information Certified and Provided by Trustee

The Plan's investment information included in this note and throughout the Plan's financial statements and supplemental schedules was prepared by or derived from information provided by First Citizens Bank & Trust Company, the trustee of the Plan, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the trustee that such information is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations on Reporting and Disclosure under ERISA, the Plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to asset information in this note and which appears throughout the financial statements and the ERISA-required supplemental schedules.

The trustee certified the fair value of investments held of \$9,104,495 and \$8,625,589 at December 31, 2024 and 2023, respectively. The trustee also certified notes receivable from participants of \$197,068 and \$155,232 as well as accrued interest of \$11,390 and \$11,304 at December 31, 2024 and 2023, respectively.

The trustee of the Plan also certified to the completeness and accuracy of \$652,457 of net realized and unrealized appreciation in the fair value of investments, \$95,349 of interest and dividends related to investments, and \$15,420 of interest income on notes receivable from participants for the year ended December 31, 2024.

### 4. Fair Value Measurements

The Plan classifies its investments based on a hierarchy consisting of: Level 1 (valued using quoted prices from active markets for identical assets); Level 2 (not traded on an active market but for which market inputs are readily available) and Level 3 (valued based on significant unobservable inputs). The assets' or liabilities' fair value measurement within the valuation hierarchy is based upon the lowest level of input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis:

#### Mutual Funds

These investment vehicles are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are considered to be actively traded.

#### Self-Directed Investment Accounts

Investments include corporate bonds, mutual funds and money funds. Mutual funds and money funds are valued at the closing price reported on the active market on which the individual securities are traded; they have been classified within Level 1 of the fair value hierarchy. Corporate bonds are valued at amortized cost, which approximates fair value, and so have been classified within Level 2 of the fair value hierarchy.

**4. Fair Value Measurements, continued**

Collective Investment Trust Funds

Collective investment trusts are valued at the net asset value (NAV) of the units. NAV is a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Since this investment is measured at fair value using the net asset value per share practical expedient it is not required to be classified within the fair value hierarchy. They are included below to permit reconciliation of the fair value hierarchy tables to the amounts presented in the statements of net assets available for benefits.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. Plan management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no significant transfers in or out of Level 3.

### 5. Exempt Party-in-Interest Transactions

On January 1, 2024, the Custodian was Newport Group, Inc, as defined by the Plan. On November 13, 2024, they merged with Ascensus, LLC (Ascensus), who became the Custodian. Certain Plan investments are shares of collective investment trust funds managed by Ascensus and therefore these transactions qualify as party-in-interest. Administrative expenses paid by the Plan to Ascensus totaled \$60,429 for the year ended December 31, 2024.

### **6. Plan Termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100 percent vested in their accounts, including employer contributions. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Plan Sponsor may determine.

### **7. Tax Status**

The Plan uses a prototype plan document sponsored by Newport Group, Inc. An opinion letter was received from the Internal Revenue Service (IRS), dated June 30, 2020, which states that the prototype plan document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

### **8. Prohibited Transactions**

During the year ended December 31, 2024, participant withholdings in the amount of \$39,747 were not remitted by the Plan Sponsor within the appropriate time period. These transactions constitute a prohibited transaction as defined by ERISA. The Plan Sponsor is aware of the occurrences and has taken the appropriate steps to correct the situation.
