Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of FlashCo Manufacturing, Inc. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and December 31, 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

Basis for Opinion



NOTES TO FINANCIAL STATEMENTS

YEAR ENDED DECEMBER 31, 2024

NOTE 1 – Description of Plan

The following description of the FlashCo Manufacturing, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a safe harbor 401(k) salary deferral and profit sharing plan covering all eligible employees of FlashCo Manufacturing, Inc. (the Company) who have completed three months of service and are age eighteen or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may elect to defer up to 100% of compensation as defined in the Plan. Participants who have attained age 50 by the end of the Plan year may defer an additional amount of annual compensation based on catch-up provisions as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company makes safe harbor matching contributions equal to 100% of eligible participant deferrals that do not exceed 3% of eligible participant compensation plus 50% of eligible participant deferrals between 3% and 5% of eligible participant compensation. The Company may also make discretionary profit sharing contributions.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's safe harbor contribution (b) the Company's discretionary contribution and (c) Plan earnings or losses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Participants direct contributions among various mutual funds and the investment contract.

Vesting

Participants are fully vested in deferrals withheld from their compensation under the salary reduction arrangement, and are 100% vested in employer safe harbor matching contributions. Vesting in employer discretionary contributions begins after the completion of one year of service, as defined, with increases in increments of 30% per year until fully vested after three years.

NOTE 1 – Description of Plan (Continued)

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested interest in the Plan. Loan terms are up to a maximum of five years. The loans are collateralized by the participants' vested interest in the Plan and bear interest at 1.00% above the prime rate. The interest rate on loans outstanding at December 31, 2024, ranged from 8.75% to 9.50%. Principal and interest are paid ratably through bi-weekly payroll deductions through 2029. No allowance for credit losses has been recorded as of December 31 2024.

Payment of Benefits

Upon termination of service due to death, disability or retirement, the Plan provides for a single lump sum distribution. Participants are also eligible to receive a lump sum distribution upon reaching age 59½. Participants may elect to postpone payment to a later date.

Forfeitures

Employer matching contributions were reduced by \$1,156 of forfeited nonvested accounts during the year ended December 31, 2024. At December 31, 2024, remaining forfeited nonvested accounts totaled \$5,996, and at December 31, 2023, forfeited nonvested accounts totaled \$884.

NOTE 2 – Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America, using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could vary from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for the fully benefit-responsive investment contracts, as certified by the trustees of the Plan's investment assets, Voya Institutional Trust Company (VITC) at December 31, 2024, and Empower Retirement, LLC (Empower) at December 31, 2023. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The investment contracts are fully benefit-responsive and are reported at contract value, which approximates fair value. See Note 4 for a discussion of the investment contracts and Note 6 for a discussion of fair value measurements.

NOTE 2 – Summary of Significant Accounting Policies (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Net appreciation in value of participant directed investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Plan Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Certain transaction fees are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

Management has evaluated subsequent events for potential recognition and/or disclosure through October 13, 2025, the date the financial statements were available to be issued.

NOTE 3 – Information Certified by the Trustees of the Plan's Investment Assets

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Under this provision of ERISA, investment information and related activity certified as complete and accurate by a qualified institution need not be subjected to independent audit. Accordingly, VITC and Empower, the trustees of the Plan, have certified to the completeness and accuracy of the following:

- Investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and December 31, 2023.
- Net appreciation in fair value of investments, dividends and interest reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments reflected on the supplemental schedule of assets (held at end of year) as of December 31, 2024.

NOTE 4 – Investment Contracts with Insurance Companies

The Plan has a fully benefit-responsive investment contract with Voya Retirement Insurance and Annuity Company (VRIAC). The Plan had a fully benefit-responsive investment contract with Empower at December 31, 2023. VRIAC maintains contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuers are contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan.

Because the guaranteed investment contracts are fully benefit-responsive, contract value was the relevant measurement attributed for that portion of the net assets available for benefits attributable to the guaranteed investment contracts. Contract value as reported to the Plan by VITC (2024) Empower (2023) is equal to contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

As of December 31, 2024 and 2023, there were no reserves against the contract value for credit risk of the issuer or otherwise. Certain events may have limited the ability of the Plan to transact at contract value with the contract issuer. However, the Plan's management was not aware of the occurrence or likely occurrence of any such events.

NOTE 6 – Fair Value Measurements

The Fair Value Measurements and Disclosures topic of the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under the FASB ASC are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2

Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The Plan's mutual funds at December 31, 2024 are valued at the net asset value based on the investments' ending price as of the end of the year. The Plan's mutual funds at December 31, 2023 are valued at the net asset value based on the investments' ending price as of the end of the year, then adjusted to apply an expense factor. There has been no change in the methodology used at December 31, 2024 and 2023.

The Plan's collective trust funds are valued at their respective NAV as reported by such trust. The NAV is used as a practical expedient to estimate fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 7 – Party in Interest Transactions

Plan investments include shares of a money market fund managed by Voya Investments, LLC, and an investment contract managed by VRIAC as of December 31, 2024. VITC, a party related to Voya Investments, LLC and VRIAC, is the trustee of the Plan’s investment assets, as defined by the Plan, and therefore these transactions qualify as party in interest transactions.

NOTE 8 – Tax Status

The Plan is operating as a non-standardized pre-approved defined contribution plan. The Plan obtained its latest opinion letter in June 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax-exempt for the year ended December 31, 2024, and, accordingly, no provision for income taxes has been recorded.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator does not believe the Plan had any material uncertain tax positions as of December 31, 2024 and December 31, 2023.

NOTE 9 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 10 – Transfer of Assets

On January 5, 2024, the Plan assets were converted to cash and transferred from Empower to VITC. The transfer initiated a "Black Out" period from December 29, 2023, through January 26, 2024. During this period, employees were unable to direct or diversify their investments in the former investment offering.

NOTE 11 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in all amounts credited to their accounts.
